Assam University is a Central University established in 1994 (Act XXIII of 1989). It is a NAAC accredited institution of higher learning with multi-disciplinary programmes. It has 56 affiliated colleges spread in five districts of Assam. The university runs Post Graduate programmes in 40 disciplines - 32 in the main campus and 8 in its setellite campus at Diphu, head quarter of the Karbi - Anglong, a hill district of Assam.

Annual accounts of Assam University are being drawn on historical cost basis and prepared in the format prescribed for Central autonomous bodies by the Ministry of Human Resource Development in consultation with the Comptroller & Auditor General of India. Since 2005-2006 these accounts are being maintained on accrual basis.
