As per the decision of the 76<sup>th</sup> & 77<sup>th</sup> Academic Council meeting held on 4<sup>th</sup> October 2016 and 14<sup>th</sup> February 2017 vide resolution No.AC:76:10-16:37.4 and AC:77:02-17:08.1 respectively, the previous system of IPP Course Work Examination for enrolment of M.Phil/Ph.D. course is going to be discontinued from January 2017.

Students who have admitted themselves as per old M.Phil/Ph.D. Regulation (2009) shall be permitted to appear **IPP Course Work (Arrear) examination 2017** to be conducted from **25<sup>th</sup> April 2017**.

All **arrear** candidates are hereby directed to submit the examination forms complete in all respect along with a fee of Rs. 900.00 (Rs.500.00 as exam fee + Rs.300.00 as Centre fee + Rs.100.00 as marksheet fee) to the concerned department as per the dates given below :-

By the Department to Examination Branch	12 <sup>th</sup> April, 2017 (Wednesday)

The examination forms must be enclosed with the following documents without which the forms will be summarily rejected. The forms and fees must be sent in due time, no forms will be entertained by the Examination Department after the expiry of the above mentioned date.
