ABOUT THE SEMINAR

For this purpose minimum of one participant from India-bordering countries will participate with a paper or resource person for two days in the Dept. of Commerce, Assam University, Silchar. India's political, Social and Economic Relations with bordering countries will focus on what affects the border trade. The seminar will also discuss the issues of Northeast India (NEI), as it is surrounded by most countries, which is 98 per cent of NEI's total borderline. Act East Policy, connectivity, manufacturing industries, cluster development, medical tourism and other service industries related to Border trade, will be analyzed.

SUBMISSION GUIDELINES:

- 1. The paper should be original, unpublished, and not under review with any academic publication.
- 2. Abstract should not exceed 250 words with at least 4 keywords and the length of the full paper should not exceed 5000 words.
- 3. Manuscripts should be typed in MS Word with Times New Roman- font size 12 with 1.5 line spacing.
- 4. All the authors were directed to submit an un-plagiarised manuscript with a plagiarism report of less than 10%.

PUBLICATION OPPORTUNITY:

From the accepted papers, selected papers will be considered for publication in UGC Care list/Scopus indexed journals on the basis of recommendation of session chairs and blind review process. However, the publication/processing fee (if any) has to be borne by individual authors. The remaining papers shall be published in the seminar proceedings with ISBN.

ACCOMMODATION:

Outstation participants shall be provided accommodations in the University Guest House on payment on 1st come, 1st served basis. Hotel accommodation in the city can be also be arranged on need basis.
