Resolutions:

- 1. Regarding the candidates with un-downloadable forms, it was decided that since the downloadable forms could not be provided by the Computer Centre of Assam University, the DAC will accept the virtual forms of the eight candidates who have appeared in the Admission Test, if they are otherwise eligible.
- 2. Since one candidate, namely Shima Das, Application No. 729757, missed the entrance test due to a technical error, she will be given another test on 13/11/2020. In pursuance of the telephonic communication of the HoD, English with the Chairperson, Central Admission Committee in this regard, it was further decided that the candidate will be given a set of questions compatible with the question paper of the first entrance test. All the members of DAC have been requested to mail 2 to 3 topics/questions to the HoD English latest by 12/11/2020 night for the same purpose. The one hour test would be conducted from 3 pm on 13/11/2020. The matter will be communicated via email to the Chairperson, Central Admission Committee, for further directions from him in this regard.
- 3. Candidates appearing for entrance test in both the campuses of Assam University should be disqualified as it is not allowed as per the Admission Guidelines. Further, since both the tests were held at the same time, it is indicative of adoption of unfair means on the part of those candidates. There are three such candidates as of now, about whom the DAC authorises the HoD, English Assam University, Silchar to get in touch with the HoD, English of Diphu Campus. It was decided that the list of all candidates who appeared at the Written Test for Silchar headquarter will be shared with AUDC for verifications. Such candidates, in consultation of AUDC, will be rejected consequent upon detection at any stage of the admission process and even beyond.
- 4. All admissions will be subject to the verification of original documents as and when done.

- 5. Dr. Lalthakim Hmar will distribute the Answer Scripts of the Admission Test among all colleagues equally (except Prof. Dipendu Das who has an urgent engagement till 19th November). The scripts are expected to be evaluated and returned with marks entered in a format, to be provided along with, latest by 17/11/2020.
- 6. The subsequent documents sent by the candidates will be verified from soft copies saved in Google drive. This will be compatibly shared among the DAC members along with its password.
