



## MEMORANDUM OF UNDERSTANDING (MOU) AND ACADEMIC COLLABORATION

## BETWEEN

## ASSAM UNIVERSITY SILCHAR, ASSAM, INDIA AND DAFFODIL INTERNATIONAL UNIVERSITY, DHAKA, BANGLADESH

This Memorandum of Understanding is made on the 9<sup>th</sup> August 2018 between **Assam University Silchar (Central University)** Assam, India having its office at Assam University silchar, Dist-Cachar, Assam and **Daffodil International University**, Dhaka, Bangladesh, aim to establish and develop a close partnership to promote academic and cultural exchanges between the two Institutions through mutual assistance, specially, in the areas of teaching and research.

This Agreement of Co-operation, upon approval of the Vice Chancellor of Daffodil International University and the Vice Chancellor of Assam University Silchar will serve as a general framework for institutional co-operation.

And both the parties as mentioned above set forth and agree to abide by the following terms of this agreement.

- It will facilitate faculty members to discuss and develop specific programs of cooperation. Each University will designate a liaison officer to co-ordinate the application of this Agreement in the best interest of both Institutions. Co-operative relations shall be carried out through the activities such as:
- Exchange Program: In the case of exchange of students, each University will evaluate and decide on study period of the relevant student. A student, who has received a grant and fulfils the entrance level of each institution, will be treated as a fully accepted student of concerned School/Faculty/Department, with all the same rights and regulations.
- Faculty Exchange: The exchange of academic staff for short duration in order to share expertise and knowledge among staff and students of both institutions.
- ➤ Research Degrees: The provision of placements and support for Masters Students to undertake a period of research/placement at the partner institution.
- Resources Share: The acquiescence of access to the Library database, Journal and other online resources for both staff and students of each university.
- Summer/Spring Program: Both universities will agree to participate in short term Summer/Spring program arranged by other partner institution. In this matter, partner institution will circulate the notices among students and motivate them to attend the summer programmer for capacity building and cross cultural education.

- > Blended Learning Courses: Both Partner institutions may arrange blender learning courses/program for the students where students will study specific subjects in their home institution and rest of them will complete in the partner institution.
- > Intern Exchange: To encourage young entrepreneurs, newly graduate and young teaching assistants, both institutions will facilitate them for internship placement from partner institution.
- > Scholarship Opportunity: Both Institution may arrange scholarship opportunity for meritorious students of partner institution and cooperate accordingly.
- 2. The provisions and activities specified in this Agreement are subjected to the availability of funds and the approval of the Authorized Officers of both Institutions. A separate financial agreement to be finalized prior to implementation of the program arrangement.
- 3. The Agreement shall take effect from the date of signing and shall be valid for an initial period of 5 (five) years. Any amendment and/or modification of this Agreement require the written approval of the Vice Chancellor of Daffodil International University and the Vice Chancellor of Assam University Silchar and shall be appended hereto. Neither University shall take action relative to this Agreement without consultation with the partner in this Agreement.
- 4. Arbitration: Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations by the parties unde. Arbitration & Conciliation Act, 1996. It shall be settled through or sole Arbitrator appointed by the Assam University. The award of the arbitration shall be final, conclusive and binding upon both the parties.

## Miscellaneous:

- a) The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b) The parties to this MOU may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.
- c) The intent and implementation of this memorandum is SUBJECT to the policies of the laws of the land.
