MEMORANDUM OF UNDERSTANDING (MoU)

Between

THE DEPARTMENT OF STATISTICS, SHAHJALAL UNIVERSITY OF SCIENCE AND TECHNOLOGY, SYLHET, BANGLADESH

("DOS-SUST")

AND

THE DEPARTMENT OF STATISTICS, ASSAM UNIVERSITY (a Central University), Silchar, India

("DOS-AU")

The **MEMORANDUM OF UNDERSTANDING(MOU)** is made in Sylhet, Bangladesh, on this day of 6th February, 2018 between Department of Statistics, Shahjalal University of Science and Technology, Sylhet, Bangladesh represented by Professor Dr. Md. Elias Uddin Biswas, Treasurer and Professor Md. Ahmed Kabir Chowdhury as Head, Department of Statistics, here is after referred to as (DOS-SUST) which expression shall always include its successors in title, agents or representatives or anybody claiming any rights thereto and through them.

and

Assam University, a central university established by an Act of Parliament in 1994 and having its main office at Silchar, Assam, represented by Professor Dilip Chandra Nath, Vice-Chancellor and Professor Dibyojyoti Bhattacharjee, Head, Department of Statistics, hereinafter referred to as (DOS-AU) which expression shall always include its successors in title, agents or representatives or anybody claiming any rights thereto and through them.

DEPARTMENT OF STATISTICS, ASSAM UNIVERSITY (a Central University), Silchar,

Both SUST, Sylhet, Bangladesh and AU, Silchar, India are universities established by the respective Governments in 1987 and 1994 respectively. The department of Statistics, SUST and the department of Statistics, AU seek to promote educational and research activities through the development of corporative relationship between them. The Head of the DOS-SUST and the Head of the DOS-AU hereby agree to enter into this non-binding Memorandum of Understanding that enables to work together for building the Academic and Educational Partnership between the two departments. AND WHEREAS it is found to be more beneficial and convenient to carry out the said objectives between the parties hereto and therefore, the parties have agreed to enter into this Memorandum of Understanding under the following conditions.

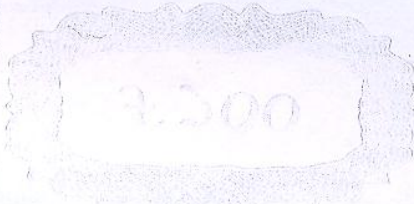

- a. Exchanges of Faculty/Staff and Graduate Students
 - b. Joint Research activities and publications
 - c. Co-organization of and participation in seminars and academic meetings
 - d. Cooperative in each other's educational program
 - e. Organizing special short-term academic and educational programs
 - f. Registration fee for all mutually agreed exchanges (maximum 4 persons per Department per year) may be waived!
2. Any Activities mentioned above shall be organized and implemented by the concerned Department in due consideration of the following principles;
 - a. Consistent with the policies and the missions of each Department
 - b. In accordance with the laws and the regulations covering "the right of intellectual property", "freedom of information and protection of privacy" of respective countries.
 3. DOS-AU and DOS-SUST shall be responsible for overall implementation of the MoU.
 4. Each side shall bear its own costs and expenses arising from this memorandum unless otherwise mutually arranged and agreed to.
 5. The MoU shall be operational with the approval by appropriate governing bodies of their respective institutions.
 6. Disputes with regard to interpretation of any or all clauses shall be settled by the two nodal authorities. Failing an agreement of the two, a committee having three representatives of each institution nominated by the respective Vice Chancellor, shall resolve the issue in joint meeting(s). The committee shall have powers to recommend modification, annulment, addition, substitution of any clause and/or issue explanatory memorandum that will form part of the MoU.
 7. Matters not covered under this MoU shall be open for incorporation from time to time subject to mutual consensus of the competent authorities of the two institutions.
 8. This memorandum shall take effect on the date of signatures by the representatives of both departments and shall be valid for the period of Five (5) years.
 9. Either side may terminate this memorandum prior to the expiry with written notice to the other side. Any programs and/or projects in progress at the time of termination shall remain unaffected.
 10. For each assignment of work to be undertaken by DOS-SUST/DOS-AU under this MOU, the extent of skills and expertise by each of the said departments and fee for skills and expertise and faculties to be provided and the terms of payment shall be as per rules of the university and in case the skill or expertise is not available it shall be negotiated and be agreed upon by mutual consent. Moreover, they may apply for complementary finance from the programs of other bodies. Similarly, they may apply for funding from national, regional and international bodies.
 11. This memorandum may be amended or extended by a written document on the mutual written consent of the two departments and on approval of the competent authorities of both the universities.
 12. In the event of disputes between the two departments, the same shall be solved amicably. If the departments are unable to do so the same shall be referred to an arbitrator to be appointed by the Vice
