

**AGREEMENT ON ACADEMIC EXCHANGE  
BETWEEN THE  
FACULTY OF AGRICULTURE, SHIZUOKA UNIVERSITY, JAPAN  
AND THE  
SCHOOL OF LIFE SCIENCES, ASSAM UNIVERSITY, SILCHAR, INDIA**

The Faculty of Agriculture of Shizuoka University, Japan and the School of Life Sciences, Assam University, Silchar, India, (hereafter referred to as both institutions) enter into agreement under the following terms for the purpose of furthering educational and research exchange and thus deepening the friendship between both institutions.

1. Both institutions agree to cooperate in order to expand opportunities for further development of academic research and other academic activities. The cooperation shall entail the following activities:
  - (1) exchange of academic and administrative personnel
  - (2) exchange of students
  - (3) exchange of academic information and knowledge
  - (4) other exchange activities to which both institutions agree
2. The exchange specifications mentioned above are determined through mutual consultation between both institutions and specified in any and all Memoranda of Understanding appended of this Agreement.
3. This agreement shall come into effect upon signature of this document by representatives of both institutions. The term of validity is five years from the date on which signatures are affixed below and can be extended through joint recommendation by both institutions. This agreement may be terminated by one or both of the institutions upon submission of a request for its cancellation six months in advance.
4. Two copies of this Agreement shall be made, one to be held by each institution, and both shall serve as original.







**MEMORANDUM OF UNDERSTANDING BETWEEN THE  
FACULTY OF AGRICULTURE, SHIZUOKA UNIVERSITY, JAPAN AND THE  
SCHOOL OF LIFE SCIENCES, ASSAM UNIVERSITY, SILCHAR, INDIA  
REGARDING STUDENT EXCHANGE**

This is a Memorandum of Understanding between the Faculty of Agriculture of Shizuoka University, Japan and the School of Life Sciences, Assam University, Silchar, India, regarding student exchange. The Memorandum of Agreement on Academic Exchange, together with this signed Memorandum of Understanding (MoU), shall constitute the exchange agreement.


1. It is the intention of both institutions to exchange undergraduate students by mutual consent. The students accepted for participation in student exchange (hereafter referred to as "exchange students") shall be treated as visiting students.
2. The number of exchange students accepted each year on the basis of this Agreement shall be up to 2.
3. Registration at the host institution shall be for a period of at least six months and shall not exceed one year.
4. The home institution shall recognize credits obtained by an exchange student at the host institution.
5. The host institution shall waive application, admission and tuition fees for exchange students.
6. Exchange students must have a reasonable command of English and/or the language spoken in the country where the host institution is located.
7. The home institution shall screen applicants in accordance with the stated purpose of the exchange agreement and recommend students for participation in the exchange program.
8. The home institution shall recommend exchange students and submit the required documents for consideration at the host institution. The host institution shall inform the home institution of the outcome.
9. The host institution shall offer an academic program to exchange students appropriate to their academic ability.
10. Exchange students shall be responsible for all necessary travel documents, including passport and visa, transportation to and from the host institution as well as accommodation, meals, textbooks, clothing, medical insurance, health service fees and other personal expenses including all debts incurred during their stay.
11. The host institution shall make every effort to provide accommodation for exchange students.
12. This MoU shall come into effect upon signing by representatives of both institutions and will remain in effect until the date of expiration of the Agreement on Academic Exchange.
13. Two copies of this MoU shall be made, one to be held by each institution, and both shall serve as original.


