Sub: Extension of approval of affiliation of Deshbandhu Chittaranjan School of Legal Studies ( Department of Laws) Assam University, Silchar, Assam imparting five year BA. LLB ( Hons.) law course.

Sir,

Legal Education Committee at its meeting held on 12<sup>th</sup> July, 2014 considered the reply of Show cause notice of the above mentioned college. After consideration, Committee made the following recommendations:-

The Legal Education Committee considered the reply sent by the college in response to show-cause notice vide letter dated 9<sup>th</sup> June, 2014 in which they have stated that the university has already taken up the matter with the UGC for sanction of 6 faculty members for non-law subjects in the Department of Law at the earliest. In view of this, the approval is granted as per recommendation of the inspection team. However, the compliance should be done within six months that the appointment of the teachers with intimation to the Secretary, Bar Council of India. Office to proceed.

It is made clear, earlier inspection fees deposited was valid for three years only from 2010-11, 2011-12 and 2012-13. From 2013-14 the University has not deposited the requisite fees which they should deposit within four weeks for implementing of this order. Approval is granted from 2013-14 and 2014-15 for running five year BA.LLB(Hons.) with existing strength of students.

The above recommendations were considered by the Bar Council of India at its meeting held on 13<sup>th</sup> July, 2014 and accepted the same.
