2. The staff appointed on the project should be paid as indicated in the budget statement attached.
3. The approval duration of the research scheme is three year. The annual extension will be give after review of the work done on the research scheme during the previous year.
4. Ten copies of the annual progress report of work done be submitted to the Council after completion of one year of the project.
5. The institute will maintain a separate account of the receipts and the expenditure incurred on the research scheme and will furnish a utilization certificate and an audited statement of the account pertaining to the ground.


The grant will be released to the head of the institute in installments during the financial year on receipt of the demand in the prescribed form (Appendix- I) as indicated below:
