(I) The Chaireeson Placed the structure and contents of the II-semester syllabus which was approved by Hon ble Vice chancellor for ratification in BPGS Mathematics.

The Chairperson apprised the house that with this new syllabus the classes are going on in II Semester, Chairperson also apprised the member that Hon'ble V.C. has suggested for experts' comments for the III & IV semester syllabus and accordingly the syllabus of III & IV semester should be revised with the experts' comments after getting their comments.

(II) The chairceson placed a letter written by one of the scholar Riaz Uddin Mazumder addressing Vice-Chancellor (Through proper Chanel) for submission of thesis under the supervision of Prof.D. Biswas and Co-supervisor Dr. S.A. Begum, (Computer Science AUS).

By a threat tone discussion on this letter, the members opined that

(a) as the HOD, Mathematics has not received any communication in this regard i.e. to receive the thesis signed by Dr. S.A. Begum as supervisor,

(b) The pupers (અરસ્ટાનને with the Application) do not reflect any where that the co-supervisor may sign in place of supervisor.

So the Thesis should be properly signed by respective supervisor and co-supervisor as the presubmission seminar (21.11.13) was held before super-annution of Prof. D. Biswas (Supervisor) and then to be submitted to the Department of Mathematics.

The process may take some time, the members also opined that as an when signed by supervisor and co-supervisor, the scholar may be allowed to submit the thesis to the Department of Mathematics.

(c) The chairperson placed the application for co-supervisor along with the biodata submitted by Prof. Nazibuddin Ahmed who is Prof. of Department of Mathematics, Gauhati University, Guwahati.

The members chined that as Prof. Nazibuddin Ahmed is professor by designation, there may not be any objection to act as co-supervisor. The matter is forwarded to School Board and onward submission to BRE(SE)
