At the outset, the Chairperson read out the minutes of the 38<sup>th</sup> meeting of the BPGS. It was resolved to confirm the minutes.

**Item No.1: To consider the cases of Provisional Registration (AUDC):**

- The Provisional Registration proposal of Ms. Bandita Teronpi is discussed and it is recommended that the proposal in its present form is not acceptable. However, the scholar may consider to streamline and broaden the scope of the study by incorporating state-local relations as well.
- The Provisional Registration proposal of Mr. Bijay Kumar Mishra is discussed and it is felt that the proposal is required to be more focused.
- The proposal of Ms. Jyotsna ~~Rani Das~~ <sup>Harjai Ka</sup> is sent back for revision as the proposal needs change in every aspect including objectives, hypotheses, methodology and so on.

**Item No.2: To consider the cases of M.Phil Registration (AUDC):**

The M.Phil Registration proposal of Ms. Zerin Sultana Barbhuiya and Mr. Lenin Gogoi are adopted and recommended for placing the same in the forthcoming School Board meeting.

**Item No.2: To consider the cases of Final Registration (AUDC):**

- Final Registration proposal of Mr. Guru Prasad Upadhyay is discussed. The language and title of the proposal need to get reformulated. The title has to be as it is in the Registration Form.
- Final Registration proposal of Mr. Nasirul Haque is accepted and recommended for placing it in the forthcoming School Board meeting.
- Final Registration proposal of Ms. Subhash Talukdar is accepted. However, Provisional Registration certificate is required to be attached.

- d) Final Registration proposal of Mr. Dilip Kumar Sonowal is thoroughly discussed and it is resolved that the proposal is to be revised thoroughly as the objectives are incoherent to each other and research questions are the repetition of the same thing. Besides, the title page needs to be changed and the operational definition of the 'ethnic assertion', 'ethnic mobilisation' are to be provided.

**Item No.5: To consider the Panel of Examiners:**

Hence, she has requested for re-registration. After a threadbare discussion, the Board recommended her case to the School Board for consideration and approval for fresh provisional registration (as per Ordinance on the Doctor of Philosophy vide no.4 (III) (b).


**Item No.11: To consider the cases of Extension of Time (Ph.D. AUDC):**
