#### 18. Miscellaneous

1) Brig. R. P. Singh, PHD Submission matter (post-submission)

DRC has considered the plea submitted by Prof. Joyati Bhattacharya regarding Brig. R P Singh's Ph.D Term Regularization and has resolved flowingly:

Brig. R.P. Singh, a scholar in the Department of Political Science, had presented his Provisional Registration Seminar under Old Regulations on Mphil/Ph.D on April 6, 2015. His provisional registration was approved in relevant statutory bodies. As per Clause 4(III) of the Old M.Phil/Ph.D Regulations he was supposed to complete his final registration within eighteen months but after Completion of one year of the provisional registration. But there was no communication from Brig. R.P. Singh till 2020. Hence, as per the provision of Clause 4(III) (b), his provisional registration lapsed. But in the year 2020, he wrote to the then Hon'ble Vice-Chancellor to consider his case citing adequate ground for his prolonged absence. Accordingly, the competent authority granted him the Permission to continue the research work and present his final registration seminar by 31.12.2020.

Accordingly, Brig. R.P. Singh presented his final registration seminar on November 28, 2020. Subsequently, he submitted his thesis after presenting presubmission seminar on 27.09.2022 as per old Regulations. After submission of the thesis, the examination section raised certain queries with regard to his extension/re-registration between provisional registration and final registration. After discussing the merit of the Case, it may be noted that the scholar concerned (Brig. R.P. Singh) has already submitted the thesis after the competent authority had recommended his case for Continuation of research and presentation of the final registration, although there was huge lapse of time. He also happens to be an army personnel who generally faces various exigencies

of circumstances which might have caused this delay. Hence, it is recommended that Brig. R.P. Singh's case may be regularized in the relevant statutory bodies by granting him retrospective extension for the period 2019-20 and treating the remaining period pandemic extension as per UGC guidelines.

Hence, Brig .R. P. Singh's Thesis submission may also be treated regularized
