At the outset, the Chairman welcomed all the Members. The Chairman expressed thanks to Prof. Ramesh C. Deka & Dr. L. N. Bora, Visitor's Nominee for attending the meeting. The Chairman also introduced Prof. Sivasish Biswas, Pro-Vice Chancellor, A. U. Diphu Campus as new member of EC. Thereafter, the meeting formally started.

#### (A) Agenda item for confirmation:

Item No. 1: Confirmation of the minutes of the 108th, 109th & 110th Meeting of EC:

EC:111:05-17:1: The minutes of the 108th, 109th (Special) & 110th (Special) Meeting of the Executive Council held on 24th November 2016, 24th January 2017 & 23rd February 2017 respectively are placed for consideration and confirmation.

**Resolution:** The members perused all the minutes of the meetings concerned and confirmed all with the following observations. That:

- (a) Action taken report be placed from the next meeting of EC.
- (b) The word "reprimanded" stands deleted in the EC resolution No. **EC:109:01-17:11.6** where as Prof. Apurbananda Mazumder, Dept. of Business Administration, EC member as Dean was given the responsibility to resolve amicably the issue immediately for which the said resolution was adopted in 109th meeting of EC.
- (c) For preparation of ATR, concerned officials of the respective departments/sections where actions are to be taken shall communicate the appropriate authority after publication of minutes of the Executive Council.
- (d) All officers and Head of the Department/Section need to be present in office during the period of holding of Executive Council meeting.
- (e) Correction/modification if any is required in the minutes of the Executive Council, the same has to be reported to the Registrar well in advance before holding of the Executive Council for placement in the agenda for confirmation.
- (f) The resolution of 109th EC vide No. EC:109:01-17:10 is corrected as under:

The house further decided that the academic departments can spend the amount of Annual Course Fee generated in a particular in a academic year upto 15<sup>th</sup> December of the following academic year. All advance adjustment/reimbursement claims in this connection have to be settled before 31<sup>st</sup> December and after 31<sup>st</sup> December, the unutilised course fee of the particular academic year shall be deposited in the University MRF. Reversion of fund from MRF shall not be allowed any further.

#### (B) Agenda item for approval by the Council:

### Item No. 2: Extension of lien of Dr Nigamananda Biswas for another year:

EC:111:05-17:2: Dr Nigamananda Biswas has joined Aligarh Muslim University, Murshidabad Centre, West Bengal on lien from this University w.e.f. 13/6/2016 to 12/6/2017 in the department of Business Administration as an Associate Professor. The authority of AMU, Murshidabad Centre has requested to extend his lien for another year w.e.f. 13.6.2017 to 12.6.2018. In the letter dated 25.2.2017 the Director, AMU, Murshidabad Centre has stated that confirmation of the service of Dr Biswas may require time for completing all the official formalities and hence he has requested for extension of lien. As per the offer letter of Dr Biswas issued by the AMU dated 01/06/2016, the probation period is one year. Authority of this University may like to extend the lien for six months giving sufficient time to complete the process of confirmation of his service there. The item was placed before the Council for consideration and approval.

**Resolution:** The Council approved the issue subject to furnishing of papers by the incumbent that his probation period is over.

### Item No. 3: Extension of lien of Dr Kabindra Singh Brijwal for another year:

EC:111:05-17:3: Dr Kabindra Singh Brijwal has joined Banaras Hindu University, Varanasi on lien from this University w.e.f. 10/3/2016 to 9/3/2017 in the faculty of Law as an Assistant Professor. Dr Brijwal has requested to extend his lien for another year w.e.f. 10.3.2017 to 9.3.2018. In the letter dated 11.2.2017 Dr Brijwal has stated that his service is yet to be confirmed by BHU and hence he has requested for extension of lien. As per the offer letter of Dr Brijwal issued by the BHU dated 22/02/2016, the probation period is one year. Authority of this University may like to extend the lien for six months giving sufficient time to complete the process of confirmation of his service there. The item was placed before the Council for consideration and approval.

**Resolution**: The Council approved the issue subject to furnishing of papers by the incumbent that his probation period is over.

### Item No. 4: Termination of service in respect of Shri Nitin Kumar & Ms Anamika Yadav:

EC:111:05-17:4: In continuation of the order even no. dated 11/11/2016 and as Shri Nitin Kumar has been treated as having resigned from the post of Assistant Professor, Dept of Agricultural Engineering of this University, the service of Ms Anamika Yadav appointed against the leave vacancy of Shri Nitin Kumar is hereby terminated with effect from the date of issue of this order as per the terms and conditions of the offer of appointment. This is with the approval of the competent authority. The item was placed before the Council for consideration and approval.

**Resolution**: The Council approved the proposal.

#### Item No. 5: Change of home town in respect of Dr Indra Nil Sanyal, Dept of French:

EC:111:05-17:5: Dr Indra Nil Sanyal, Associate Professor, Dept of French has applied for change of his home town from Varanasi to Allahabad. He has stated that he has purchased an ownership flat at Allahabad (Uttar Pradesh). He has submitted an application for the above purpose duly filled in and attached a copy of 'Khasra' issued by Allahabad Municipal Corporation. As per LTC rule Dr Sanyal is entitled to change his home town under Clause (ii) of CCS (LTC) Rule. The item was placed before the Council for consideration and approval.

**Resolution**: The Council approved the proposal.

## Item No. 6: Leave matter of Dr Ajita Tiwari, Asstt. Prof., Dept of Agri. Engg.

EC:111:05-17:6: Dr Ajita Tiwari, Asstt Prof, Dept of Agricultural Engineering was absent from her duties from 27/10/2014 to 4/5/2015. As per rule an employee has to apply for leave to the authority well in advance. After getting approval from the authority then only the employee can proceed on leave. In the case of Dr Tiwari it was not done from her part. Moreover, in her applications dated 10/10/2014 and 22/11/14 the subject and context of applications are different. These applications cannot be treated as leave applications as she did not follow proper procedure for applying for leave. Further leave is not a matter of right. Hence the period of absence from 27/10/14 to 4/5/15 (i.e. 6 months 10 days) can be treated as unauthorized absence as per CCS (Leave) Rule. The matter was placed before the EC in its 108th meeting and it was decided in the meeting to look into the matter administratively. It is not the first instance of unauthorized absence on her part. Earlier also she was granted extra ordinary leave for 199 days from 25/7/2012 to 7/2/2013 for overstayal of leave and her salary was withheld for three months i.e.

from February to April 2013. It may be noted that Dr Tiwari has taken leave and remained absent from her duties frequently during the last few years. A detailed absentee report along with a brief of the case in respect of Dr Tiwari was placed for perusal. Appropriate decisions as approved in the file and enclosed herewith may be considered. The item was placed before the Council for decision.

**Resolution:** The matter was discussed in length and considering the various rule provisions for the issue, the Council was in the opinion that the said case may be considered subject to a written submission from the incumbent to deal with her case sympathetically, along with an assurance that such happenings will not repeat again where as the University administration shall grant her leave under appropriate rule in force subject to an application from Dr. Tiwari to allow leave of the kind due.

## Item No. 7: Lien matter of Dr. Vinay Kumar Rao, Asstt. Prof., Dept. of History:

EC:111:05-17:7: Dr. V K Rao was granted lien for 1 year for the period 11.8.2015 to 10.08.2016 as per Assam University lien regulation to join Central University of Punjab (CUP). Further, Dr. V. K. Rao also applied for the post of Associate Professor in August 2014 while in Assam University and his application was routed through proper channel. Meanwhile, in December 2015, in 5<sup>th</sup> month of his lien, he applied for extension of lien by one more year. The said application couldn't be processed for further extension of lien without knowing the status of confirmation of his service at CUP. Later on, a mail has been received dated 13<sup>th</sup> June 2016 in which Dr. V K Rao has mentioned that he has resigned from CUP and joined Central University of Haryana (CUH). However, the content of the letter was not clear and seemed ambiguous as on 13<sup>th</sup> June 2016, Dr. V K Rao mentioned that he joined CUH on 12<sup>th</sup> July, 2016. In the said letter, Dr. Rao sought for transfer of lien in favour of CUH from CUP. It was later clarified vide his email dated 28<sup>th</sup> July 2016, that Dr. Rao has in fact joined CUH on 12<sup>th</sup> July 2016.

It may be mentioned here that Dr Rao was released on lien as per AU Regulation on lien & other terms and conditions as per O/O No. 103/175/2004-Pers/579-606 dtd. 04.08.2016. The release was specifically for CUP and not CUH. Further, as per AU Regulation on lien there is no provision of transfer of lien. The transfer of lien as prayed for by Dr. Rao in his email dtd. 13th July 2016 citing DOPT references is not applicable to the instant case. Therefore, Dr. Rao ought to have joined Assam University after the completion of purpose/period of lien whichever is earlier instead of directly moving to CUH from CUP. It may be mentioned further that as per AU Regulation on lien, an employee on joining AU after a spell of service outside University shall have to serve the university for a minimum period of 3 years before he is considered for grant of lien for another spell. Thus under all

circumstances, Dr Rao was not entitled immediately for another spell of lien in a different University. Accordingly vide letter no. 103/175/2004-pers dtd. 3<sup>rd</sup> April 2017, Dr. Rao was informed that his joining of CUH is not within the provision of AU Regulation on lien and therefore he should join Assam University within 7 days for violation of terms and conditions of Regulations of lien and to avoid termination of service. However, the University has not received any response from Dr. Rao thereafter. Hence the matter was placed in EC to decide whether-

- (i) to terminate the service of Dr Rao for not complying with the letter no. 103/175/2004-Pers dtd. 3<sup>rd</sup> April 2017, as mentioned above
- (ii) to issue another ultimatum to Dr V K Rao asking him to join within 15 days failing which his service will be terminated and his release from Assam University will not be considered as routing through proper channel as "resignation is treated as a technical formality where Govt. Servant has applied through proper channel...." (DOPT OM enclosed)
- (iii) Any other decision EC deems fit.

The item was placed before the Council for decision.

**Resolution:** The matter of lien in respect to Dr. Vinay Kumar Rao, Asstt. Professor, Dept. of History was discussed in detail. After a long deliberation on his issue the Council decided to consider Dr. Vinay K Rao to have deemed to be resigned from the date of initiation of lien. The resignation shall however be considered as a technical resignation.

### Item No. 8: EOL matter of Dr Ranjit Singh, Asstt. Prof., Dept. of Business Administration:

EC:111:05-17:8: Dr. Ranjit Singh was released on Extra Ordinary Leave (EOL) for the period from 2/5/2013 to 1/5/2014 to join IIIT Allahabad as Associate Professor. His EOL was further extended upto 2/8/2014. Dr. Ranjit Singh approached Assam University for rejoining after relieve from IIIT Allahabad on 31/7/2014. At the time of joining it was noticed that Dr. Singh's regular service at IIIT Allahabad was cancelled on 26/3/2014 and was in contractual service for the period from 27/3/2014 to 30/7/2014 without any intimation to Assam University. As a result Assam University was not in a position to regularize his period of contractual service as there was violation of the condition on which EOL was granted. Recently, on the basis of a case filed by Dr. Ranjit Singh & others in Allahabad High Court, judgment was pronounced by Hon'ble High Court setting aside the cancellation of regular appointment of Dr. Singh & others and consequent termination from the post of Associate Professor. However, there has been no intimation of regularization of the contractual service of Dr. Singh for the above mentioned period from IIIT Allahabad. Unless there is such information from IIIT Allahabad, Assam University suo-moto cannot implement Allahabad High Court's Order as the University is

neither a party to the case at Allahabad High Court nor there is any directive to Assam University in this regard. Therefore, Assam University may write a letter to IIIT Allahabad to communicate Assam University if it has modified its decision in regard to contractual service of Dr Ranjit Singh for the period from 27/3/2014 to 30/7/2014 in the light of Allahabad High Court decision vide writ petition No. 21920/2014 as submitted to us by Dr Singh. Based on the information from IIIT Allahabad, Assam University will take necessary action accordingly.

The item was placed before the Council for perusal and approval.

**Resolution:** The EOL matter of Dr. Ranjit Singh, Asstt. Professor, Dept. of Business Administration was discussed considering existing rule provisions and after a detail discussion the Council directed the administration to treat the entire period of EOL as non-qualifying service for the purpose of counting of service benefits.

# Item No. 9: Matter regarding promotion of Dr. Mukut Sarmah as per directive of Hon'ble Gauhati High Court Order:

EC:111:05-17:9: Hon'ble Gauhati High Court vide its order dtd. 16/3/2017 in WP (C) No. 2563 of 2015 in the matter of Dr. Mukut Sarmah, directed Assam University to reconsider the claim of the petitioner for promotion to the post of Associate Professor (stage IV) in the AGP 9000 by treating the previous service rendered by the petitioner in the post of Librarian and Senior Librarian as equivalent to the post of Assistant Professor within two months of the receipt of certified copy of order. It may be noted that Dr. Sarmah served as Librarian of Pandu College from 27.11.1998 to 19.11.2009. On 20.11.2009, Dr. Sarmah joined this University as Assistant Professor with Ph.D. degree in his credit. Dr. Sarmah was granted Assistant Professor stage II scale by the University on 20/11/2013 without counting his past service as Librarian following which Dr. Sarmah approached Court. It has been noted in the said order of the High Court that learned Counsel appearing for UGC opined that the stand of Assam University in this regard is correct. However, in compliance of the directive of the High Court for promotion to the post of Associate Professor (stage IV) by counting the past service of Librarian, Assam University has issued a memo dated 11th May 2007 requesting Dr. Sarmah to submit updated application in prescribed proforma for initiating selection committee process as per UGC regulation 2010 for placement in the Associate Professor with AGP 9000/-. IT has been particularly noted in the said memo that as UGC, New Delhi is the funding authority of the University and counting of past service, pay scale, promotion/placement to higher AGP etc. of teachers are regulated by UGC Regulations, so the placement of Dr. Sarmah to AGP 9000/- shall be subject to concurrence and approval of the UGC. Accordingly, the case has been prepared for referring to UGC. Thereafter, Hon'ble

High Court has to be informed within due period of two months (15/5/2017) that as per directives of the High Court, the case of Dr. Sarmah has been duly considered by the University & the action has been initiated to promote Dr. Sarmah to the post of Associate Professor with AGP 9000/- by treating the previous service rendered by Dr. Sarmah in the post of Librarian and Senior Librarian as equivalent to the post of Assistant Professor. Matter has been also referred to UGC for compliance. On selection to the post of Associate Professor by the duly constituted Selection Committee and concurrence and approval by UGC, the University shall immediately place Dr. Sarmah to the post of Associate Professor with AGP 9000/-. The item was placed before Council for perusal and approval.

**Resolution:** The Council after a threadbare discussion decided to wait for one month for consent from UGC in the matter. However, if no reply is received from UGC or otherwise within one month, the Council authorised the Vice-Chancellor to take necessary action as per the existing directives of the High Court for release of arrear dues.

#### Item No. 10: Appointment of Heads of Departments, Diphu Campus:

#### EC:111:05-17:10:

- 1. **Dr. Kh. Narendra Singh**, Associate Professor, Department of Anthropology was appointed as Head, Department of Anthropology w.e.f. 15.01.2014 to 14.01.2017. The tenure of Headship of Dr Singh has expired on 14.01.2017 and the Department has no other Professor and Associate Professor. As such as per the provision of Statute 8.(3) Dr Singh may be reappointed as Head, Department of Anthropology for another three years.
- 2. **Dr. Ajit Kumar Tamuli**, Associate Professor, Department of Life Science was appointed as Head, Department of Life Science w.e.f. 15.01.2014 to 14.01.2017. The tenure of Headship of Dr Tamuli has expired on 14.01.2017 and the Department has no other Professor and Associate Professor. As such as per the provision of Statute 8.(3) Dr Tamuli may be reappointed as Head, Department of Life Science for another three years.
- 3. **Dr. Paul B. Chonzik**, Associate Professor, Department of History was appointed as Head, Department of History w.e.f. 15.01.2014 to 14.01.2017. The tenure of Headship of Dr Chonzik has expired on 14.01.2017 and the Department has no other Professor and Associate Professor. As such as per the provision of Statute 8.(3) Dr Chonzik may be reappointed as Head, Department of Life Science for another three years.
- 4. **Prof. Ranjit Singha**, Department of Physics was appointed as Head, Department of Geography w.e.f.12.08.2014. Prof. Singha has requested to be relieved from the responsibility of Headship from the Department of Geography. Head in-charge of the Department amongst the Assistant Professors as per seniority may be appointed for a period of three years or till the joining of Professor/Associate Professor in the Department whichever is earlier.

### Item No. 11: Enhancement of ceiling on approval and sanctioning power of the Pro Vice Chancellor, Diphu campus:

**EC:111:05-17:11**: Delegation of power to the Pro Vice Chancellor, Diphu campus in connection with the day to day functions (academic and administrative) of the Assam University's Diphu Campus.

- i. The Pro-Vice Chancellor, Diphu campus has placed a request to review the Delegation of Power delegated to the PVC, Diphu Campus issued on July 13, 2007 keeping in view increase in consumptions and expenses.
- ii. As per Delegation of Power, Pro Vice Chancellor Diphu Campus, the Pro Vice Chancellor, Diphu campus has placed a request to enhance the approval and sanction limit to full reimbursement only on account of medical reimbursement of staff as per AUMAP and CSMA rules in each case.

The matter was placed before the Council for consideration.



EC:111:05-17:42.7: All the Assistant Registrar of the University have submitted representations for framing of Recruitment/Promotion Rules in the University as per the guidelines UGC and DoPT in recent past. The relaxations as proposed by

them are supported by the specific guidelines provided by the competent authority. The guidelines as provided were placed in the meeting for consideration and approval of the Council for implementation in the University.

**Resolution:** The representation of the Assistant Registrars of the University were perused by the members and also on perusal of the concerned guidelines communicated by the UGC, the Council considered and approved the following modifications for the Assistant Registrars of the University.

- (i) The requirement of 08 years service in respect of incumbent Assistant Registrars in PB-3 with GP of Rs. 5400/- for placement in Senior Scale in PB-3 with GP of Rs. 6600/- is reduced to 05 years service (Ref:-UGC letter no: 69-4/2012(CU) dtd. 14th August, 2015 endorsing the DoPT OM No AB.14017/13/2013-Estt (RR) dated 31st March, 2015 and DoPT OM no. AB.14017/45/2010-Estt (RR) dated 31.12.2010.)
- (ii) The Assistant Registrars (Senior Scale) having Grade Pay of Rs. 6600/- will be eligible for promotion to Deputy Registrar which shall be 25% of the total sanctioned posts of Deputy Registrar if they complete 05 years of service in the Senior Scale with Grade pay of Rs. 6600/-(Ref:-UGC letter no. 6-7/97/(JCRC) Vol IV dated 01st October, 2014(Clause(II)).
- (iii) The requirement of 02 Orientation Programme/Training Programmes in Educational Administration will not be a bar for placement of incumbent Assistant Registrars in the senior scale carrying the GP Rs. 6600/- in PB-3 and subsequent promotion to Deputy Registrar, since such programmes have not been held in the University for the last 20 years. However keeping in view the rare conduct of orientation programme/training programme of 04 weeks by the Universities the Council directed the administration to hold such programme at the earliest and provide the Assistant Registrars/Deputy Registrars with adequate opportunity for attending the same.

# Item No. 42.8: Confirmation of service of Shri Debasish Chakraborty in the post of Public Relation Officer:

EC:111:05-17:42.8: Shri Debasish Chakraborty joined to the post of Public Relation Officer on 08-04-2015 as per offer of appointment letter no. 102/1(NT)/2014-Estt, dtd. 08-04-2015. He was granted lien for two years w.e.f. 08-04-2015 vide office order no. 103/519/96-Pers/3199-3203, dtd. 01-06-2015.
