Item No. 3: Launching of B. Voc. in (i) Food Processing and (ii) Farm Machinery and Power Technology programme in the Assam University:

Item No. 4: Launching of online admission process in the Assam University:

Item No. 6: Establishment of new Department in Assam University, Silchar:

Item No. 7: Infrastructure development of the University:

PB:16:11-15:7: On sanction of a Kendriya Vidyalaya in the University by the concerned ministry the administration has taken steps for construction of buildings for Kendriya Vidyalaya. Also to implement the Wi-fi facility covering the University area and Solar Power Project is being processed.

Item No. 8: Regulation of PG, Integrated courses and UG courses under Choice Based Credit System (CBCS):

PB:16:11-15:8: The 74th meeting of Academic Council held on 3rd October 2015 vides resolution No. AC:74:10-15:42, has accepted a Regulation called "Assam University Regulations governing Post Graduates, Integrated and Undergraduate Programme under the Choice Based Credit System (CBCS) ". These programmes are offered only to the students admitted in the University campus in Silchar and Diphu and Haflong Govt. College (in some subjects). The Vice Chancellor has approved the same. These regulations shall come into force from the academic year 2015-2016.

The matter as reported were perused by the Board and recommended for implementation.
