Jain (Rtd.), Director, Army Institute of Management, Kolkata, Dr. Atindra Kumar Adhikari, Principal, Assam Medical College, Dibrugarh and Chief Rector's Nominee Dr. Parimal Ch. Bhattacharjee, (Retd.) Professor & HOD of Zoology, Gauhati University and Prof. Dilip Kumar Dey, (Retd.) Professor & Principal, Govt. T. T. College, Silchar. The following items were taken up for discussion.

Item No. 1: To confirm the Minutes of 16th meeting of the University Court held on 13th November 2014:

Court:17:11-15:1: The Minutes of the 16th meeting of the Court held on 13th November 2014 was placed for confirmation. No comments were received from the members and accordingly the minutes were considered confirmed.

Item No. 2: Annual Report for the year 2014-2015:

Court:17:11-15:2: The Annual Report for the year 2014-2015 as approved by the 98th Meeting of the Executive Council vide resolution No EC:104:11-15:01 dtd. 27th November 2015 was placed before the Court for consideration and approval. The same will be forwarded to the MHRD for placing before the Parliament. The Director, IQAC has highlighted the gist of the Annual Report 2014-15.

After deliberations by the members, the Court approved the same and authorized the Vice Chancellor to submit the Annual Report to the MHRD for placing before the Parliament. However, the members suggested that attempt should be made in future to make the Annual Report readers friendly.

Court:17:11-15:3: The audited Annual Accounts and Separate Audit Report of Comptroller & Auditor General of India on the accounts of Assam University for the Financial Year 2014-15 with its compliances placed at Annexure - B as approved by the Executive Council in its 102nd meeting held on 26th June, 2015 vide Resolution No. EC:102:06-15:16 and its 105th meeting held on 27th November 2015 vide Resolution No. EC:104:11-15:03 respectively were placed before the Court for consideration, approval and adoption. The same is required to be submitted to MHRD for placing before both the Houses of Parliament. The Finance Officer highlighted the fact and figure of the Annual Accounts 2014-15.

After deliberations by the members, the Court has approved the same and authorized the Vice Chancellor to submit the Annual Accounts for the year 2014-15 to MHRD for placing before the Parliament.

Item No. 4: Approval of Revised Budget Estimate for the Financial Year 2015-16 and Budget Estimate (Non-Plan) for the Financial Year 2016-17.
