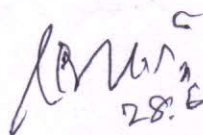
**Item No. FC: 42/02: Confirmation of the Minutes of the 41st meeting of the Finance Committee of the University held on November 27, 2015.**

The copy of the Minutes of the 41st meeting of the Finance Committee of the University held on November 27, 2015 were circulated to all the members vide letter no. AUF/686/FC-41/2015-16/4964, dated December 17, 2015. In response to the Minutes circulated, Joint Secretary, UGC, New Delhi in his e-mail dated January 20, 2016 remarked that "the minutes of the meeting have been examined in this office and it is observed that all the annexures are not available with the minutes and, therefore, it is not possible to give comments on the minutes as a whole. However, it is requested that before acting on item nos. 41/08 and 41/12, it may kindly be ensured that 1) the total cost of the building projects is well within the allocation and 2) total expenditure on buildings is not more than 50% of the allocation under the head-35. With these observations, the minute seems to be in order".

As the above observations of the Joint Secretary, UGC have been complied with, the Minutes may kindly be confirmed.

**Resolution:** The Action Taken Report on the Minutes of the 41<sup>st</sup> Meeting of the Finance Committee of the University held on November 27, 2015 were perused and noted by the Members of the FC with following observation:

1. As regards to the observation of UGC on Item No. 41/04, Para 3.3, the Committee reiterated its view that "if the observation of Audit will be followed in the accounts, there will be double booking of expenses in the Utilisation Certificate to be submitted to the UGC, the funding agency. As UGC has issued letter vide No. AUF/686/FC-41/2015-16/5205, dated 28th December 2015 by the University for providing necessary compliance and no compliance has been received on this issue, the Committee opined that a reminder may be issued to the UGC with a copy to the MHRD for necessary clarification on the matter.
