## **CONCEPT NOTE:**

The initiative of the Government of India (GOI) towards effecting the country's gradual transition to a 'cashless economy' mode has triggered many a debates. While, in an ICT-driven era of networked societies, the compulsions propelling the move is rather obvious, given the state of the country's ICT-prepare dness, the timing of the move is being questioned from many a quarters.

Nonetheless, the likely positive fall-outs of the move are seen as overarching. Indian economy needs to be smarter and cleaner where money can move from one end to the other at the 'speed of light'. Transactions need to be more transparent and easily trackable; and at least should no longer allow the creations of numerous black-holes of corruption. The prevalent channels of corruption which - by pushing up the 'transaction-costs' - have already rendered many sectors of the economy uncompetitive and unviable, need be urgently plugged, if India were to make its presence felt in global markets where cost-standards and delivery-schedules of late have become more important than ever before. The reports of the Boston Consulting Group (BCG) mentioned that, in the year 2015, while 75% of transactions in India were cash based, the said proportions in countries like US, Japan, France and the like were only around 20-25%. This provides a telling testimony of the state of affairs in India as compared to the developed countries of the globe.

Yet, any transition brings in its train certain inevitable hiccups and initial difficulties that need to be braved if the goals were to be duly accomplished. What matter at the moment are the right-planning of the proposed transition, the sequencing of the phases and then a vigorous drive for raising the country's preparedness-level. In the cashless era, payments are increasingly likely to be on e-platform via such modes as electronic / mobile banking, e-wallets / mobile wallet and other apps. In this emerging scenario, all technology and applications linked to electronic / mobile transactions are to be in the forefront. Given the current state of e-literacy of people and the extent of their preparedness, the launching of a massive orientation-drive for inculcating in stakeholders the 'bare minimum' capability for handling the new 'technologies' and for surviving and growing in the cashless regime is therefore seen as the prime need of the hour. In the same vein, discussions and Workshops need to be arranged for sensitizing the educated youth to the numerous opportunities that are likely to be opened up as India proceeds along the path of 'creative destruction'.

# The specific objectives of the seminar are:

- (1) Exposing and orienting participants to the numerous modes of paym ents and transactions in a 'cashless' era;
- (2) Examining the 'security' question in relation e-transactions and introducing participants to the security-essentials;
- (3) Sensitizing the participants to the opportunities expected be triggered by the change-over to the cashless era; and
- (4) Engaging participants to draw up road-maps for carrying forward the sensitization campaign to other layers in society.
