

# Item No. 5: The matter related to promotion of Dr. Arjundev Sensarma, Dept. of Indian Comparative Literature:

**EC:117:03-18:05**: The matter of promotion of Dr. Arjundev Sensarma was kept on hold due to complaint of irregular appointment as forwarded by MHRD.

On prima-facie examination, the complaint does not seem to be based on fact. As it was decided in similar other cases of promotion previously in 116<sup>th</sup> meeting (Special) meeting of the Executive Council held on 11<sup>th</sup> January, 2018 vide Resolution No. EC:116:01-18:4 that the matter of promotion should not be tagged with MHRD complaint, therefore, the matter of promotion of Dr. Arjundev Sensarma may be considered as per the recommendation of the Selection Committee.

Resolution: The Council noted with reference to the resolution of 116<sup>th</sup> meeting (Special) of the Executive Council vide Resolution No. EC:116:01-18:4 and on the basis of administrative scrutiny report, approved the recommendation of the Selection Committee in respect of Dr. Arjundeb Sensarma, Assistant Professor Stage - III to Associate Professor w.e.f. 04/06/2015. However, the Council was in the opinion that the matter be referred to appropriate authority (UGC/MHRD) for information.

#### Item No. 6: Item from the Chair:

EC:117:03-18:06.1: Enquiry Committee for illegal promotion of Prof. Samira Behera, Deptt. of Mathematics.

**Resolution:** The Council discussed the matter of illegal promotion of Prof. Samira Behera, Deptt. of Mathematics and resolved that the Enquiry Committee constituted vide Order no. AUR/21-1/2018/1023 dated 12/02/2018 stand cancelled, as one of the member of the Committee expressed his inability to participate in the process. Thereafter the Council authorized the Vice Chancellor to constitute a new Enquiry Committee at the earliest to deal the issue.

#### EC:117:03-18:06.2: Report of Internal Complaint Committee (ICC):

**Resolution:** The ICC report vide No. ICC/CR/09/2018 dtd 7<sup>th</sup> March 2018 signed and submitted by the Chairperson to the Vice Chancellor was placed before the Council for a decision on the recommendation made by the Committee. On perusal of the report the Council resolved to accept the recommendation for imposing major penalty of compulsory retirement under Rule 11 of CCS (CCA) against Sri Sabir Ahmed.
