16th Convocation of Assam University is going to be held on **16th March, 2018** in Assam University Silchar Campus.


The degrees that will be conferred in the 16th Convocation are as follows :

1. M.Phil. and Ph.D. degrees awarded on or after 25-01-2017 and on or before 26.02.2018.
2. Post Graduate, Under Graduate, Integrated, Diploma, B.Ed., L.L.B. and Three Year Degree Courses (B.A., B.Sc., B.Com., B.B.A., B.C.A.) completed in any of the following :
 - (a) Odd Semester Examination 2016
 - (b) Even Semester Examination 2017
 - (c) Odd Semester Examination 2017 (Results published on or before 26.02.2018)
3. **Annual Examinations (Special Chance – New Course) 2016, held in January, 2017.**

Candidates who are eligible and willing to attend the Convocation should apply online for registration in the prescribed online form available at www.ausconvocation.in w.e.f. **7th February 2018 (11 a.m. onwards)**. **Last date** of submission of application forms along with all supporting documents is **26th February 2018, 5:30 P.M.** Student willing to participate in the 16th Convocation is required to deposit a fee of `1500/- (Rupees one thousand five hundred) only through **NEFT/Net Banking** to “**Assam University Convocation Account**”, **Account No. 20050110009109, Bank Name – UCO Bank, Branch – Assam University, IFS Code – UCBA0002005** on or before the last day of application and upload the scanned/soft copy of the receipt in requisite format along with the application form.

There will be a **rehearsal on 15th March, 2018** at the Assam University Silchar Campus for those attending the Convocation. **Applicants must report to the University Campus by 10:30 A.M. of 15th March, 2018** for the same and for collection of Convocation Uttoriyo etc. Participation in the rehearsal is compulsory for all the candidates who are willing to attend the Convocation.

Students not willing to attend the Convocation may apply for the Original Certificates after Convocation as per normal procedure.
