About the Conference

The 8th November declaration is a generations' memorable experience and is going to be one of the economic events of our time. The debate

over the demonetisation, following the Prime Ministerial declaration on 8th November 2016 has triggered new political, economic, social and legal discussions in the country. The discussions as usual follow the popular pattern of analysing the merits and demerits of the demonetisation, efficiency of the measure in achieving the envisaged outcomes, its timing, managerial issues, institutional frictions and inertias, legality and legitimacy of the policy decisions etc. Interestingly, the notification is coupled with another major economic reform i.e., a drift towards digital economy.

The implications of such reforms attempting a sweeping change in economic structure are beyond human imaginations. There is an uncertainty about what could be the possible impact on various sectors of economy and its elements. The human consequences, whether are they accounted for or not, is an important policy matter when such reforms are attempted. This raise, on one side, the questions of accountability and responsibility and on the other side, the need for efficiency and enforceability of monetary laws gain prominence and compete equally well, if not higher. The balancing is more complex, when claims are presented in the wrapper of public and national interest.

Therefore, the academic fraternity of Department of Commerce, Assam University Diphu Campus feels there is much more to be discussed about new demonetisation notification than from the popular standpoints. Moreover the experiences of the new notifications have been unalike in different states of the country. It is closely related to their market structure, to the level of social and political maturity of the populations; and to the trading traditions and customs. We hence decided to organise a national seminar to collate various perspectives from different parts of the country and to mark a research co-ordination in the area of Law and Monetary Policy. Various scholars and practitioners from different parts of the country and from the diverse streams of discipline such as,

economics, law, political science, monetary science, banking sector, finance, management etc. may engage in the deliberations.

With this agenda, the Department of Commerce, Assam University Diphu Campus, Diphu, Karbi Anglong, Assam, India plans to organize The National Conference on "DEMONITISATION AND APPROACHES TOWARDS DIGITAL INDIA".

Guidelines for Full Paper Submission

We encourage academicians, research scholars, & professionals to submit their full papers which would undergo a double blind peer review process. Kindly refer to the following guidelines before submitting manuscript:

- ➤ Each research paper/ case study must clearly address one or more of the above listed topics.
- Abstracts may be within 200-400 words and cover a brief introduction, followed by the objectives of the paper, methodology used, findings in brief and implications along with key references.
- Submitted manuscripts must not have been previously published, presented, accepted for publication for any other journal or research conference/ seminar.
- The entire manuscript (including cover page, abstract, main text, appendices, and references) should be included in one document.
- All author related information name, affiliation, and contact details should be mentioned only in the cover page and any information conveying identification of the author(s) (including name, affiliation, and acknowledgements) must be removed from the manuscript.
- Manuscript must be submitted in A4 size pages with double-spaced, Times New Roman-12 pitch in MS Word compatible format text.
- The length of research papers (including exhibit and references) should be between 3000-5000 words.
- ➤ List the references should be in alphabetical order at the end of the paper. All references must be single spaced. The references should be distinguished by hanging indents.

- All the papers will be blind reviewed by an expert committee with respect to their quality, originality, and relevance. Articles will be subject to plagiarism check before being sent for review process.
- ➤ In case of more than one authors, each author has to individually register to attend/participate and avail the conference kit/Certificate. Otherwise conference kit/Certificate will be provided to the registered author only. All rights of publication of papers presented in the conference shall rest with the Conference Organizers.
