



It is for the information of the Committee that in May 2015, in the meeting of the Principals Chaired by the Hon'ble Vice-Chancellor decided that the honours course scripts shall also be got evaluated from the Zones by enhancing the honorarium by 50%. Accordingly the Zonal evolution work was carried out. The enhanced honorarium as under was approved in the Principals' meeting held on 4th March, 2016, which was presided over by the Vice Chancellor-in-charge for even and odd semester Examination 2015 only.

Thereafter, with effect from Even Semester Examination 2016, responsibilities of evaluation of honours course scripts taken back by the University and work of different Zones remained restricted to pass course subject papers only. However, Principals' as Zonal Officers are insisting for regularization of honorarium with effect from Even Semester Examination 2016 onwards at the enhanced rates as stated above.

In the course of deliberation in the Academic Council, some members of the Council from Assam College Teachers' Association put forth their views regarding enhancement of remuneration for TDC examination works. The Council considered for enhancement of the remuneration for TDC examination related work to the extent of certain percentage. The existing rates of remuneration vis-a-vis proposed enhanced rates are as under:

Resolution: The recommendations of the Academic Council were discussed in detail in the meeting and after threadbare discussion, the Committee resolved the followings:

- (i) As recommended by the Academic Council, the Finance Committee approved the enhancement of Fee Structure of TDC examinations.
- (ii) The Committee feels that enhancing the honorarium to the designated officials for the TDC Examinations of the Zones to 50% is not at this stage advisable, considering the inadequate internal resources of the University at present. Therefore, the Committee approved the Honorarium Structure recommended by the Academic Council for TDC Examinations to the Zones with an enhancement of 20% for the designated officials of the Zones.
- (iii)As recommended by the Academic Council, the Finance Committee approved the enhancement of the proposed remunerations for TDC Examinations with a slight modification for Sl. No. (d) for the Examiner that "Rs. 15/- per script (Pass Course) and Rs. 20/- per script (Honours Course) subject to minimum of Rs. 500/- per Examiner".

The copy of the relevant portion of the resolution of the $81^{\rm st}$ Academic Council meeting regarding Fee Revision of the MBA students was placed in the meeting as Annexure to the agenda for consideration and recommendation to the Executive Council of the University for approval.

Resolution: The proposal was discussed in detail in the meeting and the members opined that the fee revision should be proposed considering the mandate of the University, vulnerability of the stakeholders' vis-à-vis generating internal resources and reviewing the expenses of the University at large.

Therefore, the Committee suggested that the fee revision should be proposed considering the above factors into account by a duly constituted Fee Revision Committee with Deans/HoDs, Registrar, Finance Officer & Controller of Examinations being the members and a reasonable fee revision thereafter, should be placed before the Finance Committee after due recommendations by the Academic Council.

Item No. FC: 49/08: Approval for enhancement of Honorarium for evaluation of research publications by the External Experts for consideration in CAS promotions.

The Academic Council in its 81^{st} meeting held on 5^{th} May 2018 vide Resolution No. AC:81:05-18:34 recommended the following for payment and enhancement of Honorarium for evaluation of research publications by the External Experts for consideration in CAS promotions.

The external subject experts who are evaluating research publication/books etc of the internal candidates applied for and to be considered under CAS promotions [Asst Professor Stage 3 to Associate Professor and Associate Professor to Professor] are entitled for payment of honorarium after evaluation of the publications send to them. The External Experts have been paid an honorarium @ Rs. 1,000/- per Expert/per Candidates as in the case of External Experts are paid for Ph.D. thesis evaluation. Some experts have requested for enhancement of honorarium for Evaluation of Research Publications under CAS promotions. Therefore, Academic Council recommended that an enhanced rate for the evaluation may be fixed to the tune of Rs. 1,500/- and \$ 25 (for foreign examiner of SAARC countries) per expert/per candidate.

The matter was placed before the Executive Council vide EC: 115:11-17:05 for approval. The Executive Council opined that the matter may be first referred to the Academic Council for justification and recommendation of enhancement from Rs. 1,000/- to Rs. 1,500/- and submitting it to the Finance Committee for recommendation before placing it to the Executive Council.

Pretext & Justification: The honorarium of Rs. 1,000/- for evaluation of research publication i.e., five publication for promotion to Professor under CAS has been effective since 2000 and three research publication for promotion to Associate Professor is effective from 2010. Since Sitting Allowance, etc for External Experts of Selection Committee of faculty recruitment has already been revised and enhanced to the tune of double the amount [Rs. 1,000/- to Rs. 3,000/- for half day and Rs. 5,000/- for full day], enhancement of honorarium from Rs. 1,000/- to Rs. 1,500/- and \$ 25 to \$ 50 (for Foreign Examiner of SAARC countries) per expert per candidate could be considered. The matter was placed before the Academic Council and the Council recommended the same to the Finance Committee for consideration.

The copy of the relevant portion of the resolution of the 81st Academic Council meeting regarding payment and enhancement of Honorarium for evaluation of research publications by the External Experts was placed in the meeting as Annexure to the agenda for consideration and recommendation to the Executive Council of the University for approval.

Resolution: The recommendations of the Academic Council were discussed in detail in the meeting and it was resolved that a comparative statement with supporting documents showing the details of such enhancement of Honorarium for evaluation of research publications by the External Experts in CAS promotions being followed in BHU, JNU, AMU and UoH may be placed before the Finance Committee for necessary consideration.

UGC in Letter No. F.18-3/2017(CU), dtd. 28.03.2018 communicated the approval for one time allocation of Rs. 900.00 lakh for C/o Pharmaceutical Science Building to be utilized upto 31.03.2019.

Considering the above allocation, the Building Committee in its 92nd meeting held on 15th May 2018 recommended for approval of Construction for Phase I of Pharmaceutical Science Building with an estimated cost of Rs. 8,99,67,362.00 to be awarded to MGCC Ltd. with a negotiated departmental charge of 5% on deposit work basis .

The Abstract Cost Estimates & Rate Conformity Certificates were placed in the meeting as Annexure to the agenda for kind perusal of the members of the Finance Committee and consideration for recommendation to the Executive Council for approval.

The recommendations of the Building Committee of Assam University in its 92nd meeting held on May 15, 2018 were placed in the meeting as Annexure to the agenda for kind recommendation for approval.

Resolution: The agenda item was withdrawn and the Committee advised that the proposal may be submitted to the Finance Committee after following all codal formalities and provisions of GFRs 2017.

Item No. FC: 49/10: Adjustment of advances of the Faculty Member based on the proof of submission of bills and submission of photocopies of the missing bills.

Prof. Manabendra Dutta Choudhury, Professor, Department of Life Sciences has taken advance of Rs. 25,000/- on dtd. 25.07.2011 and submitted original vouchers of Rs. 18,558/- on dtd. 09.08.2011 and deposited the balance amount of Rs. 6,442/- on dtd. 05.08.2011 in the Finance Dept. The proof of submission of the vouchers vide Finance Dy. No. 9171L, dtd. 09.08.2011 was placed as an Annexure to the agenda in the meeting.

Similarly, Prof. Dutta Choudhury has also taken advance of Rs. 60,000/- on dtd. 01.08.2007 and submitted original vouchers of Rs. 72,363/- on dtd. 25.02.2008 and reimbursement was made for Rs. 10,000/- on 09.07.2009, out of the excess expenditure made by the faculty of Rs. 12,363/-. However, adjustment of Rs. 60,000/- was not made in the Advance Ledger.

Item No. FC: 49/11: Payment of honorarium to the members of Inspection Committee in connection with visits to affiliated colleges/institutions.

With approval of the competent authority, the Director, College Development Council, Assam University submitted the following agenda for consideration.

UGC in Clause 4.6 of UGC Affiliation of Colleges by Universities Regulations, 2009 vis-à-vis the Statute 33(4) of Assam University Act 1989 is having a provision for inspection of affiliated colleges by a Committee constituted by the Vice-Chancellor for matters related to grant of various permission like opening of new subjects/introduction

of Honours Courses/grant of temporary or permanent affiliation to the colleges.

A resolution vide No. 7 (c) was adopted in the 10th meeting of the College Development Council held on 24.08.2012 wherein, it was proprosed that the members of the Inspection Team be paid honorarium @ Rs. 1000/- (Rupees one thousand only) per head per inspection in addition to payment of TA/DA. The proposal was approved by the Hon'ble Vice-Chancellor. It is pertinent to mention here that as per provisions of UGC referred to above, the Inspection Committee may comprise of the following members:

- (i) One Expert for each of the subject areas proposed.
- (ii) Dean, College Development Council/an equivalent academician of the University,
- (iii) A representative of the higher education department of the Government not below the rank of Deputy Director, and
- (iv) An Engineer from the PWD/CPWD or the University not below the rank of Executive Engineer.

It is further submitted that as per practice in Gauhati University, a State University, payment of honorarium to the Inspection Committee members @ Rs. 2000/- (Rupees two thousand only) per head per inspection was paid by the College, not by the University. Copy of letter dated 28.02.2017 of Gauhati University was placed in the meeting as Annexure to the agenda for ready reference.

In the light of above, a proposal for payment of honorarium to the members of Inspection Committee @ Rs. 1000/- (Rupees one thousand only) per head per inspection in addition to the TA/DA was submitted to the 48^{th} meeting Finance Committee held on 5^{th} March 2018 for consideration of approval subject to the condition that the total expenditure on this account should not be more than the total collection made from the colleges.

The Finance Committee in the said meeting vide Resolution No. FC:48/07 resolved the following:

"The matter was discussed in detail in the meeting and it was resolved that a tabular statement with supporting documents showing the details of honorarium paid to the members of Inspection Committee in the light of practices followed by at least five Central Universities in connection with official visits to the affiliated colleges/institutions may be submitted to the next Finance Committee meeting for necessary consideration".

However, the Academic Council in its 81st meeting held on 15th May 2018 vide Resolution No. AC:81:05-18:53.4(ii) resolved that "the honorarium for all members of Inspection Committee for visiting colleges/institutions be enhanced to Rs. 2,000/-per head per inspection in addition to the TA/DA".

The copy of the relevant portion of the resolution of the 81st Academic Council meeting regarding honorarium to the members of Inspection Committee in connection with visits to affiliated colleges/institutions was placed in the meeting as Annexure to the part of the agenda.

The resolution of the Finance Committee vis-à-vis the recommendation of the Academic Council stated above was placed in the meeting for consideration and recommendation to the Executive Council for approval.

Resolution: The Finance Committee reiterated the resolutions taken on the 48th meeting of the Finance Committee held on 5th March 2018 vide Resolution No. 48/07, which was duly approved by the Executive Council of the University in its 117th meeting held on 8th March 2018.

The Committee suggested to prepare and submit a comparative statement based on the rate/norms being followed by similarly placed Central Universities viz. HNB University, Srinagar, Garhwal, H.S. Gour Vishwavidyalaya, Sagar etc. to the Finance Committee for consideration.

Item No. FC: 49/12: Payment of honorarium to the officials engaged for conducting B.Ed. Entrance Test.

With approval of the competent authority, the Director, College Development Council, Assam University submitted the following agenda for consideration.

Hon'ble Supreme Court of India has directed that admission into B.Ed Courses should be held through a Common Admission Test to be conducted on specified dates every year. Accordingly, a Committee was constituted in the year 2017 with Prof. N.B. Biswas of the Dept of Education, Assam University in the Chair and among others Principals of some B.Ed Colleges as members. The Committee decided that to ensure the process of conducting the admission test as self-sustaining, the Colleges would deposit Rs. 500/- per candidate to the University through sale of prospectus. The Committee further resolved

that on the different heads of expenditure of the aforesaid fund along with budget expenditure which include, inter alia: (i) cost of conducting the Admission Test in various centres, (ii) Printing cost of confidential matters/admit card, (iii) Remuneration to the invigilators/venue-in-charge/paper examiners/paper setters, etc. (iv) Honorarium to Chairman/Convener/ two Coordinators of the Admission Committee/other specified members involved in conducting the Common Admission Test will be paid by the University. Besides, provisions will be made for utilizing any surplus amount for conducting the programmes on academic welfare like seminars etc. for B. Ed. Colleges. It may be mentioned that all resolutions adopted by the B.Ed. Entrance Examination Committee were approved by the Vice-Chancellor.

The Director, College Development Council, Assam University submitted the proposal for payment of honorarium to the following officials with the amount mentioned below:
