Thereafter, agenda items were taken up for discussion and resolutions were adopted accordingly.

(A) Agenda item for approval:

(Item No. 01 to 10, being the matter of Examination branch, the Controller of Examinations addressed these issues before the members of the Council with relevant papers for perusal and consideration by the Council.)

Item No. 1 : To approve the Passing of Grace of graduates for the 17th Convocation :

AC:83:02-19:1: The 17th Convocation of the Assam University is scheduled to be held on 14th March 2019 to confer degrees to the candidates graduated from Assam University. The degrees that will be conferred in the 17th Convocation are as follows:

PhD, M Phil, M Sc, M Sc (Computer Science), M Com, MA, MBA, MMC, MVA, MSW, M Ed, MLIS, (Library Science), M Tech (IT, CSE & AE), LLM, PG Diploma (PGDMM, PGDBI, PGDTM, PGDBC, COP, DOP, PGDIT, PGDTM, PGDBC, COP, DOP, PGDIT, PGDEPM, MEPM), B Tech (IT, AE & ETC), LLB, B.Ed, BVA, BSW, BALLB(H), B Sc (Pass & Honours), BA (Pass & Honours), BCom (Pass & Honours), BBA and BCA.

The matter was placed before the Council to approve to pass the grace of Graduates/Post Graduates/Diploma /Certificate course /M.Phil/Ph.D etc. for admitting them to their respective degrees in the ensuing convocation.

Resolution: The COE has presented the issue of passing of grace of graduate for the 17th Convocation in detail before the Council and the Council accepted the same and recommended to the Executive Council for approval.

Item No. 4 : Matter regarding Mass Communication as combination of subject in CBCS curriculum:

AC:83:02-19:4: The proposal of the Principal, MHMSC, Algapur has been approved by the Hon'ble V.C. subject to ratification by the AC and the EC. The said proposal was placed by the COE. The Examination Branch is in the opinion that a restriction need to be imposed i.e. the candidate need to opt one science practical subject from the following to be at par with the degree of science:-

- (i) Ecology,
- (ii) Computer Science,
- (iii) Anthropology,
- (iv) Statistics

The matter was placed before the Council for ratification.

Resolution: On perusal of the agenda the Council resolved to ratify the issue for the current session only which will continue for the batch. However, the Council was in the opinion that the admission for the curriculum for the said College henceforth be stopped.

Item No. 5 : University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 :

AC:83:02-19:5: University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 as notified in the official Gazette of India on 31st July 2018 has been received from UGC vide D.O. No. F.1-18/2018 (CPC-II) dated 6th August 2018 for compliance in the University and affiliated colleges.

The Council may consider to the effect that, henceforth the M.Phil Dissertations / Ph.D Theses submitted by the research scholars for award of the degree(s) shall go through the processes of Plagiarism check before submission for evaluation as per established procedures. The matter was placed by the COE for perusal and consideration.

Resolution: On perusal of the issue the Council resolved to adopt the same and the matter was recommended to the Executive Council for consideration.

Item No. 6 : Conduct of practical examination of CBCS curriculum

AC:83:02-19:6: As per resolution of the Principal(s) meeting held on 25.09.2018 the colleges has been informed to conduct 1st Semester CBCS practical examination in their respective colleges. The copy of the resolution & letter was placed by the COE for perusal. Some of the colleges having no practical examination centre may also be permitted till a guideline in this regard is framed and finalized.

Item No. 14: Introduction of "Bridge Course" of Bachelor of Pharmacy Practice in the Dept. of Pharmaceutical Science, AUS:

AC:83:02-19:14: The Director of Medical Education, Govt. of Assam has communicated vide letter No. DME/342/2018/17400 dtd. 28/09/2018 for introduction of 2 (Two) years "Bridge Course" of Bachelor of Pharmacy Practice in the Dept. of Pharmaceutical Science, Assam University, Silchar with an aim to increase the professional skill of the Diploma Registered Pharmacist working in Hospital and Community Pharmacies. The details of criteria to offer the said course alongwith the letter was placed in the meeting. The matter was placed before the Council for consideration and decision.

Item No. 16: Interchange in the course content of UR - 203 & UR - 204 of Urdu department, AUS:

The proposal was examined by the members of School Board and recommended to the Academic Council for consideration.

Item No. 17: To start M.C.A. Programme in the Dept. of Computer Science, AUS:

AC:83:02-19:17: While recommending the proposal of Head, Dept. of Computer Science duly recommended by the Departmental Sub Committee to start a MCA

programme in the department, the Dean, School of Physical Sciences has forwarded the course structure & syllabus for the programme. The course structure & syllabus will be placed in the meeting. The matter was placed before the Council for consideration.

Resolution: On being heard the Dept. of Computer Science for starting MCA programme in the department the Council initially approved the syllabus and course structure as proposed. However, it is resolved that to start the programme no additional fund, infrastructural facilities and equipments etc will not be borne by the University administration. Also the department needs to fulfill all the required formalities to start the programme. Further, the issues related to fianlisation/utilization of course fee shall be referred to the Finance Committee and reports in this regard to be placed to the Academic Council/Executive Council for finalization.

Item No. 18: B.Sc. Zoology (Hons. & Pass) & Industrial Fish and Fisheries (Pass) syllabus under CBCS:

AC:83:02-19:18: The Chairman, BUGS has submitted B.Sc. Zoology (Hons. & Pass) & Industrial Fish and Fisheries (Pass) syllabus under CBCS before the Council for consideration.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 19: Modified TDC syllabus (Pass & Hons.) in Sanskrit under CBCS related to DSC & GE papers:

AC:83:02-19:19: The Head, Dept. of Sanskrit has submitted TDC syllabus (Pass & Hons.) in Sanskrit under CBCS related to DSC & GE papers duly modified by the concerned BUGS. The matter was placed before the Council for consideration.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 20: Renaming of regular PGDIT to PGDCA:

AC:83:02-19:20: The Director, Computer Centre and Course Coordinator, PGDIT has placed the proposal for renaming the regular Post Graduation Diploma in Information Technology (PGDIT) course running at Computer Centre as Post Graduation Diploma in Computer Application (PGDCA).

The Executive Council in its 123rd meeting held on 19th November 2018 discussed the matter and decided to refer back the issue to the Academic Council for reviewing the course structure concerning its validation of running the course by a non-academic centre in respect to issuing of Certificates on completion of course(s). The members

were in the opinion that the administration needs to clarify the matter for the benefit of the academic interest of the University.

The Director, Computer Centre and Course Coordinator, PGDIT has submitted the revised course structure along with the detailed modified syllabus shall be placed in the meeting.

The matter was placed before the Council for consideration.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 21: Holidays to be observed in Central Govt. offices during 2019-Reg:

AC:83:02-19:21: The Ministry of Personal, Public Grievances and Pensions (DoPT) vide communication dtd. 11th July 2018 has specified the holidays to be observed by the Central Govt. offices and the said communication was placed for perusal and noting.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 22: Matter related to permitting course through SWAYAM:

AC:83:02-19:22: Dr. Prabhat Kumar Mishra, Course Coordinator – UGC MOOCs, Dept. of Hindi has proposed to start an online course entitled 'Sahitya Ka Itihas Darshan' through SWAYAM which will be offered from June 2019. The proposal alongwith relevant papers were placed in the meeting for consideration.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 23: Refresher course under ARPIT for the purpose of Career Advancement Scheme:

AC:83:02-19:23: The communication from the Joint Secretary, UGC vide letter No. 19-1/2019-CU.Cdn. dtd 9th January 2019 from the MHRD in respect of Annual Refresher programme in teaching (ARPIT) a initiative towards online refresher course was placed for perusal of the Council. UGC has decided to treat this course under ARPIT is as equivalent to one refresher course for the faculty members. As being provided on SWAYAM platform, the matter may be considered for implementation in the University.

Resolution: The Council accepted the same and recommended to the EC for approval. The Establishment Section- II shall notify for information of the concerned faculty.

Item No. 24 : Reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions :

AC:83:02-19:24: The Joint Secretary, UGC has forwarded a communication of MHRD Office Memorandum (No. 12-4/2019-UI dtd 17th January 2019) vide his letter No. F.No.81-1/2019(CU) dtd. 18th January 2019 regarding the implementation of reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions from the academic session 2019-20. The scheme for implementing the reservation for the EWS shall be displayed on the website of the institution as soon as possible. Also requested to furnish the seat matrix, programme wise, along with possible financial requirements to UGC before 31st January 2019. The matter was placed before the Council for considering the course of action to be followed by the University.

Resolution: The Council accepted the same and recommended to the EC for approval.

Item No. 25: Matter related to B.Voc:

AC:83:02-19:25: While considering the representation of the AUSU and the concerned students of the B.Voc programme, it felt necessary to place the matter before the Council for its views and therefore the Hon'ble Vice Chancellor advised the Director, CDC to prepare a detail report on B.Voc programme considering all aspects related to the course in totality and the report was placed before the Council for consideration.

Resolution: The Director, CDC presented before the house a detailed report of the current status of B.Voc programme in the University starting from inception of the programme in 2015-16. In course of presentation, mention was made on the current imbroglio arising out of the UGC Notice dtd. 30.7.2018 thereby not recommending extension of the programme vis-à-vis withholding of fund for running the programme for the existing students under B.Voc programme till completion of their course. In view of the above presentation, AC adopted the following resolutions:

- Resolved that the report submitted by Director, CDC on B.Voc programme be accepted in principle.
- All students admitted under the programme till the session 2018-19 be allowed to complete their course within 2021 and necessary fund to the tune of Rs 58.67 Lakh required for running the programme as stated in the report be arranged.
- In view of discontinuation of the programme, no further admission be held in the existing B.Voc programme w.e.f the session 2019-20.

Item No. 26 : CIL matter:

AC:83:02-19:26: With reference to the AC resolution of 81st meeting vide resolution No. AC:81:05-18:37 which resolved as "Resolution: Prof. M. Dutta Choudhury, the Chairman of CIL placed the matter in details and on hearing the views of different members of the council on the issue, it is resolved that the matter be deferred for sometime while a high power committee shall be constituted immediately by the administration for administrative scrutiny on all pros and cons of the issue and the report of the said committee shall be submitted to the Vice Chancellor for onward placement before the Executive Council for its consideration."

The University administration desired to have a detailed report on CIL in respect to its functioning in totality and accordingly the Chairman, CIL was advised to submit the report. The report was placed before the Council by the Chairman for perusal and consideration by the Council.

Resolution: As advised by the Vice Chancellor, Prof. M. Dutta Choudhury, Chairman, CIL, has placed before the Council the detailed report on CIL for the period from 2006 to 2019 for perusal of the members of the Council. Keeping in view the revamping of CIL the Chairman found it appropriate to inform the Council the need of the consideration of man and machine components of CIL simultaneously so as to enable the University administration to revamp CIL in letter and spirit. While considering all pros & cons of the issue the members of the Council observed that the following points needs to be considered by the University to make the CIL an important organ of the University. Accordingly the following were resolved:

- To start with the NMR be repaired immediately and therefore, the Chairman CIL shall take all steps found to be appropriate. As discussed the responsibility of repairing of NMR machine may be shared with the Dept. of Chemistry after obtaining the approval from the competent authority.
- It is resolved that all the machineries including NMR be kept in CIL building as these are in the CIL building from the beginning of functioning of CIL.
- 3. It is further resolved that the Dept. of Chemistry shall look after the NMR machine including its regular maintenance where as other equipments like GC-MS, HPLC will be looked after by Life Science department and LCR Meter and FT-IR will be looked after by Physics department.
- 4. Two faculties of CIL who were appointed as regular teachers of the University be transferred to concerned departments to facilitate them teaching and research activities for which the administrative procedure is on and accordingly the University administration shall communicate UGC for their consent on the issue. On receipt of the consent from UGC or considering a reasonable period the University shall implement the decision as resolved.

Item No. 27: Item from the Chair:

AC:83:02-19:27.1: M.Tech admission process under CUCET 2019:

Resolution: The Chairman placed before the Council the matter related to M.Tech admission process under CUCET (Central Universities Common Entrance Test) 2019 and advised the Dean, TSSOT to brief the same before the Council.

The Dean, TSSOT briefed the details about the admission to the M.Tech programme offered by three departments of TSSOT (Dept. of Agricultural Engineering, Computer Science & Engineering and Electronics & Communication Engineering and on heard the Dean the members resolved to accept the same and recommend to the Executive Council for consideration.

There being no other item to discuss, the meeting ended with thanks from the chair.
