
EC:131:02-20:01 : Action taken on Sri Milan Das, Research Scholar, Department of Ecology and Environmental Sciences, Assam University vide order F.No.AUR/21-1/2020/V dated 08.02.2020 was confirmed and ratified by the Council.


EC:131:02-20:02 : The Vice Chancellor is authorized by the Executive Council to take necessary action as deem fit as per Act, Statutes and other provisions of law to restore normalcy in the University.

EC:131:02-20:03 : University administration is advised by the Executive Council to identify designated place(s) for demonstration in democratic manner in the University (Silchar campus). The Vice-Chancellor is authorized to take necessary steps for the same.

EC:131:02-20:04 : Keeping in view the present scenario in mind, the Executive Council decided to postpone the 18th Convocation scheduled on 1st March 2020. Fresh date for 18th Convocation shall be fixed after further consultation with the Convocation Committee/MHRD in this regard.
