From the Vice-Chancellor's Desk



A University makes its mark in the academic arena not only through quality teaching at the Undergraduate and the Master's levels but also through its research activities in various fields of study. Research conducted by the faculty and research scholars in the different university departments in their respective specialized areas contribute significantly towards determining the status that the university enjoys in the highly competitive and quality-oriented academic world. Besides making academic contributions leading to the advancement of knowledge, research programmes of a university can be of considerable applied value in terms of generation of manpower, enhancement of managerial skills, industrial innovations, pollution control, medical breakthroughs, etc.

Since its inception in 1994, Assam University has paid special attention to the advancement of research in the fields of humanities, social sciences, science, commerce, management and other streams of study. The faculty and research scholars of the University have received and participated in a large number of highly prestigious national as well as international research projects and programmes such as fellowships, associateships and grants. The University has also been able to attract students from the SAARC countries under ICCR scheme. Several collaborative programmes with reputed Indian as well as international agencies and institutions are also being pursued in the different departments of the University.

The University has adopted the latest guidelines of the University Grants Commission while conducting the admission to M.Phil. and Ph.D. programmes from 2017 onwards. The University has also adopted the Choice-Based Credit System (CBCS) of study at the undergraduate and post-graduate levels in the University. The admission process for both Master's and M.Phil. / Ph.D. programmes have been made fully online as per the guidelines of the University Grants Commission. Assam University has taken steps for publication of Examination Results including Admit Card, Marksheets, etc. on online. In this regard, it must be mentioned that all examination related matters of the University are now dealt with online. The Silchar and Diphu Campuses are now completely wi-fi enabled campuses which help the Scholars/ Researchers in their research activities in the University.

Keeping in view the increasing number of applicants choosing Assam University as the place where they would like to conduct their research, the University administration is trying its utmost to provide necessary facilities such as health centre, post office, bank services, stores having goods and provisions, gymnasium, playground, central library and transportation facilities. The process of office automation especially in the field of academic activities has been initiated and the entire campus is being covered by networking facilities. More hostels are coming up for students and a few are already in the process of being constructed.

Besides the Silchar Campus, the satellite campus at Diphu in Karbi Anglong district is also making great strides with regard to research activities in various academic departments. Facilities similar to those provided to the scholars in the Silchar Campus are also being made available to the scholars in the satellite campus. These include networking facilities, canteen, health centre, bank and transport facilities, which are being created with financial support from the Government of India.

I take this opportunity to congratulate our students, faculties and administrative employees of the University on their achievements. I also give a hearty welcome to the new batch of research scholars who are about to join the University and wish them all success in their endeavours.

THE UNIVERSITY



Assam University, Silchar (a Central University) was established by an Act of Parliament promulgated in 1989 (Act XXIII) and enforced by a Notification of the Government of India in January 1994. In 2014 the University has been reaccredited by NAAC with Grade B with a CGPA of 2.92.

With the Bhuban and the Barail ranges of hills at the backdrop, the University campus is surrounded by lush green hillocks, natural lakes and the picturesque tea gardens of South Assam. The inner landscape is featured by sprawling lawns, well nurtured gardens and eco-forests. The serene setting makes Assam University campus a unique one with exquisite natural beauty which captures viewers' imagination and provides an ideal atmosphere for study and research.

Distance between the main campus and the Silchar city is about 23 km. Silchar city being the gateway to the entire southern part of North East India is the hub of commercial activities and is known for its history as the Tea Capital of South Assam.

Away from the humdrum of the busy city-life of Silchar and set amidst its sylvan surroundings, the University engages itself in academic pursuits. The objectives of the

University, as enshrined in Section 4 of Assam University Act, are –

“to disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit and by the example of its corporate life to make provisions for integrated courses in Humanities, Natural and Physical Sciences and Social Sciences in the educational programmes of the University; to take appropriate measures for promoting interdisciplinary studies and research in the University; to educate and train manpower for development of State of Assam; and to pay special attention to the improvement of the social, economic conditions and welfare of the people of that state, their intellectual academic and cultural development.”

The sprawling University campus at Silchar is spread over an area of about 600 acres on which there are 38 Academic departments and 6 Interdisciplinary Centres including School of Technology. In addition, CIL (Central Instrumentation Laboratory) has also been established in the university. Keeping with the policy of Govt. of India, Skill Development Programmes have been initiated through UGC sponsored Community College and B. Voc. Programmes. The University provides state-of-the-art facilities to students coming from different parts of the country and abroad. The current roll strength is around 4617 at the post graduate and Integrated Courses including around 650 M. Phil and Ph.D at research levels. These apart, there are nearly 25,000 students in the affiliated and permitted colleges in the five districts of south Assam which together constitute the jurisdiction of Assam University. The colleges imparts undergraduate teaching in Science, Arts, Commerce, B.Ed. and the Law streams.

During the last one decade, the University has

made impressive strides in establishing itself as a premier institution of learning by blending quality education, socially relevant academic endeavours and scientific research with mission-orientation and tireless striving for excellence.

The University Campus is fast developing and is endowed with amenities / facilities such as Post Office, Telephone Exchange, Public Call Offices, Bank, Police Outpost, Water Treatment Plants, Electric Substations, Students' Hostels (both Boys' & Girls'), Health Centre, Staff Quarters, Shopping Complex, Guest House, Central Library, Auditorium Kendriya Vidyalaya and Parks. In addition other amenities like ATM, Sports Complex, Cafeteria, E-Journals, INFLIBNET, DELCON, Bio-informatics and KIOSK facilities are also available. University has introduced Choice Based Credit System (CBCS) from 2010-2011 at post graduate level and semester system in colleges affiliated to it.

DIPHU CAMPUS

Establishment of Assam University Campus at Diphu has been a long felt demand of the people of Karbi Anglong, Assam. A satellite campus of Assam University at Diphu has been launched from the academic session 2007-08. The authorities of Karbi Anglong Autonomous Council have allocated 272 bighas of land in Diphu-Lumding Road about 8 kms away from Diphu town. The land so allocated has already been taken over by the University and is in the process of construction of boundary wall and other buildings. The campus site is located in a beautiful surrounding of the lush green hills.

There are **10** departments in the Diphu Campus (i) English, (ii) Political Science, (iii) History, (iv) Physics, (v) Life Science, (vi) Commerce, (vii) Assamese, (viii) Anthropology (ix) Hindi, (x) Geography and Centre for Tribal Studies.

Department of Linguistics

The Department of Linguistics came into being in 1995 with the aim of developing a better understanding of language study and linguistics. With the diverse linguistic scenario in North East India providing its backdrop, the thrust of the department's endeavour has been on analyzing the languages of North East India with special reference to the languages of South Assam. The department is also giving importance to the study of endangered languages of the North East India as a lot of minority languages are spoken in this part of the country which is considered to be endangered so that we can do something meaningful to preserve these languages. All the North Eastern languages show dialectal variations which need to be studied structurally as well as sociolinguistically. Such studies would help the standardization of languages and pave the ways for their use in education and other fields of socio-cultural life of North East India. Keeping this in view, the department has developed its course curriculum in such a way so as to enable the students at the Post Graduate level to acquire special knowledge to take up independent researches in future on various languages/dialects and their recent developments.

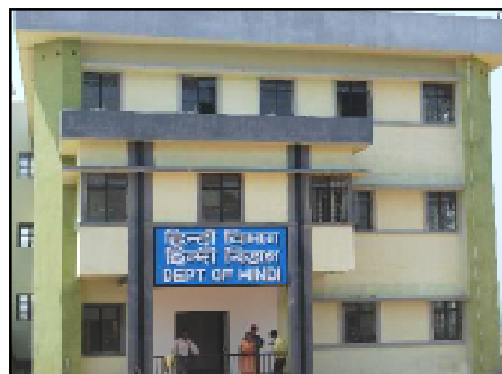

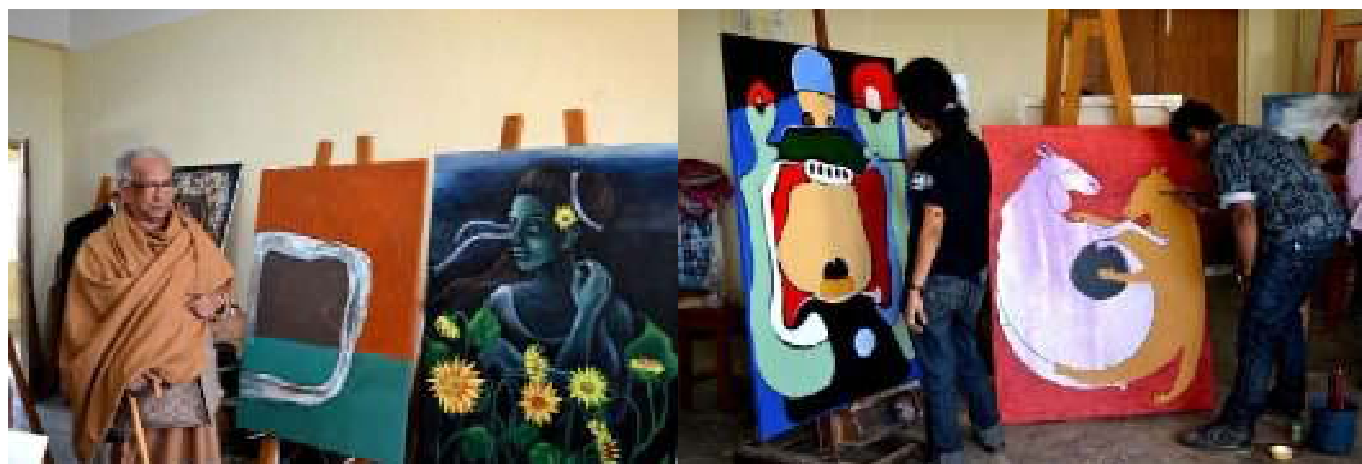

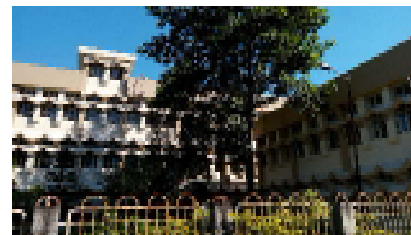

Bioinformatics Centre

Bioinformatics Centre of Assam University, Silchar came into existence in the year 2008 as an independent centre under School of Life Sciences with full financial assistance from Department of Biotechnology, Govt. of India. Since its birth, the centre has been actively engaged in teaching and research in the different fields of Bioinformatics. The Centre has launched a Post Graduate Diploma in Bioinformatics (PGDBI) Course of 1 year (2 semester) duration. Till date ten batches of students have already completed the course. The 11th batch is on the roll. The main aim of this course is to create skilled manpower in the field of Bioinformatics. Till date the centre has organized two International Conferences, three National Conferences, seventeen workshops & training programmes and several outreach programmes for Senior Secondary (Science) students to popularize Bioinformatics in this region and the entire North East as a whole. The centre has also organised sixth NEBI net meet in 2013. The main thrust area of research of the centre is Computer Aided Drug Designing. The centre has extended this facility to whole of Assam University and to 02 affiliated colleges.

The Department of Biotechnology, Assam University, Silchar offers MSc, MPhil and PhD programmes in Biotechnology. Central Instrumentation Laboratory

The Central Instrumentation Laboratory was established in the year 2007 with funding from University Grants Commission. The Central Instrumentation Laboratory houses sophisticated state of art analytical instruments like Gas Chromatography-Mass Spectrometry (GC-MS), Atomic Absorption Spectrometry (AAS), High Performance Liquid Chromatography (HPLC), Fourier Transform Infra Red Spectrometer (FT-IR), Impedance Analyser (LCR Meter) and a 400 MHz FT-NMR with multi probe facility. The main objective of the Central Instrumentation Laboratory is to provide analytical instrumentation support to all science departments of Assam University, other institutes, research laboratories, national laboratories and industries in the country. In addition, the CIL also provides teaching support to Post Graduate and IPP level of science departments of the university.

Computer Centre

Assam University Computer Centre is established in March 1997. It is the central hub for ICT related services for Assam University. Centre is the Internet gateway for the campus-wide university network through its NKN router. About eighteen hundred nodes are connected to the network. Approximately twenty servers, seventy high-end switches/routers and firewall devices are connected. All the departments of Silchar and Diphu campus are connected to the network. Computer Centre provides access to the e-journals, etc. to the stakeholders through a 10 Mbps leased line under UGC-Infonet Scheme. The centre is running a one year regular Post Graduate Diploma in Information Technology (PGDIT) course.

ACADEMIC AND STUDENT SERVICES

● CENTRAL LIBRARY

Assam University Library was started with the establishment of the university in the year 1994 as a central facility for meeting the information requirement of academic community of the university. The central library was shifted to permanent building in January 2006 and renamed as "Rabindra Library". The new building has total plinth area of 38,700 Sq.



Ft. At present the central library has a collection of books over 1, 26,000. It has a good collection of rare books donated by prominent academicians. Moreover, the facility of more than 10000 Electronic Resources is also available through UGC-Infonet, Delnet & Delcon consortia. The library provides all academic library services in an automated environment with the help of Koha OSS LMS. The library follows open access system where the users can visit the stacks and chose their required documents. The books and library cards are bar-coded for easy operations. The Library is open from 9.30 to 5.30 on weekdays and upto 5 PM on Saturdays. It has a reading room sitting

capacity of 200 and Internet Access Lab with 20 nodes. The resources of library can be viewed over <http://libraryopac.aus.ac.in>.

● HOSTEL ACCOMMODATION

There are at present **nine** hostels *four for boys and five for girls students* in the University campus. The hostels are



furnished with basic facilities. Hostel seats are limited and every student may not get the seat in hostel. Availability of seats depend upon the vacancy in the hostel. A seperate Booklet for Hostel Boarders & conduct Rules of the hostel is also available.

● HEALTH CARE CENTRE

The University Health Centre is managed by four experienced Medical professionals along with Pathologist, Staff Nurses, Pharmacist, and Paramedical staff on a 24x7 basis. The Centre caters to the medical needs of all the beneficiaries and members of the Assam University family. The Health Centre is supported by two Ambulances round the clock. Almost 300 types of medicines are being dispensed free of

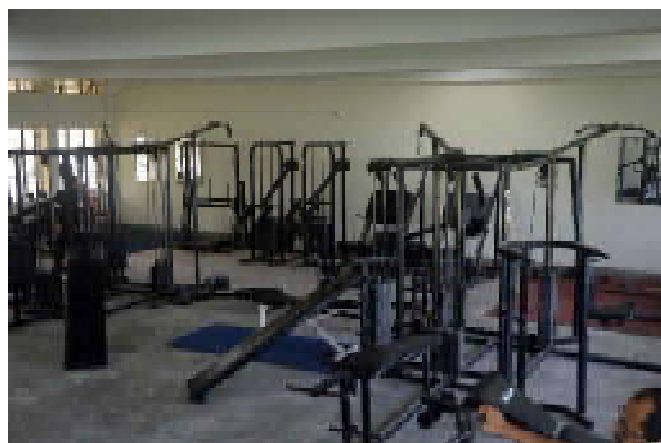
cost from the Health Centre. Critical cases are being referred to the Higher Centre by Ambulances after providing primary treatment. Specialist Doctors from the field of Psychiatry, Medicine & Homoeopathy are visiting the Health Centre on weekly basis. The University's Health Centre has procured equipments like X-ray machine, ECG, Auto analyzer and had set up of Diagnostic Laboratory. University has introduced Medical Insurance to each student. However, expenses related to the medical emergency & Hospitalization to Higher centers shall be borne by parents / guardians of the student if not covered



by the insurance. Besides this Health camps, awareness programmes with eminent doctors of the country are frequently organized by the Health centre. University is issuing Health Card to each student for extending medical facility efficiently.

● GYMNASIUM

A well equipped *Gymnasium* exists for both gents & ladies. Interested students can enroll their names for availing the facilities in the Gymnasium.



● NSS ACTIVITY

Students are encouraged in participating NSS (National Service Scheme) activities organised by the Programme Officer and Coordinator, NSS Unit of Assam University. NSS is sponsored by the Ministry of Sports and Youth Welfare.

● NCC TRAINING

The NCC Units in Assam University arrange NCC training for the students of the University - both boys and girls. For enlisting names for NCC training, the contact person will be the Dean, Students' Welfare, Assam University.

● GAMES AND SPORTS

Since its inception in 1994, games and sports have been one of the important foci of Assam University's endeavour to facilitate all-round development of students' physical and mental abilities. Every year an Annual Social Meet is organized in the University where along with cultural activities, indoor and outdoor sports are held.

The University is currently a member of the Inter-University Sports Board of India and its teams participate in Zonal and All-

India University Tournaments bringing laurels and prizes and medals for the University.

The Central Sports-complex which is in the process of coming up is expected to



give a major boost to games and sports and to other extra-curricular activities of the students in Assam University.

● BUS SERVICE

In addition to State Transport Bus service, ten buses are also available for the benefit



of the students commuting between Silchar and University campus and also Hailakandi to university campus.

● STUDENTS' WELFARE

The office of the Dean of Students Welfare

looks after the welfare of the students with active support of the representatives of the students, faculty and administration. Student Community Centre has been added from the year 2010 for various students activities.

For the benefit of the needy and deserving students, the University maintains and operates a Fund called the Assam University Students' Aid Fund which is instituted out of the contribution from the students of the University and collections from other sources. The main objective of the Fund is to render financial assistance



to poor and deserving students for payment of tuition fees, examination fees, purchase of text books, stationery etc. A student requiring financial assistance from the Fund shall have to apply in the prescribed form through the concerned Head of the Department.

There is a Students' Council in the University which caters to the students' interests and contributes towards the promotion of students' extra-curricular activities. The Students' Council also organises a week-long social meet every year. During these seven days, the students display their creative talents in

the field of sports and other cultural activities.

● THE UNIVERSITY JOURNAL

Assam University publishes research papers in the Journals in Humanities, Science and Technology in addition to some departmental Journals.

● THE UNIVERSITY MAGAZINE

The Assam University Magazine – *Prachi Prangan* is published annually. The Magazine offers to the University students a medium to give expression to their literary and intellectual endeavours.

● STUDENTS' DISCIPLINE

Each student with respect to his/her work in the course (P.G./U.G./Integrated course/ M. Phil/Ph.D./Certificate/Diploma) as well as his/her general conduct in the University, shall remain under the control of the respective School and the Department and shall be guided by the disciplinary code of the University. The Proctor looks after the discipline amongst the students.

It is mandatory for the students to keep their respective photo identity card with them while moving within the university campus.

There is complete ban on ragging in the campus as per order of the Supreme Court of India.

As per guidelines, ragging is strictly prohibited inside or outside the university campus. Each student will be required to submit one affidavit as per the format provided by the MHRD at the time of admission.

If any incident of ragging or any other act of gross violation of discipline comes to notice of the authority, the concerned students will be given adequate opportunity to explain and if his/her explanation is not satisfactory he/she will be expelled from the University.

Also, there is one committee on violence against women and sexual harassment to combat the menace of violence and sexual harassment against women in the campus, if any, and another for looking after the maintenance of discipline and decorum among the students.

● COMPUTER CENTRE

The Assam University Computer Centre is a central facility to facilitate, foster and support the computing and communication needs of University fraternity. Students have access to more than 50 computers for their lab or project work. To assist research, there is a range of computing environment available, backed by staff with considerable expertise.

Currently, the Computer Centre extends help to all administration and academic departments in running theory and practical courses related to Computer Science and computer applications.

The Centre has acquired all the latest softwares/ computers to cater to all types of computing requirements of the research scholars, faculty and students.

● CAREER COUNCELLING AND PLACEMENT CELL

The Placement Cell of the University

extend counselling services to all placement aspirants. The Cell's activities include organisation of workshops and lectures by corporate professionals and placement consultants and preparation of students' resume / bio-data / curriculum vitae and placement brochure. The Placement Cells in the various departments of the University are currently engaged in developing detailed Employer's Database that would help the students to trace out employment opportunities in India and abroad. Since inception University students are being offered good placement both in Public

and in Private sector. Many companies had participated during last couple of year's placement programme. The Companies include: IDBI Bank, ICICI Bank, TCS, Max Cement, Zolani Tech, UNISYS, Wipro Technology, Thyrocare Tech, HDFC Bank, Reliance Communications, Tata Motor Finance, Patanjali, Axis Bank and ICICI Prudential Life Insurance Company. Students from almost all the departments have been participating in the placement sessions.

Conceived as an outreach campus of Assam University, academic activities in the Diphu Campus started from the Academic Session 2007-08. The land so allotted has already been taken over by the University and the construction process is in progress. The campus site is located in a picturesque place surrounded on all sides by lush green hills.

Academic and Administrative activities for the Diphu Campus is at present being carried out in a temporary accommodation as the construction of the appropriate infrastructure in the permanent campus site is in progress. Arrangement of Hostel accommodation for students is in the process.

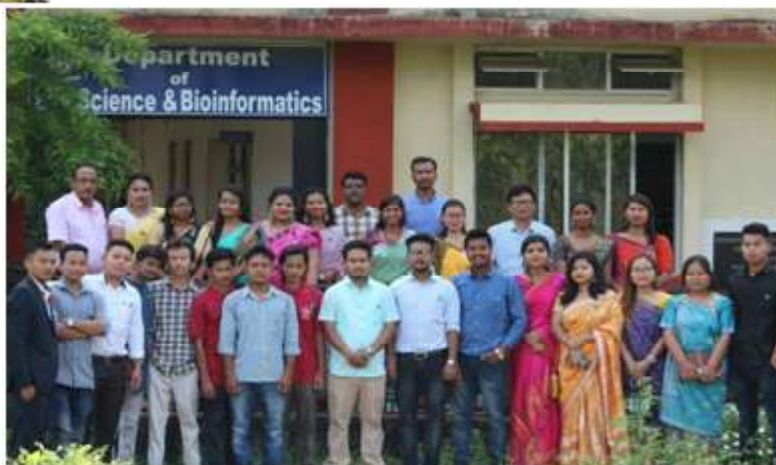

INFORMATION RELATING TO M. Phil./ Ph.D. PROGRAMME

1. Eligibility Criteria for Admission to the M.Phil. Programme

(1.1) Candidates for admission to the M.Phil. programme shall have a Master's degree or a professional degree declared equivalent to the Master's degree with at least 55% marks in aggregate, or its equivalent grade or an equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized, by an authority established, recognised or incorporated under a law in its home country or any other statutory authority in that country empowered for assessing, accrediting or assuring quality and standards of educational institutions.

(1.2) A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/ differently-abled and other categories of candidates as per the decision of the Government of India (GOI) from time to time, or for those who had obtained their Master's degree prior to 19th September 1991. The eligibility marks of 55% (or an equivalent grade in a point scale) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace marks. The candidates seeking admission against OBC quota must submit income certificate of the current financial year in support of his/ her belonging to OBC (NCL) category, from the appropriate authority.

2. Eligibility Criteria for Admission to the Ph.D. Programme

(2.1) Master's Degree holders satisfying the criteria stipulated under Eligibility Criteria for Admission to M. Phil. Programme under point (1).

(2.2) Candidates who have cleared a four paper M.Phil. course work with at least 55 % marks in aggregate or its equivalent grade 'B' or those who have already completed the course work in M.Phil. as per the UGC (Minimum Standards and Procedure for Award of M.Phil./ Ph.D. Degrees) Regulations, 2016 with at least 55% marks in aggregate or its equivalent grade in the prevalent AUS grading scale and successfully completed the M.Phil. Degree shall be eligible to proceed to do research work leading to the Ph.D. Degree in an integrated programme in the University. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ ST/ OBC (non-creamy layer)/ differently-abled and other categories of candidates as per the decision of the GOI from time to time. The candidates seeking admission against OBC quota must submit income certificate of the current financial year in support of his/ her belonging to OBC (NCL) category, from the appropriate authority.

(2.3) A student of Assam University, whose M.Phil. Dissertation has been evaluated and the viva voce is pending, may be admitted to the Ph.D. programme of the University. A Certificate issued by the examination branch in this regard be submitted in the appropriate format.

(2.4) Candidates possessing a Degree considered equivalent to the M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority,

established, recognized or incorporated by law in its home country or any other statutory authority in that country empowered for assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. programme.

3. Duration of the Programme

(3.1) M.Phil. programme shall be for a minimum duration of two (2) consecutive semesters/ one year and a maximum of four (4) consecutive semesters/ two years, excluding course work.

(3.2) An extension of one semester may be given to an M.Phil. Candidate for submission of dissertation on recommendation of Research Advisory Committee (RAC)

(3.3) Ph.D. programme shall be for a minimum duration of three (3) years, including course work and a maximum of six (6) years.

(3.4) An extension of one year may be given to Ph.D. scholar for submission of thesis on recommendation of RAC .

(3.5) An additional year of extension may be granted under special circumstances to a Ph.D. candidate.

These extensions may be granted on recommendation of RAC routed through relevant statutory bodies provided the candidate applies with the recommendation of RAC well in advance, prior to the date of expiry of her/his tenure of M.Phil./ Ph.D.

Any extraordinary situation may be referred to the Chairperson, Board of Research Studies (BRS), through RAC and Departmental Research Committee (DRC), for decision which should later be ratified in the relevant statutory bodies.

(3.6) Women candidates and persons with disability (more than 40% disability) may be allowed a relaxation of one year for M.Phil. and two years for Ph.D. in the maximum duration in addition to that mentioned in point 3.1-3.5.

(3.7) In addition, women candidates may be provided Maternity Leave/ Child Care Leave, only once in the entire duration of M.Phil./Ph.D. for up to 240 days.

Explanation: "relevant statutory bodies" refers to Board of Post-Graduate Studies, Board of School, Board of Research Studies, and Academic Council, as the case may be.

4. Procedure for Admission

(4.1) Candidates will be admitted to M.Phil./ Ph.D. programme through an Entrance Test to be conducted annually.

(4.2) A student having PG degree from Assam University, UGC-NET (including JRF)/ UGC-CSIR NET (including JRF)/ SLET/ GATE/ teacher fellowship holders, and teachers teaching in the University, will get 10% of her/his PG grade/ percentage of marks as bonus over the entrance examination score.

Candidates with M.Phil. degree will get 10% of their course work grade/percentage of marks as bonus. These will be included at the time of preparation of merit list.

(4.3) Candidates will be selected through a two stage process that is:

(4.3.1) An Entrance Test conducted by the university to test knowledge of research methodology (50%) and the relevant subject (50%). Qualifying marks for the entrance test will be 50%, provided that a relaxation of 5% of marks (from 50% to 45%) shall be allowed for the candidates belonging to SC/ST/OBC (Non-Creamy layers)/ Differently-

abled category in the entrance examination conducted by the University. The test shall be conducted at the Centre(s) notified in advance. Changes of Centres, if any, are also to be notified well in advance.

(4.3.2) An interview, to be organized by the concerned department where the candidates are required to discuss their research interest/ area through a presentation before a duly constituted DRC. The merit list will be prepared giving 70% weightage to the written test and 30% to the interview.

(4.4) The DRC during interview shall also consider the following aspects, viz. whether:

(4.4.1) the candidate possesses the competence for the proposed research;

(4.4.2) the research work can be suitably undertaken at the department concerned;

(4.4.3) the proposed area of research can contribute to new/ additional knowledge.

(4.4) A student admitted to M.Phil./ Ph.D. program shall pay the fees as prescribed by the university from time to time.

5. Research Supervisor:

(5.1) The allocation of Research Supervisor for a selected candidate will be decided by the concerned DRC at the time of admission depending on the number of scholars per Research Supervisor, the available specialization among the Supervisors and research interests of the scholars as indicated by them at the time of interview.

(5.2) In case of relocation of an M.Phil./ Ph.D. woman scholar due to marriage or otherwise, the research data may be allowed to be transferred to the university to which the scholar intends to relocate provided all the other conditions in this ordinance are followed in letter and spirit and the research work does not pertain to the research project secured by the parent institution/ supervisor from any funding agency. The scholar will, however, give due credit to the parent guide and the institution for the part of research already done, without violation of IPR.

6. Course Work:

(6.1) Successful completion of course work shall be treated as prerequisite for M.Phil. / Ph.D. title registration.

(6.2) The M.Phil./ Ph.D. course work shall be of 16 credits.

(6.3) Course work should be completed in the first semester of the programme; arrear, if any, should be cleared within the next semester failing which the admission will stand cancelled.

There shall be no re-evaluation/ betterment for coursework examination.

(6.4) Candidates already holding M.Phil. Degree from Assam University with a four-paper coursework with minimum 55% marks in aggregate, or those who have already completed the course work in M.Phil. as per the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016, and admitted to the Ph.D. programme or those permitted to proceed to pursue Ph.D. degree in an integrated programme, may be exempted from the Ph.D. course work. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work prescribed by the Department.

(6.5) An M.Phil. /Ph.D. scholar has to obtain a minimum of 55% in aggregate and a

minimum of 50% in each paper or its equivalent grade in prevalent AUS scale in the course work in order to be eligible to continue in the programme and submit the dissertation/ thesis.

(6.6) A candidate obtaining qualifying marks in each paper but having shortage in aggregate may choose to repeat any of the theory paper(s) in the following semester.

(6.7) The regular Course Work Examination will be held in July and arrear examination will be held in January every year.

7. Evaluation and Assessment Methods, Minimum Standards/ Credits for Award of the Degree, etc.

(7.1) The credit requirement, including credit for the course work, for the award of M.Phil. degree shall be 32 of which 16 shall be secured from coursework and 16 from dissertation.

(7.2) Upon satisfactory completion of coursework and obtaining the required marks/ grade, a scholar shall be required to undertake research work and go for registration of title of the dissertation/ thesis.

A presentation on the proposal should be made before RAC, on whose recommendation the scholar shall submit a synopsis. Thereafter, the scholar shall submit an application (in prescribed format) to the Department along with the recommendation of RAC based on the presentation.

The application, complete in all respects, shall be forwarded to BRS through the relevant statutory bodies within twelve months of successful completion of coursework, barring which admission will stand cancelled.

(7.3) Any modification/ alteration in title of Ph.D. thesis within the scope of registered work can be done. Any such change shall have to be approved by the BRS before pre-submission. For this purpose, on receiving request from the scholar, the supervisor shall first propose the modification/ alteration to the RAC, on the recommendation of which it will be submitted to the DRC, which in turn will get it approved in the relevant statutory bodies.

Modification in M.Phil dissertation title will only be allowed under extraordinary circumstances subject to approval in the relevant statutory bodies.

(7.4) Prior to the submission of the dissertation/ thesis, the scholar shall make a presentation in the Department before her/his RAC which shall also be open to all faculty members and other research scholars. The feedback and comments obtained from them may be suitably incorporated into the draft dissertation/ thesis in consultation with the RAC.

The scholar shall be allowed to deliver the pre-submission seminar after completion of at least two-and-a-half (2.5) years from the date of admission, in case of Ph.D. and ten months, excluding course work, in case of M.Phil.

(7.5) Within two weeks from the successful presentation, the scholar has to submit an Abstract (within 1000 words) of the dissertation/ thesis along with duly filled prescribed form and fees to the Department.

The Ph.D. thesis should be submitted within six months from the date of pre-submission but not earlier than 3 years from the date of admission. In case a Ph.D. scholar fails to

submit the thesis within six months from the date of pre-submission presentation she/he needs to take special permission from the competent authority on recommendation of RAC.

A M.Phil. scholar must submit the dissertation within two months from the date of pre-submission, but not earlier than one year from the date of admission, excluding coursework.

(7.6) M.Phil. scholars shall present at least one (1) research paper in a national conference/seminar and Ph.D. scholars must publish at least one (1) research paper in refereed journal and present two (02) papers in national conferences/ seminars before the submission of the dissertation/ thesis for adjudication, and produce evidence for the same in the form of presentation certificates and/or reprints.

(7.7) The dissertation/thesis shall have an undertaking from the research scholar and a certificate from the Research Supervisor attesting to the originality of the work, vouching that there is no plagiarism and that the work has not been submitted for the award of any other degree/diploma of the same Institution where the work was carried out, or to any other Institution.

(7.8) Dissertation/ Thesis shall be printed in the prescribed format. Three soft bound copies along with a soft copy in the prescribed format of the dissertation/ thesis should be submitted to Department for evaluation.

Two hard bound copies of the dissertation/ thesis (incorporating all changes/ alterations/ corrections suggested during the process of evaluation, if any) along with a soft copy in the prescribed format should be submitted within fifteen (15) days of completion of viva-voce.

Notification will be issued by the university in the first week of every month for award of M.Phil./ Ph.D. to the candidates who have successfully completed viva-voce in preceding month.

(7.9) In the event of death of an M.Phil./ Ph.D. candidate before her/ his viva voce could be conducted, a posthumous degree may be awarded provided the reports of one (in case of M.Phil.) or both (in case of Ph.D.) the external examiners is/are positive with recommendations for viva-voce. Such a proposal has to be routed through the relevant statutory bodies.

8. Treatment of Ph.D./ M.Phil. through Distance Mode/ Part-time Basis

(8.1) There will be no M.Phil. and Ph.D. programmes offered through distance education mode.

(8.2) Part-time Ph.D. will be allowed provided all the conditions mentioned in the extant Ph.D. ordinance are met. A No Objection Certificate (NOC) from competent authority in the format prescribed by the authority needs to be submitted at the time of personal interview during admission by all employed candidates. In addition, an employed candidate needs to submit leave sanction order from competent authority for at least a period of six (6) month for attending course work.

Teachers of Assam University and its affiliated colleges would be exempted from attending regular classes during coursework. They will have to write an assignment in

each paper and earn credit through seminars, fieldwork, etc.

(8.3) Part time scholars have to be present in the campus for 30 days in a year and must appear before RAC once in every six month. Attendance records of such scholars will be maintained by the Supervisor and reported to RAC per academic year. RAC may take appropriate action if a part time scholar does not have the required attendance.

9. Conduct and Discipline

Each scholar with respect to her/his work in the course as well as general conduct in the University shall remain under the control of respective School of Studies and shall be governed by the disciplinary code of the University.

(9.1) A full-time scholar shall not undertake any employment between the date of admission and date of submission of dissertation/ thesis. She/he shall not join any other course of study other than those, which may be useful for her/his research programme.

(9.2) The Ph.D. scholars may be required to assist the department in teaching and examination related works.

(9.3) A full time scholar shall be entitled for 30 days leave in a year. Women candidates may be provided maternity leave/ Child Care Leave as prescribed in point 3.7.

Important Notes (B)

☉ Each M. Phil./ Ph. D. student, with respect to his/her work in the course as well as his/her general conduct in the University, shall remain under the respective School and shall be governed by the disciplinary code of the concerned Department.

☉ The students who are not registered with Assam University should apply for Registration online within two months from date of admission. The original migration certificate from the institution last attended should be submitted along with the hard copy (print copy of the application submitted online) through the department. The students already registered with Assam University should also register for the course online.

The candidates seeking admission against OBC quota must submit income certificate of the current financial year in support of his/ her belonging to OBC (NCL) category, from the appropriate authority. EWS candidates are also required to submit certificate from any designated authorities as per format prescribed by GOI.
2. Relaxation of marks in qualifying examination for SC/ST/ PWD.
3. Selection of SC/ST students for admission in hostel will be made on the basis of their previous qualifying examination results.
4. Rent will not be charged from SC/ST students residing in the University hostels.
5. Coaching for NET or SET to SC, ST & Minority communities students are available.
6. Coaching for entry into services for SC, ST & Minority communities students are available.

Concessions to the Kashmiri migrant students:

1. Extension in date of admission by about 30 days.
2. Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement.
3. Increase in intake capacity up to 5% course -wise.
4. Reservation of at least one seat in merit quota in technical/ professional institutions.
5. Waiving off domicile requirements.
6. Facilitation of migration in second and subsequent years.

INTERNAL QUALITY ASSURANCE CELL

To act as a nodal agency for coordinating quality related activities, the Assam University has established an Internal Quality Assurance Cell (IQAC) as per UGC - NAAC guidelines in 01.09.2008. The cell has Prof. Dilip Chandra Nath, Vice Chancellor, as its Chairman and Prof. Dibyojyoti Bhattacharjee from Department of Statistics as its Director.

Some of the responsibilities that the IQAC has been entrusted with include:

1. Development and application of quality bench marks/ parameters for the various academic and administrative activities of Assam University.
2. Facilitating the creation of a learner - centric environment conducive for quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process.
3. Arrangement of feedback responses from students on quality-related institutional process.
4. Dissemination of information on various quality parameters of higher education to various external agencies.

ADMISSION OF FOREIGN STUDENTS

1. A Foreign student will be required to furnish the following documents from concerned authorities.
 - a] Equivalence and Eligibility Certificate from Association of Indian Universities, AIU House, 16, Kotla Marg, New Delhi - 110002 (Ph 911112320059 Fax 911123232131)
 - b] Student Visa obtained from the Indian Mission (Embassy / High Commission/ Consulate) before leaving his/ her home country. However students from SAARC countries may be selected for admission provisionally on Tourist Visa, subject to production of valid Student Visa.
 - c] A foreign student will be allowed provisional admission on production of the above documents and his/her admission will be confirmed after successful completion of all other formalities as per GOI/ AUS rules.
 - d] Foreign diplomats wishing to study M.Phil/PhD courses will be permitted on student visa.
 - e] Foreign students sponsored through cultural exchange programme of the Govt. of India or under the provisions of MoU signed with Foreign Universities will be given preference.
2.
 - a] 15% supernumerary seats may be available in the universities for admission of foreign students including PIOs as per UGC/GOI rules.
 - b] 5% of the 15% Supernumerary quota will be earmarked for admission of foreign students being children of Indian workers in the Gulf and South East Asia.
3. A foreign student will have to pay fees as below:
 - a] Self-sponsored students from SAARC countries will pay the same amount in INR as applicable for Indian students.
 - b] Students from SAARC countries who are sponsored by their respective Governments or Government of India as well as students from other developing countries will pay three times the amount as applicable for Indian students in INR.
 - c] Students from other than SAARC countries shall pay, five times the amount as applicable for Indian students in INR.
4. A foreign student seeking admission shall not be required to appear for the admission test procedure provided he/she furnishes letters of references from two teachers testifying his/her suitability for the course applied for and submit the transcript of his/her marksheet issued by the competent authority.
5.
 - a] A Foreign student must report to the Foreign Branch of SP office immediately after reaching India preferably on that day.
 - b] Foreign Registration must be done within 14 days after reaching India.

Ragging in any form is strictly prohibited by the Supreme Court

CODE OF CONDUCT FOR STUDENTS OF THE UNIVERSITY

- ☞ Students enrolled at Assam University must recognize their responsibilities to this university, to the teachers, to the officials and to fellow students bearing in mind the prestige and the reputation of the institution. Failure to maintain appropriate standards of conduct, decency and decorum would warrant disciplinary action.
- ☞ 75% of attendance is compulsory to all the students for Course Work. A student shall be considered to have satisfied the requirement of attendance for appearing the course work examination, if he/she has attended not less than 75% of the number of classes held for the Course Work including tests, seminars and practicals etc.
- ☞ However, there is a provision for condonation of attendance for the students those who have put up the attendance between 60% and 74% on Medical Grounds on production of medical certificate.
- ☞ A student who does not satisfy the requirements of attendance shall not be permitted to appear Course Work examinations.
- ☞ Students should not possess mobile phones/ pagers/ any other electronic device for communication in the class rooms/ seminar halls/ examination halls/ library/ any other place of academic interest within the University.
- ☞ Any problem related to students must be processed through the DSW or Head of the Departments or Deans of Schools, whose copy may also be forwarded to the Proctor & Students' Council.
- ☞ If Students have grievances, they are to register their grievances through the Grievance Redressal Committee of the University. Students are prohibited from approaching any outside agency regarding their grievances.
- ☞ Consequent upon the order of the Hon'ble Supreme Court of India on curbing Ragging in educational institutions, it has been decided that, if any incident of ragging comes to the notice of the authority, the concerned student shall be given adequate opportunity to explain and if his explanation is not found satisfactory, the authority will expel him/her from the University. Students taking admission in any course in Assam University have to sign an Affidavit, the content of which is available in the website.

MISCONDUCT

Student misconduct includes but is not limited to the following:

1. Disruption of classroom activities or hindering the learning of other students anywhere in the University,
2. Cheating on assignments or examinations,
3. Behaviour which interferes significantly with the normal operation of the University, disrupts education, challenges the health or safety of staff or students, or causes disfiguration or damage to the property of the University or belongings of staff members or students.
4. Possession and/or use of intoxicating beverages on campus,
5. Possession of illicit drugs in the campus,
6. Falsification of documents or the supply of false information in order to obtain admission, the possession of weapons.
7. Failure to return loaned materials to settle debts with the university
8. Disobeying any instructions of any kind issued by the Head of the University, i.e. the Vice Chancellor, or the Head of the Department or any authority empowered by the VC to make decisions regarding matters related to students.
9. Bringing the University into disrepute by any action / behaviour / instigation with a proven intention to tarnish the image of the university.

Failure to adhere to the guidelines as above shall invite strict disciplinary action which may lead upto expulsion from the University.

BESIDES, STUDENTS SHALL HAVE TO ABIDE BY RULES AND REGULATIONS OF THE UNIVERSITY WHICH MIGHT BE ADOPTED FROM TIME TO TIME.
