Item No. 14: Termination of lien on end of one year probation for teaching staff unless there is extension of probation in accordance with Clause 11.1 and 11.2 of UGC Regulation 2018.

EC:138:12-20:14: As per Clause 11.1 of UGC Regulation 2018, "The minimum period of probation of a teacher shall be one year, extendable by a maximum period of one more year in case of unsatisfactory performance" and Clause 11.2 of the Regulation, "The teacher on probation shall be confirmed at the end of one year, unless extended by another year through a specific order, before expiry of the first year". As lien (right of a Government employee to hold a regular post) is granted to an employee for the period of probation; therefore, unless there is a specific order for extension of probation; the same

shall stand terminated at the end of one year. The matter was placed before the Council for approval.

**Resolution**: After threadbare discussion the Council approved the same.

#### Item No. 15: Change of home town in respect of Prof R R Dhamala:

EC:138:12-20:15: Prof R R Dhamala (retired), Dept of Political Science applied for change of her home town from Namchi, Sikkim to Siliguri, West Bengal vide her application dated 6/2/2020. It may be noted that she was superannuated on 30/4/2020 and she applied for change of her home town before superannuation. She stated that her family had shifted from Namchi to Siliguri long back. As a proof she submitted the electricity bill which was issued in the year 2000. She submitted an application format duly filled in for the above purpose. She also submitted a copy of the money receipt of electricity bill vide dated 28/6/2019.

Item No. 17: Proposal for Approval for appointment of Head in the department of Physics, Assam University Diphu Campus, Diphu:

EC:138:12-20:17: This is to mention here that on expiry of the Headship of Prof. Ranjit Singha, Department of Physics, AUDC, Dr. Subrata Hazarika, Associate Professor, Department of Physics, AUDC was assigned to work as Head in the department as per ratification by the Executive Council, AUS vide item No. 09 and EC Resolution No. EC 136:09:20-09 in 136th Executive Council meeting held in 16th September 2020. But Dr. Subrata Hazarika, Associate Professor has declined to take over the charge of Headship due to his health issues and problems. Under the circumstances, Prof. Ranjit Singha may continue as Head of Physics Department.

The matter was placed before Executive Council for decision/approval.

**Resolution**: The Council approved the same. Further, the matter related to appointment of HODs discussed in the 137<sup>th</sup> EC meeting and the Council is of the opinion that the action taken in this regard be placed in the subsequent EC.

Item No. 18: Recommendations of Selection Committee/DPC for promotion/confirmation of Non-teaching staff:

(a) Promotion to Section Officer through Departmental Test:

**EC:138:12-20:18 (a):** A DPC cum Selection Committee constituted as per approval of the Vice Chancellor, and held its meeting on the 11<sup>th</sup> December, 2020 recommended the name of Sri Subroto Sinha, Assistant of this university for promotion to the vacant post of Section Officer (UR) post code- NTS-0036 in the Pay Matrix level 7.

After due approval of the Vice Chancellor Sri Subroto Sinha has been issued order of promotion to the post of Section Officer with minimum of pay Rs 44,900/- p.m at the pay matrix level 7 with all other admissible allowances from the date of his joining to the post. This promotion is made in pursuant to the provisions of "Assam University Recruitment and Promotions Rules -2013 (Non-teaching)" under the Departmental Test Quota of Selection of Section Officer with reference to the application of Sri Sinha against the notification no 104/79/2014-Estt/2531-34 dated 18.06.2020.

The matter was placed before the Council for ratification.

**Resolution:** The Council ratified the same. However, the EC advised the administration that such item in the agenda should be narrative.

(b) Appointment of Laboratory Assistant in the Department of Agricultural Engineering through Open advertisement:

EC:138:12-20:18(b): The Executive Council vide its resolution EC: 134:05-20:49 authorized the Vice- Chancellor to hold DPC to complete the recruitment process of Laboratory Assistant in the Department of Agricultural Engineering.

A duly constituted DPC/Selection Committee chaired by the **Pro-Vice Chancellor** perused the resolution of the Executive Council cited above and after due scrutiny and pursuit of the Selection Committee recommended the name of the following who eventually stood first in the written test conducted for **Laboratory Assistant for Agricultural Engineering**, against the notification vide the advt no 4/2017 dated 09.08.2017.

#### 1. Sri Nataraj Nath

The Committee Chaired by the Pro-Vice Chancellor recommended appointment of the candidate, but the recommendation was divided in 5:1. The matter was placed before the Council for decision.

**Resolution :** The Council ratified the decision of the majority members of the DPC as it is in accordance with the 134<sup>th</sup> meeting of EC resolution and directed to issue the appointment letter. The Council also observed that the appointment from relevant subject/discipline is appropriate and there is no need for making water tight compartments.

The Written Exam shall be held for 2 hours carrying total marks of 100 in lieu of 150. The matter was placed before the Council for approval.

#### 1). Dr. Sudipto Sarkar, Associate Professor:

Dr. Sudipto Sarkar, Associate Professor was Charge sheeted on the basis of preliminary inquiry report of the Internal Complaints Committee on alleged sexual harassment as per the Sexual Harassment of Women at Workplace Act 2013. Thereafter, final Inquiry has been conducted by Prof. D K Pandiya as Inquiry Officer. The Inquiry Officer has submitted the report which was sent for administrative scrutiny. The Scrutiny report pointed out various flaws in the final inquiry. The report of the Inquiry Officer and the administrative scrutiny report is placed before the Council for perusal and further direction.

Further, the pay and allowances of Dr. Sudipto Sarkar is with held since suspension. As per directives of the Honourable Court, University has allowed resumption of duty of

Dr. Sarkar but in a different Department; i.e in AUDC. Dr. Sarkar submitted joining through online but he is yet to report for duty at AUDC. However, holding of salary after withdrawal of suspension may not be legally tenable. The matter is placed before the Council for direction.

**Resolution:** The Council authorized the Vice-Chancellor to send the report back to the Inquiry Officer in order that the inquiry is completed following the extant rules for Departmental Proceedings as there are certain procedural lapses.

Dr. Sudipto Sarkar to be paid pay and allowances subject to submission of joining report in AUDC.

#### 2). Dr. Partha Sarkar, Associate Professor:

Dr. Partha Sarkar, Associate Professor was Charge sheeted on the basis of preliminary inquiry report of the Internal Complaints Committee on alleged sexual harassment as per the Sexual Harassment of Women at Workplace Act 2013. Thereafter, final Inquiry has been conducted by Prof. Bela Das as Inquiry Officer. The Inquiry Officer has submitted the report which was sent for administrative scrutiny. As per the report, the complainant has withdrawn the complaint. The report of the Inquiry Officer and the administrative scrutiny report is placed before the Council for perusal and further direction.

Further, on completion of 3<sup>rd</sup> extension of suspension period (i.e 360 days), Vice-Chancellor has reinstated Dr. Partha Sarkar w.e.f 15<sup>th</sup> December 2020 as suspension cannot be extended beyond a year and as final report has been already submitted whereby the complainant has withdrawn the complaint.

**Resolution :** The Council approved the report of the Inquiry Officer and exonerated Dr. Partha Sarkar from the Charges. The Council ratified the decision to re-instate Dr. Sarkar w.e.f 15<sup>th</sup> December 2020.

## Item No. 22: Untimely demise of casual employees & scope of employment of family member:

EC:138:12-20:22: Due to untimely demise of casual employees (below 60 years), who are mostly poverty stricken and are sole bread earner of family; the family members become helpless with no alternative means of living available immediately to them. Requests have been repeatedly received from those families for providing alternative employment to family members as there are several small school going or below school going children. Many of the young kids are forced to drop out from school and suffer from malnutrition and diseases due to lack of proper food and health care in absence of earning by family members.

Under such circumstances, as the non-teaching staff of the University is also highly skewed and much below required numbers in proportion of teaching staff and as a social responsibility, one of the kin (family members) of the deceased may be employed on temporary/daily wage basis in lieu of the deceased provided the family member posses requisite qualification. The matter was placed before the Council for consideration.

**Resolution :** The Council authorized the Vice Chancellor to constitute a Committee and examine the matter. Recommendations of the Committee to be placed in subsequent EC

#### Item No. 23 : Employment of daily wager by HOD (ICL):

EC:138:12-20:23: The Dept. of Indian Comparative Literature was established in 2014 with permission from UGC and official notification was issued on 18th November, 2014. From the very beginning no non-teaching staff was posted to the Dept. and HOD, ICL has employed one of the daily wager for helping the departmental activity.

However, no formal approval was taken for the said appointment. The person concerned has joined in the Dept. in 2017 and worked there for more than 3 years. During the period no salary was paid to him. Now again the Dept. is asking him to join for work. On verification of records it is understood that he has performed satisfactorily in the department.

The department has prayed to engage him in the University on daily wage basis as no staff is deployed in the department and the concerned staff has been rendering service for more than 03 years without any pay by office.

The matter was placed before the Council for consideration.

**Resolution:** Considering the need of the Department and acute shortage of non-teaching staff, the Council authorized the Registrar to temporarily engage a suitable candidate on daily wage basis through outsourcing with due approval of the Vice-Chancellor.

## Item No. 24: Conversion of CPF to GPF cum Pension Scheme of 12 nos of employees of the University:

EC:138:12-20:24: Hon'ble Gauhati High Court vide order dtd. 25-11-2020 for case No. Cont.Cas(C)/230/2019 has directed Assam University either to comply with the direction or if the direction is not as per law, to file appropriate appeal etc. against such direction. Accordingly, Assam University vide letter No. 105/2/00-Pers/4911-18 dtd. 01-12-2020 has intimated Ministry of Education and asked for immediate release of money to ensure compliance of the order of the High Court. The University has also responded vide letter No. 105/2/00-Pers dtd. 01-12-2020 to the letter of the Ministry of Education No. 9-5/2020-CU-I dtd. 13-11-2020. The relevant communications are placed in the meeting. The matter was placed before the Council for discussion and direction if any.

**Resolution :** The Council noted the matter especially the latest communications made by Ministry of Education vide letter F.No.9-5/2020-CU-I dated 10<sup>th</sup> December 2020 and vide letter F.No.9-5/2020-CU-I dated 16<sup>th</sup> December 2020 which were placed by Registrar during the meeting.
