**Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the Assam University, Silchar for the year ended 31 March 2015.**

We have audited the attached Balance Sheet of the Assam University, Silchar as at 31 March 2015, the Income and Expenditure Account and Receipts and Payments Account for the year ended on that date under Section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 31(1) of Assam University Act, 1989. These financial statements include the accounts of two units of the University. These financial statements are the responsibility of the University's Management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This separate Audit Report contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the Management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that :

- i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- ii. The Balance Sheet and Income and Expenditure Account/Receipt and Payment Account dealt with by this report have been drawn up in the format prescribed by the Ministry of Human Resource Development, Government of India vide order No. 29-4/2012-FD dated 17 April 2015.
- iii. In our opinion, proper books of accounts and other relevant records have been maintained by the Assam University, Silchar as required under

Section 31(1) of the Assam University Act, 1989 in so far as it appears from our examination of books.

- iv. We further report that

#### A. Balance Sheet

##### 1.1 Liabilities

###### 1.1.1 Current Liabilities and Provisions (Schedule 3) : ₹ 77.98 crore

The above amount had been arrived at after adjusting negative balances totaling to ₹ 6.81 crore under Students Co-curricular fund (₹ 2.89 lakh), Hostel maintenance fund (₹ 2.94 lakh), Model Study Fee Fund (₹ 0.05 lakh) and OBC grant (₹ 675.52 lakh). As the amount was recoverable/receivable from respective agencies, the same should have been shown under Loans, Advances & Deposits.

This exhibition of minus balances had resulted in understatement of Current Liabilities and Provisions as well as Loans, Advances & Deposits by ₹ 6.81 crore.

##### 1.2 Assets :

###### 1.2.1 Loans, Advances & Deposits (Schedule-8) : ₹ 32.60 crore

The above head had been overstated by ₹ 3.75 crore as advance (₹ 3.10 crore) paid to CPWD for construction of four civil works at Diphu Campus and advance of ₹ 0.65 crore paid for subscribing print journals had not been capitalised despite completion of the works by CPWD in between November 2008 and October 2009 and receipt of print journals by March 2015.

This had also resulted in understatement of Fixed Assets by an equal amount.

Further, it had resulted in short provision of Depreciation of ₹ 0.44 crore as the above amounts were not capitalized and this had further resulted in overstatement of Excess of Income over Expenditure by same amount for the year 2014-15.

#### B. Income and Expenditure Account

##### 2.1 Expenditure

###### 2.1.1 Other Expenses (Schedule-21) : Nil

The amount of Loans, Advances & Deposits included ₹ 2.70 lakh shown as recoverable towards Education loans and ₹ 5.51 lakh being the amount of excess expenditure incurred on 10 projects shown as recoverable from project sanctioning authorities, which were pending for recovery for more than 3 years. Since prospect of recovery is remote, the matter may be reviewed and necessary provision for Bad & Doubtful debts should have been made.

#### C. General

**3.1** Current Liabilities & Provisions included an amount of ₹ 1.55 crore (sub-schedule-3A item no: 77) as Misc-Suspense Receipts. Out of which, ₹ 76.08 lakh remained unadjusted for more than one year and ₹ 6.51 lakh remained unadjusted for more than two years. The University needs to identify the source and purposes of receipts of amount lying under Misc-Suspense Receipts Head.

**3.2** Rule 215 (3) of GFR stipulates that while the project or schemes are ongoing, the assets created or acquired out of those sponsored projects funds should be disclosed specifically as regards their holding and using such assets in the 'Notes on Accounts'.

Since 2005-06, the University did not disclose total Nos. of project/scheme closed while assets valuing ₹ 39.76 lakh only had been shown (Schedule-4E) since March 2004, though during the period April 2005 to 31<sup>st</sup> March 2015 the University had created Fixed Assets of ₹ 13.76 crore out of grants received under 149 sponsored projects/schemes. Further, 5 projects out of 149, were completed and assets of ₹ 69.24 lakh had been created. Despite mention in earlier year's Management Letter, the University had not disclosed the possession of assets valuing ₹ 13.76 crore against sponsored projects/schemes in schedule-24 – 'Notes on Accounts'.

**3.3** As per Notes and Instructions for compilation of financial statements of Central Higher Educational Institutes issued by the MHRD on new format of accounts, provisions for liabilities on actuarial valuation basis towards the amount payable on gratuity, pension (including family pension) and accumulated leave encashment to the employees on death/retirement are to be made in the accounts. In departure therefrom, the University had not provided any liabilities on the above grounds.

#### D. Grants-in-aid

The University is mainly financed by the grants received from the Government of India. During the year (2014-15) the University had received total grants of ₹ 8039.98 lakh (Plan ₹ 2945.40 lakh including receivable grants of ₹ 500.75 lakh and Non-plan grant ₹ 5094.58 lakh including receivable grant of ₹ 1459.95 lakh of previous year). Out of the total grants (₹ 8039.98 lakh) the University had spent ₹ 7375.19 lakh (Plan ₹ 1560.70 lakh and Non-plan ₹ 5814.49 lakh) leaving an overall unspent balance of ₹ 664.79 lakh (Plan ₹ 1384.70 lakh and Non-plan ₹ (-) 719.91 lakh).

Besides above the University had also received grants of ₹ 250.00 lakh under TEQIP and ₹ 703.00 lakh under Academic & Research collaboration

between Queen's University Belfast & North Eastern Region Institution. The University had spent ₹ 76.00 lakh only under the TEQIP head leaving an unspent balance of ₹ 174.00 lakh at the end of 2014-15 and no expenditure was incurred against the fund of Academic & Research collaboration between Queen's University Belfast & North Eastern Region Institution.

#### G Net Effect

The net impact of the comments given in the preceding paragraphs is that the Assets and Liabilities in main Balance Sheet had been understated by ₹ 6.81 crore as at 31 March 2015 and the excess of Income over expenditure was overstated by ₹ 0.44 crore for the year ended 31 March 2015.

#### H Management Letter

Deficiencies which have not been included in the Audit Report have been brought to the notice of the Vice Chancellor, Assam University, through a management letter, issued separately for remedial/corrective action.

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income and Expenditure Account and Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.
  - a. in so far as it relates to the Balance Sheet, of the state of affairs of the Assam University, Silchar as at 31 March 2015 and
  - b. in so far as it relates to Income and Expenditure Account of the surplus for the year ended on that date.

- 2.2 The head of accounts of University were not codified.
- 2.3 All purchases were not made through Purchase Department.

### **3 Physical Verification of Assets :**

University had not conducted Physical Verification of Asset since 2011-12.

### **4 Statutory Liabilities**

The University had not disposed of CEST (Service Tax) amounting to ₹ 1.72 lakh.

### **SCHEDULE - 23      SIGNIFICANT ACCOUNTING POLICIES:**

#### **a) Accounting Convention**

Assam University is a Central University established in 1994 under an Act of Parliament (Act XXIII of 1989). It is substantially funded by Government of India. The Financial Statements are prepared on historical cost basis in accordance with applicable Accounting Standards issued by the Institute of Chartered Accountants of India. Accrual method of accounting and recognition of Income & Expenditure is followed in the preparation of the Final Accounts except for the following:

#### **b) Recognition of Income/Expenditure**

- i) Fees from students, sale of admission forms and interest on savings bank accounts are accounted for on cash basis.
- ii) Receipts of interest on House Building Advances are accounted for on recovery basis.
- iii) Receipts of Interest on Endowment Funds are accounted for on realisation basis.
- iv) Expenditure on charges prepaid except subscription of journals, is accounted for on cash basis.

#### **c) Transfer to the Capital Fund**

- i) Assets created out of Earmarked/Designated Funds where the ownership of such assets are vests with the University are accounted for by transferring the amount to the Capital Fund and correspondingly merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets.

#### **d) Inventories**

- i) Inventories comprising of chemicals, glassware, consumables, stationery and other stores are valued at lower of cost or net realizable value. Costs of inventories are determined on FIFO method of Inventory Valuation.

e) Investments

- i) Long Term Investments are carried at cost.
- ii) Current Investments are carried at lower of cost or fair value.

f) Foreign Currency Transactions

- i) All foreign currency transactions are recorded, in the reporting currency, by applying to the foreign currency amount at the exchange rate prevailing on the date of settlement.

g) Fixed Assets, Depreciation & Amortisation

- i) Fixed assets of the University are acquired out of the Grants received from the Government of India. Grants utilized for acquisition of Fixed Assets are accounted for by transferring the amount to the Capital Fund and correspondingly merged with the Fixed Assets of the University.
- ii) Fixed assets are stated at historical cost less depreciation.
- iii) Capital Works in Progress are stated at cost, incurred relating to Assets in progress.
- iv) Value of an asset, when fully charged to depreciation, but in use, is carried over at residual value of Re.1/-.
- v) Depreciation on Tangible Fixed Assets is provided on Straight Line Method at the following rates:

- vi) Intangible Assets (Software) are amortised at the rate of 40% on Straight Line Method of Depreciation.
- vii) Intangible Assets (Software) acquired on or before 31.03.2013 were shown and depreciated as "Computer/Peripherals". Because of difficulty in the identification as well as determining the depreciated value of these Intangible Assets, the Intangible Assets (Software) acquired before 31.03.2013 are still shown and depreciated as "Computer/Peripherals". But Intangible Assets (Software) acquired from 01.04.2013 are amortised as per the Accounting Policy described in (vi) above.
- viii) Depreciation/ amortisation on additions during the year are provided on a pro-rata basis from the date the asset is acquired.

#### **h) Employee Benefits**

- i) Short term employee benefits are charged off in the year in which the related service is rendered.
- ii) Post Employment Benefits in the form of Provident Funds and New Pension Scheme Fund are owned and managed by employees as members of these Funds. The University has no ownership on these funds. Retirement Benefits in the form of contribution to these funds are Defined Contribution Schemes and are charged to the Income & Expenditure Account as and when the contribution is due.
- iii) Other Post Employment Benefits, other Long Term Benefits & Terminal Benefits are paid to the employees as and when it becomes due by charging the amount to the Income and Expenditure Account.

The Accounting Policy followed by the university as described (iii) above is not as per the Accounting Standard 15, "Employee Benefits" issued by the Institute of Chartered Accountants of India. The University should Actuarially determine and provide for liability in respect of these Employee Benefits. The reason for such departure is because the Assam University is situated in the North East Corner of India and there is neither any Actuarial services available in this

part of India nor any Actuary is willing to come from other parts of India to do the valuation of Employee Benefits as required in the Accounting Standard 15, "Employee Benefits". The financial effect of such departure is not ascertainable.

i) **Taxes on Income**

- i) The Income of the University is exempt from Income Tax under Section 10(23C)(iiab) of the Income Tax Act, 1961. Hence no provision for income tax is made in the accounts.

j) **Research Activities**


- i) The Research and Development expenditure comprises all expenditure that is directly attributable to research or development activities or that can be allocated on a reasonable and consistent basis to such activities. Expenditure on Research and Development is recognised as an expense when it is incurred.

k) **Contingent Liabilities**

- i) Liabilities, which are material and whose future outcome cannot be ascertained with reasonable certainty, are treated as contingent and disclosed by way of notes to the accounts.


**b) Current Assets, Loans, Advances and Deposits**

- h) As the Provident Fund accounts and the New Pension Scheme Account are owned by the members of those funds and not by the University, these accounts were separated from the University's Accounts.
