At the outset the Vice-Chancellor cum Chairman of the meeting welcomed all the members of the Executive Council. The Chairman also welcomed Dr. Bharati Singh and Prof. Amarendra Kumar Das, Visitor's Nominees for attending the meeting through video conference. The Chairman further welcomed Dr. Subrata Hazarika, Senior most Associate Professor participated in the meeting as new member.

Thereafter the meeting formally started and following agenda items were taken up for discussion and resolutions were adopted accordingly.

#### **Item No. 1 : Reopening of University Campus for offline classes :**

**EC:144:08-21:01 :** As per the latest SoP issued by the State Government, Higher Educational Institutes are to gradually start functioning through offline mode from 1<sup>st</sup> September 2021. In the light of state SoP, matter for reopening of offline classes of University is placed before the Council for discussion and direction.

**Resolution :** On having detailed discussion on the issue, the Council resolved that the existing Committee for the purpose shall review the situation with reference to latest SoP from the State Government and to report back to the Vice Chancellor. The Council was also in the opinion that the University shall open offline classes first for the Research Scholars in phase manner based on the basis of State SoP. Further, offline classes for other Courses to be opened on the basis of report of the Committee. The completely vaccinated student can only stay in the University hostels.

#### **Item No. 2 : Utilisation of Annual Course Fee Fund of self-financing course of the University :**

**EC:144:08-21:02 :** The validity of utilization of Annual Course Fee Fund for the department is for one year as per the decision of the 85<sup>th</sup> meeting of the Academic Council vide resolution No. AC:85:07-19:9. However, the University is also running several self-financing courses like B.Voc which are no more financially supported by UGC. In such courses, if the fund lapses after one year, it will become extremely difficult to run the courses smoothly. Therefore, for self financing courses, the validity of

utilization of Annual Course Fee Fund may be raised from one year to 'n+1' year, where 'n' is the duration of the course. For example, in case of B.Voc, where course duration (n) is three years, the validity of utilization of Annual Course Fee Fund may be 'n+1' i.e, 3+1=4 years.

The matter was placed before the Council for consideration.

**Resolution :** The Council approved the proposal.

**Item No. 3 : Issue of Pensioners Identity Card and Pension Book to Superannuated/Retired employees of the University :**

**EC:144:08-21:03 :** The University has received several requests including Employees Association for issue of Pensioners Identity Card and Pension Book to Superannuated/Retired employees of the University.

The matter was placed before the Council for consideration.

**Resolution :** The Council approved the same and directed the University administration to process further.

**Item No. 4 : Research guideship by teachers of non-core departments :**

**EC:144:08-21:04 :** The 88<sup>th</sup> meeting of Academic Council vides resolution No. AC:88:07-21:30 adopted the recommendation of Prof. C. R. Bhattachajee Committee subject to further administrative scrutiny. The matter was referred to Controller of Examinations for administrative scrutiny. Report of COE was placed in the meeting for further discussion.

**Resolution :** The Council discussed the matter in length and decided that the matter shall be referred back to the Committee constituted for the purpose to re-visit the issue and the report to be submitted in the next regular meeting of the Academic Council.

#### **Item No. 6 : Reporting to Assam University Diphu Campus (AUDC) by Dr. Sudipto Sarkar, Associate Professor, Dept. of Agricultural Engineering:**

**EC:144:08-21:06 :** In pursuance of 143<sup>rd</sup> EC resolution vide No. EC:143:06-21:01 dtd. 29<sup>th</sup> June 2021 Dr. Sudipto Sarkar, Associate Professor, Dept. of Agricultural Engineering was asked to report to Pro-Vice Chancellor, AUDC through online/offline mode. Minutes of the meeting of the committee constituted by the Vice-Chancellor under the Chairmanship of Prof. S Giri, Dean School of Life Sciences on Special Course Work Examination and related matters as :

"The committee feels that the students may be given one more regular special course work examination in 2022 along with the Regular Course Work Examination in addition to special course work examination 2020 & 2021. Those who fail to qualify in the first attempt of special course work examination may be allowed to appear arrear paper. This is applicable only for those candidates who are covered under special Course Work Examination".

As the notice (Ref. No. AUE/COE/CW-66/2017 (Vol-1), Dtd 8<sup>th</sup> May 2021) refers to students across the University the matter may be ratified in the next meeting of AC.

The 88<sup>th</sup> meeting of Academic Council vide its resolution No. AC:88:07-21:8 has accepted the same and resolved that those scholars who are eligible to sit for special course work examinations {Ref. No. AUE/COE/CW-66/2017 (Vol-1), Dtd 8<sup>th</sup> May 2021} shall be allowed to submit their thesis for evaluation on completion of all other required formalities. However, her/his result shall be kept in abeyance until she/he qualifies the special Course Work examination (Old) with a minimum of 55% marks in aggregate. Scholars must qualify special course work examination within 2022, failing which their candidature for Ph.D. degree will stand cancelled.

Students may be given chance of clearing arrear papers (if any) in one more special course work examination (Old) in 2022 along with the Regular Course Work Examination in addition to special course work examination 2020 & 2021. Those who will fail to qualify in the first attempt of special course work examination, they may be allowed to appear for arrear paper(s) in the next arrear examination to be conducted by the University. The matter was placed before the Council for final approval.
