

#### **ASSAM UNIVERSITY: SILCHAR**

### NOTICE

In partial modification of the notification No.AUR/21-1/2020-21 dated 26<sup>th</sup> October 2021 and in pursuance of the resolution of the 89<sup>th</sup> Meeting of the Academic Council held on 16<sup>th</sup> November 2021 and in consideration of the prevailing situation arising out of COVID 19; the following guidelines are laid down for information and necessary compliance by all concerned.

- Odd semester Offline Classes (except 1<sup>st</sup> Semester) of following Schools shall be held on all working days with effect from 29<sup>th</sup> November 2021.
  - i. Albert Einstein School of Physical Sciences
  - ii. Horgobindo Khurana School of Life Sciences.
  - iii. Jawaharlal Nehru School of Management Studies
  - iv. E P Odium School of Environmental Sciences
  - v. Triguna Sen School of Technology
  - vi. Susgruta School of Medical and Paramedical Sciences
  - vii. Aryabhatta School of Earth Sciences
- Classes (except 1<sup>st</sup> Semester) of following Schools shall be held on blending mode (Offline & Online). Offline classes shall be held on Monday, Wednesday and Friday
  - i. Mahatma Gandhi School
  - ii. Abanindranath Tagore School
  - iii. Ashutosh Mukhopadhyay School
  - iv. Rabindranath Tagore School
- Classes (except 1<sup>st</sup> Semester) of following Schools shall be held on blending mode (Offline & Online). Offline classes shall be held on Tuesday, Thursday and Saturday
  - i. Suniti Kumar Chattopadyay School
  - ii. Jadunath Sarkar School
  - iii. Sarvepalli Radhakrishnan School
  - iv. Swami Vivekananda School
  - v. Deshbandhu Chittaranjan School
- 4. Classes of 1<sup>st</sup> Semester for all the Schools shall be held online on commencement of the same.
- 5. As Government of India is yet to extend COVID 19 vaccination to citizens below the age of 18 years; therefore, no vaccination certificate for COVID 19 is required to be produced by the students of the University born on or after 1<sup>st</sup> April 2003. However, concerned students shall be required to provide proof of Date of Birth as and when asked for.

- 6. Departments having field work, extension services etc. for students may arrange the same ensuring and abiding by the COVID 19 protocol laid down by GoI from time to time.
- 7. All concerned in the campus are expected to abide by the COVID-19 protocol. Students should refrain from visiting other academic and administrative departments. Assembly of 5 or more persons for programmes/activities other than official and declared well in advance shall be considered illegal and violation of COVID protocol in the campus.
- 8. Hostel accommodation shall be provided from 1<sup>st</sup> December 2021 to boarders of the hostel who had to vacate hostel due to pandemic but are still pursuing the Course as a bonafide regular student of the University. Such boarders have to fill up a proforma and submit undertaking as per format enclosed herewith within 25<sup>th</sup> November, 2021 to Mr. Gautam Nandi Purkyastha, Security Officer, Assam University, Room No. 007 (Administrative building).
- 9. The allotment of hostel rooms to the existing boarders shall be provisional and Mess arrangement shall be made by boarders. However, the University in course of time shall facilitate mess arrangement by finalising vendors on self financing basis by the boarders.
- 10. Hostel dues shall not be charged upon boarders for the period vacated on the basis of notice issued from this end in view of spread of COVID-19.
