Assam University Diphu Campus has received the verification and antecedents reports of the teachers of Sl. No. 1 to 5 **except Sl. No. 6**, which is yet to receive. The forwarding letters along with the PBAS of the teachers in original for Sl. No. 1 to 6 has already been send to Silchar Campus. The matter was placed before the Council for perusal and approval.

Resolution : The Council approved all the cases of confirmation of service except Sl. No. 6, the case of Dr. Sheetanshu Kumar which has been dropped by the Council.

Item No. 19: Matter regard to completion of tenure of Pro-Vice-Chancellor, Diphu Campus.

EC:146:01-22:19: As per the Statute 4(2) the term of office of a Pro-Vice-Chancellor shall be such as may be decided by the Executive Council but it shall not in any case exceed five years or until the expiration of the term of office of the Vice-Chancellor whichever is earlier. Hon'ble Vice-Chancellor completed five years of his office on 15-05-2021, however Ministry of Education vide letter F.No.9-4/2021-CU-1 dated 15.5.2021 has conveyed that the present Vice-Chancellor, Assam University may continue in office notwithstanding the expiry of the tenure till his successor is appointed and enters upon office or till further orders, whichever is earlier. But no such decision with respect to Pro-Vice-Chancellor, Assam University, Diphu Campus was taken and no extension order was issued.

Matter was placed before the Council for information and appropriate decision in this regard.

Resolution : The Council deliberated the matter and noted the fact that no extension order was issued for the service of PVC, AUDC which ought to have been. The Council however, ratified the service of Prof. Sibasish Biswas during the extended term of Vice-Chancellor by considering the period as an extended period. However, the service of PVC shall remain as coterminous as per statute and the extended period of Prof. Sibasish Biswas as PVC shall end with the cessation/termination/end of extended tenure of service of the present Vice-Chancellor.

EC:146:01-22:37: The 89th meeting of Academic Council vide its resolution No. AC:89:11-21:33.9 has accepted the matter. After threadbare discussion, the member present in the Academic Council unanimously decided that PG/ UG/ Integrated Odd Semester Examination, 2021 will be held within 22nd January, 2022 to 15th February, 2022. The examination will be held in offline mode. Student will be required to answer one question from each unit. (Answer five questions taking one from each unit). It is also decided that TDC Odd Semester Non CBCS Examination, 2021 examination will be held in offline mode in the last week of January, 2022 and the type of question will be as per CBCS guidelines. The Council further recommended the same to the Executive Council for approval.

Resolution: The Council approved the proposal. However, the state SoP shall be followed and the Vice Chancellor is authorized to take necessary action in consultation with the COE time to time as required.

Item No. 38: Change of home town in respect of Dr Ajit Kumar Baishya, Professor, Dept of Linguistics:

EC:146:01-22:38: Dr Ajit Kumar Baishya, Professor, Dept of Linguistics has applied for change of home town from Sualkuchi to Guwahati, Assam. He has submitted his application in the prescribed format for change of home town. The relevant documents in connection with change of home town such as i) photocopies of first page and last page of the deed of purchase of flat at Guwahati, ii) photocopy of NOC issued by DC's office,

Kamrup Metro for transfer of flat by way of sale submitted by Prof Baishya. It may be noted that Dr Das has applied for change of home town for the first time as per service record. He is entitled to change his home town as per CCS Rule.

The matter was placed before the Council for perusal and approval.

Resolution: The Council approved the same.

Item No. 39: Audit observation on non deduction of Income Tax on leave encashment.

EC:146:01-22:39: CAG vide Para 2.4, 2019-20 has observed that as per section 10(10AA) of Income Tax Act 1961, any payment received as leave encashment at the time of retirement, whether on superannuation or otherwise, shall be "fully exempted" for Central Government and State Government employees. However, in case of such payments received by an employee other than the employee of the Central Government or a State Government, the limit of exemption of leave encashment has been specified as Rs 3.00 lakh u/s 10(10AA)....Since Assam University is an autonomous organization its employees do not fall in the category of central or state government employees, hence leave encashment received by them at the time of retirement is chargeable to income tax subject to an exemption limit of Rs 3.00 Lakhs.

Similarly, incase of tax on perquisites, the University has received similar observation from CAG.

Accordingly, the University is deducting income tax at source on leave encashment. However, the matter was placed before the Council for discussion and direction, if any.

Resolution: On perusal of the said Audit observation, the Council resolved that the administration shall communicate to the MoE/UGC for clarification on the issue and in the meantime the University shall follow the Income Tax rules in force.

Item No. 40: Matter relating to non-subscription to pension scheme in time :

EC:146:01-22:40: CAG report vide para 7.1, 2015-16 observed that there has been additional liability due to retention of NPS subscription and contribution of some of the employees. The crux of the matter is that a number of employees has not subscribed to NPS for years which has created administrative, legal and financial issues. It is therefore submitted that hereafter:

- Employees at the time of joining the University have to compulsorily fill up form for allotting PRAN account for NPS subscription without which no salary shall be disbursed.
- 2. Existing employees who are yet to subscribe to NPS and are not eligible at the moment for any other pension scheme on the basis of documents available with Assam University must submit filled in form for allotment of PRAN and NPS subscription within a period of three months without which no further salary shall be disbursed beyond three months.

- 3. Pension benefits of combined service on joining Assam University through proper channel shall be considered, if past service benefits are transferred to Assam University in full and final within one year of joining Assam University. However, in special circumstances, based on proper justification, the period may be extended by another year by Vice-Chancellor.
- 4. Pension benefits of combined service for employees of Assam University who have joined prior to 2020 through proper channel shall be considered, if past service benefits are transferred to Assam University in full and final within a period of six months. However, in special circumstances, based on proper justification, the period may be extended by another six month by Vice-Chancellor.

The matter was placed before Executive Council for consideration.

Resolution: The Council discussed in detail and directed Registrar to obtain legal vetting and administrative scrutiny on the matter.

Item No. 41: Optimum utilization of DG set installed at different locations within the campus.

EC:146:01-22:41: It is observed that University is having DG sets installed at different locations within the campus which are not utilized to its optimum level. Especially Science departments are facing lots of trouble due to acute crisis of uninterrupted power supply which result to non-functioning of sophisticated equipment installed in their laboratories. It hampers functioning of regular academic affairs and research works due to non-availability of uninterrupted power supply. Whereas, in some cases it is observed that DG set installed in some of the locations are not used regularly which results to discharge of batteries regularly and other technical problems. For maintenance of those DG sets it requires regular expenditure in the form of purchase of new batteries etc. Moreover to run these DG sets University has to deploy operators at different locations for running of those DG sets which result into underutilization of manpower to its optimum level thus result into extra recurring expenditure.

To overcome such situation it is proposed to shift all those DG sets to a common place where from it can be controlled by a single operator and uninterrupted power supply can be supplied to all those departments where it is required. It will reduce recurring expenditure on maintenance of those DG sets and underutilization of manpower and also lead to optimum utilisation of DG Sets.

The matter was placed before Executive Council for its approval to shift DG sets as per requirement to facilitate stake holders of the University.

Resolution: The Council approved the same.

The matter was placed for consideration. If agreed, a Committee may be constituted in course of time for framing guidelines in this regard.

Resolution : The Council approved the proposal in principle and it is decided that a committee to be constituted by the Vice Chancellor to look into the issue.

Item No. 46: Standardisation in purchase of equipments from GeM.

EC:146:01-22:46: Due to lack of standardization of specification/model of the purchase of equipments by the University; it is observed that the University receives products from various brands with varying quality when procured through GeM. It becomes very difficult to ensure AMC of these products as there is no homogeneity. It is therefore necessary to finalize a set of specification for each of these frequently purchased equipments. The matter was placed for Consideration. If agreed, a Committee may be constituted in course for framing guidelines in this regard.

Resolution: On thorough discussion the Council advised the University to constitute a committee by the Vice Chancellor for framing the guidelines for the purpose.

Item No. 47: Implementation of e-office for paperless office management.

EC:146:01-22:47: E-office is digital workplace solution comprising of a suite of products that paves the way for an efficient and transparent system by streamlining workflow for both inter and intra University processes and making them paperless. The aim of e-office is to offer comprehensive portal to implement Human Resources & Record Management. The advantages are:

- Paper less file/record management. Online PBAS/APAR can be maintained.
- Access to office even on non working days in emergency
- A complete record warehouse will be created and reply to ministry may be sent immediately with error free data. Moreover, it ensures Assure data security and data integrity
- Increase accountability the responsibility of quality and speed of decision making is
 easier to monitor. Keeping in view of the Pandemic situation, Office will be ON even
 during closure.
- Greater output by releasing staff energy and time from unproductive procedures.
- The records can be updated by the staff himself as and when required. Thereby, promote greater collaboration in the work place and effective knowledge management.



The Government of India extends e-office facility on payment basis. Instead of procuring separate software and hardware, the University can take advantage of the Centralised system of GoI on payment basis.

The matter was placed for consideration. If agreed, a Committee may be constituted in course for framing guidelines in this regard.

Resolution: The Council approved the matter in principle. However, the Council authorized the Vice-Chancellor to constitute a committee and prepare modalities for implementing the same as per feasibility.

Item No. 48: Selection of Non-Teaching PWD Positions through Direct Recruitment:

EC:146:01-22:48: The Selection Process for the Non-teaching positions have been completed against the Employment Notification No. 4/2017 dtd. 09/08/2017, 2/2020 dtd. 28/05/2020, & 3/2020 dtd. 21/9/2020 and appointment for post other than PWD posts have been made as per resolution of the 144th EC meeting vide No. EC:144:08-21:05(d) dtd. 26th August 2021. Resolution: The Council approved the recommendation of DPC/Selection Committee for following PWD posts and the Council recommended the following persons to be issued offer of appointment for the respective Non-Teaching positions:

 Library Attendant: OBC-PWD (Heard of Hearing): Shubro Acharrjee (Roll Number - LIBA/002)

2. Laboratory Attendant : UR-PWD (Autism) : Bijoy Dhar (Roll Number – LA/152)

3. Laboratory Attendant: UR-PWD (Heard of Hearing): NFS

4. MTS: OBC-PWD (Low Vision) : No applicant found

5. Hindi Translator: PWD : No applicant appeared for written

test.

The Council directed the University administration for re-advertise the positions at SI No. 3 to 5 as per rules. However, in view of letter to All Registrars of CU by UGC vide No. F.8-1/2014(CU) dated 18th October 2021; it has been resolved that consent of UGC be obtained before issue of appointment letter.

Item No. 49: Wage revision of casual/contractual employees:

EC:146:01-22:49: As per the resolution of the 143rd meeting of the Executive Council vide resolution No. EC:143:06-21:20 dtd 29th June 2021 a letter was sent to UGC vide email dtd 22nd October 2021 for necessary action at their end. However, no response has been received yet. A Committee was therefore constituted vide office notification No.113/18/96-Pers/5669-72 dtd 22-12-2021 to suggest appropriately as the Central Govt. Industrial Tribunal cum Labour Court vide order dtd. 22-07-2021 has directed the management of Assam University to hold discussion in the concerned workers or their representatives

within 90 days of the receipt of the award and arrive at a fresh settlement in regard to payment of wages etc to the concerned workers. The report of the Committee shall be placed in the meeting. The matter was placed before the Council for decision.

Resolution : In view of the decision of the 62nd Finance Committee on the Action Taken Report on item No 61/10, the Council resolved to wait till a response is obtained on the matter from UGC.

Item No. 50: Item from the Chair:

EC:146:01-22:50.1: Proposal for setting up a chapter of Indian Institute of Foreign Trade at Silchar, Assam:

Dr. Rajdeep Roy, Hon'ble MP, Silchar, Cachar has communicated to the Hon'ble Minister of Commerce & Industry, GoI, dtd. 12-11-2021 for setting up a chapter of Indian Institute of Foreign Trade at Silchar, Assam. In this context he had a discussion with the competent authority of the University and some other representatives of the Govt. of Assam. Hon'ble local MP has nicely elaborated the advantages of having such a programme in Silchar whereas he has cited the very need of the hour in respect to encouraging the business scope in the North Eastern Region in foreign trade and also with the ASEAN countries, which will be a step forward to the success of the "Act-East Policy".

The need being immediate, he has requested to start a 'Certificate Programme' dealing with the Trade & Export Development for which support may be obtained from NIT, Silchar in collaboration with IIFT, Kolkata. He is also in the opinion that the formalities for setting up of IIFT in Silchar may also be taken up. This is in view to train and empower people to take the advantages of the initiatives.

Hon'ble MP desired to start this initiative within the next three months keeping in view that the NEC is already funding a Centre for North East Studies (CeNEST), at IIFT, Kolkata which will help the tusk of setting the programme easier.

The copy of the letter addressed to the Hon'ble Minister of Commerce & Industry, GoI, communicated by our Hon'ble MP was placed for perusal of the members and a decision in this regard as the role of Assam University to be decided.

Resolution: The Council consented to the pproposal of opening a chapter of IIFT in Assam University Silchar campus. The Dean, School of Economics & Commerce was given the responsibility to look into the matter of setting up of the course in the School.

EC:146:01-22:50.2: Deal with legal matter/Court cases in the University:

Resolution: The Chairman placed the issue of filing of cases against statutory officers of the University by name by various aggrieved petitioner. The Chairman pointed out that these cases arise out of discharge of official function by Statutory Officers and filing of the

case by name should not create obstacle for the University not to represent the same. The Council agreed to the view of the Chairman and resolved that any case filed against any Statutory Officer by position or by name shall be dealt by the University if the matter arises out of discharging official duty by concerned Officer.

EC:146:01-22:50.3: Transfer of faculty from CIL:

Resolution : The Chairman placed before the Council the communication made by UGC vide letter F.No.18-9/219(CU) dated December 2021 on transfer of teaching posts from CIL, Assam University to academic departments whereby UGC authorized the University to utilize the services as per their own need. On perusal of the same, the Council approved the transfer of teaching posts of the two faculties of CIL viz. Dr. Siddhartha Sankar Nath and Dr. Subhasish Coudhury in the Dept. of Electronics & Communication Engineering and Dept. of Life Science & Bio-informatics respectively in addition to the existing number of faculties in both the departments.

EC:146:01-22:50.4: Opening of classes in the University:

Resolution: The issue of opening of classes for offline/online was discussed in the meeting and keeping in view the present scenario, the Council was in the opinion that the Vice Chancellor shall take appropriate decision on the basis of SoP issued by the State Government & other Regulatory Bodies from time to time.
