Thereafter the meeting formally started and following agenda items were taken up for discussion and resolutions were adopted accordingly.

Agenda item for ratification by the Executive Council:

Item No 1 : Grant of lien to Dr. L. Dibamani Singh, Dy. Director (S&PE) :

EC:155:02-23:01 : Dr. L. Dibamani Singh, Deputy Director (S & PE) has been appointed for the post of Registrar at National Sports University, Imphal vide offer of appointment letter No. 4/NSU/ESTT/REG/2022, dated 31.12.2022 and Dr. Singh was released from the post of Deputy Director (S & PE) on 05-01-2023 (A/N) by granting lien for the period of five (05) years with one day earned leave on 6th January, 2023 vide order No. 103/720/99-Pers/dated 05-01-2023 to enable him to join in his new assignment in National Sports University, Imphal.

The matter was placed before the Executive Council for ratification.

Resolution : The Council perused and ratified the same.

Item No 2 : Promotion of Dr. Naba Kanta Sarma - Preponing Date of Effect of Promotion :

EC:155:02-23:02 : The Screening Committee for CAS has recommended the date of effect for promotion in respect to Dr. Naba Kanta Sarma, Dept. of Mathematics (Assistant Professor Stage I to Stage II) as 10-12-2008 (preponed) from 10-12-2011 which has already been approved by the Vice Chancellor.

The matter was placed before the Council for ratification.

Resolution : The Council perused and ratified the same.

Item No 3 : Extension of period of suspension in respect of Dr Laxmi Narayan Sethi, Dept of Agricultural Engineering :

EC:155:02-23:03 : Dr Laxmi Narayan Sethi, Professor, Dept of Agricultural Engineering was placed under suspension vide order no. 103/220/2006-Pers/2086-94 dated 8 August 2022. The competent authority extended the period of suspension of Prof. Sethi for further period of 90 days from the date of completion of initial period of suspension under Rule 10 (6) of CCS (CCA) Rules, 1965 vide order no. 103/220/2006-Pers/3334-44 dated 4 November 2022 and after completion of 1st extension period it has been extended for a further period of 180 days vide order No. 103/220/2006-Pers/504-11 dated 3rd Feb. 2023.

The matter was placed before the Council for ratification of the 2nd extension period.

Resolution : The Council perused the matter and ratified the same.

Item No 4 : Review of suspension in respect of Shri Murali Basa, Dept of Performing Arts :

Resolution : The Council perused and approved the same.

Item No. 10 : Approval of the recommendations of 66th meeting of the Finance Committee of Assam University slated on 24th February 2023 :

EC:155:02-23:10 : The 66th meeting of the Finance Committee of the University was held on 24th February 2023 was placed on the table for consideration and approval by the Executive Council.

Resolution : The Council perused and approved the same.

Item No. 11 : Creation of Assam University Guest House Receipt Fund :

EC:155:02-23:11 : The University Guest House needs to be maintained on self financing mode and therefore all the income generated from the Guest House shall be accumulated in a fund which may be named as "Assam University Guest House Receipt Fund".

Accordingly, the expenses required for Guest House including Capital Expenditure from time to time may be met up from the said fund generated. It is proposed that the same may be affected from April 1, 2023.

The matter was placed before the Council for consideration.

Resolution : The Council accepted the proposal.

Item No. 12 : Construction of Sengyajik Joya Thaosen Memorial Hall cum Museum in the University Campus, Silchar :

EC:155:02-23:12 : A proposal is received from the Chairman, Barman Dimasa Kachari Development Council (BDKDC), Assam, for allotment of land for the construction Memorial Hall cum Museum in the name national freedom fighter Sengyajik Joya Thaosen in the University campus, Silchar. The Council have agreed in principle to construct a **500 seated capacity Auditorium cum Museum** including office room, teacher's cabin, class room and library etc. The Engineering Cell of the University was requested by the BDKDC to prepare the DPR from the same.

Accordingly, a preliminary survey for identification of land for construction has been conducted and it is proposed that the said Memorial Hall cum Museum may be constructed on the other side of the University main road opposite to Administrative Building at the junction point of Examination Block.

The matter was placed before the Council for consideration.

Resolution : The Council approved the proposal and directed the University for communication to be made to the Chairman, BDKDC in this regard.

Item No. 13 : Naming University Guest House :

EC:155:02-23:13 : The Assam University has two Guest Houses namely (i) Kamini Kumar Chanda Guest House (Old Guest House) and (ii) International Guest House (IGH). In recent past the IGH was renovated and became fully operational now. It is proposed that the IGH may be named after any great personality of our country and in this regard the Executive Council may select a suitable name for the building.

The matter was placed before the Council for consideration.

Resolution : The Council discussed the agenda including proposal raised in the meeting by the PVC i/c, AUDC for extension of Kamini Kumar Chanda Guest House

and it was resolved that the Vice Chancellor is authorized to constitute a Committee to finalize the issue.

Item No. 14 : Memorandum of Understanding (MoU) between India Metrological Department (IMD) and Assam University, Silchar :

EC:155:02-23:14 : Proposal is received for MoU between India Metrological Department and Assam University, Silchar under which a plot of land is proposed to be leased for 30 years to IMD. On perusal of the same, some suggestions were forwarded by a few Officers of the University for modification/addition/ alteration in the MoU.


Accordingly, the proposal was placed before the members for kind perusal and consideration/decision.

Resolution : The issue of MoU between India Metrological Department and Assam University, Silchar was discussed in length and it was resolved that a Committee shall be constituted with Prof. Atri Deshamukhya, Director, IQAC, Finance Officer i/c or his nominee and the Vice Chancellor was authorized to nominate other members in the committee for finalizing the feasibility of the MoU for implementation.

Item No. 15 : Un-authorized absence of Dr. N. Jiban Singh & action initiated by the University in this regard :

EC:155:02-23:15 : Dr. Jiban Singh, Assistant Professor, Dept. of Mathematics has not reported to duty since Sept, 2018. Subsequently, a Committee was constituted to examine the matter of unauthorized absence of Dr. Singh and as per recommendation of the Committee a letter was sent to the parent of Dr. Singh at his home address on 30-07-2021 but no response has been received yet. Therefore, as recommended by the Committee an FIR was also lodged about the missing of Dr. Singh to the O/C, Dwarbond Police Station (Nearest Police Station) on 15-03-2022, but till date no report is received from Police. The Committee has also recommended that if no information could be obtained from Dr. N. Jiban Singh or his family members within a reasonable time, the University authority may consider floating a notice in the local/national newspaper to join duty within a specified date. Accordingly, a paper notice has been published on 14-01-2023 in a National Daily (The Statesman, Kolkata) indicating that if he fails to resume his duties within one month from the date of publication of notice, it will be presumed that he has left his service with the University and his name will be struck off from the employees list and no further correspondence in this regard will be entertained. The matter was placed before the Council for perusal and approval.

Resolution : On being heard, detail discussion took place on the issue and the action taken by the University administration was accepted by the Council. The Council directed to issue termination notice and accordingly advertise the said post for further recruitment.



Item No. 16 : Compliance of the UGC letter F. No. 9-3/2016-CU-I(part) dated 18-09-2017 and consequential order of the Hon'ble Gauhati High Court :

EC:155:02-23:16 : In compliance of the order of the Hon'ble Gauhati High Court vide Case No. WP(C) 7602/2017 dated 16/12/2017 a show cause notice was issued to the concerned official to which a response has been received. Legal views on the matter have also been obtained. The matter was placed before the Council for discussion & direction.

Resolution : The issue was discussed in detail and the Council observed that on the basis of decision of the Hon'ble Gauhati High Court Sri Charvak was reinstated in his positions. Therefore, no further action is needed on the issue and the matter shall be considered as closed.

Item No. 17 : Revision of wages of contractual doctors :

EC:155:02-23:17 : The University administration has received two separate letter of request from both the contractual doctors of the University for revision of their wages without which it is getting difficult for them to continue their service. The doctors are being paid a fixed remuneration i.e, of Rs. 50,000/- per month from the date of their appointment. Recently on audit observation, Income Tax is also deducted @ 10% every month from their salary. As a result, the contractual doctors are left with less amount of disposable income.

The matter was placed before the Council for discussion and direction as the service of doctors are indispensable to the University and it is very difficult to get doctors on contractual basis for the Health Centre of the University.

Resolution : On perusal of the prayers of the contractual doctors of the University and on consideration of the contents of the agenda item the Council authorized the Vice Chancellor to finalise the revision of wages of the concerned doctors by constituting a Committee at the earliest.

Item No. 18 : Matter pertaining to increasing the age limit for contesting in Assam University Students Union (AUSU) Elections :

EC:155:02-23:18 : The AUSU had submitted a memorandum regarding increasing the age limit (for contesting in AUSU elections) with regard to students pursuing LLM and other such courses. In this context, a Committee was constituted by the competent authority to look into the matter pertaining to the demand for age relaxation to contest in AUSU elections within the ambit of the Lyngdoh Commission Report. The Committee's recommendation was placed before the Executive Council for deliberation and decision.

Resolution : The Council perused and approved the same. The Council also directed to prepare a report course wise as per the recommendations of the Committee.

Item No. 19 : Modalities of utilisation of School/Departmental Development Fund :

EC:155:02-23:19 : The University has framed specific guidelines for Annual Course Fee Fund (ACFF) vide 90th EC resolution No. **EC:90:05-13:03** dtd 18th May 2013. However, there is no specific guideline for utilisation of School/Departmental Development Fund. It is therefore proposed that the School and Departmental Development Fund where ever available may be utilised for academic purposes only, preferably for engagement of Guest Faculty by creating a Central pool. The said fund may be used only for those academic departments where ACFF is inadequate to meet the requirements for engagement of Guest Faculty.

The matter was placed before the Council for deliberation and decision.

Resolution : The Council approved the same. However, the Vice Chancellor has been authorized to constitute a Committee which shall access the requirement of the academic departments and allot the fund. The Council also directed to implement uniform fee structure as far as feasible.

Item No. 20 : Payment of TA and cost of transportation of personal effect on joining to Assam University as Librarian :

EC:155:02-23:20 : Dr Vikram Kumar Sharma, joined Assam University Silchar as Librarian on 28/12/2020 (F/N) against the advertisement No. 3/2020 dated 21/09/2020. His earlier service is in Manav Rachna International Institute of Research and studies which was a deemed University in the list of Universities notified by University Grant Commission on 22.11.2021. After joining to Assam University, he submitted joining TA and cost of transportation of personal effects amounting to Rs. 99,800/. It was processed as per provision of SR-105 and further added with 100th EC meeting resolution vide No. EC:100:01-15:12 for consideration. But the case is still remains under consideration.

The matter was placed before the Council for consideration and decision.

Resolution : The issue of payment of TA and cost of transportation of personal effect on joining to Assam University as Librarian was discussed in the light of 100th EC meeting vide resolution No. EC:100:01-15:12. The Council was of the opinion that the matter needs to be re-looked and thereby authorized the Vice Chancellor to constitute a Committee and the report of the Committee shall be considered within one month time.

Item No. 21 : Item from the Chair :

EC:155:02-23:21 : There was no item from the Chair.

Item No. 22 : Item with permission from the Chair :

EC:155:02-23:22.1 : Inclusion of Assam University Diphu Campus in the Statute of the University :

In pursuance to the Provisions of the Act Clause 3.(2), Assam University, Silchar has established a satellite campus at Diphu, Karbi Anglong in the year 2007, this needs to be incorporated in the Statutes and Regulation of the University for smooth functioning of the Assam University Diphu Campus.


Resolution : The said proposal of the PVC i/c, AUDC was discussed and the members were of the opinion that the same shall be communicated to the concerned Ministry for incorporation in the Statute of Assam University. Further, it was also decided that there are other issues pending for incorporation in the Statute and as such the Council advised the University administration to constitute a Committee to review the Statute of the University and to propose required changes/addition in the Statute.


