- 1) As the time is the essence of the Contract Agreement, the ability and competence of the Govt. Agency to render required service within the specified time frame will be a major factor while deciding the selection of Agency.
- 2) Elligibility criteria of PSUs/ Govt Construction Agencies:

The agency should have extensive experience in execution of multi storey hostel building, functional building, residential building and other development works including beautification and land development etc.

- (i) 3 single building of executed cost not less than 26.00 Lakhs in total for each project, or
- (ii) 2 single building of executed cost not less than 40.00 Lakhs in total for each project
- (iii) 1 single building of executed cost not less than 65.00 Lakhs during last 7 years ending 31st January, 2023 under IIT, NIT, Central/ State University or any other reputed Organizations.
- The applications shall be signed by the person/s on behalf of the organization having necessary Authorization/Power of attorney to do so. - The interested bidder must examine the nature of work after visiting the site physically before submission of bid to satisfy them about the scope of the work during submission of the EOI. - 17) The University does not bind itself to accept lowest Bidder and reserves the right to reject any or all the EOI received by recording clear, logical reasons.
- 18) Canvassing in any from will be a disqualification for submission of the EOI including submission of EOI to the university in future.
- 19) In case of any disputes regarding the contract and its execution, the matter will be referred to a sole Arbitrator to be appointed by the University whose decision shall be final and binding for both the parties. The Civil court shall have no jurisdiction to certain any dispute regarding the same.
- 20) As recommended by MHRD, for all MHRD Institutions, Engineering, Procurement and Construction (EPC) contract has been mandated for all major engineering works. Therefore, the Agency intending to participate in this EOI must have adequate knowledge regarding the clauses of EPC mode of contract and moreover the Agency must abide by the instructions of EPC mode of contract.
- 21) If any Govt. Agency/ PSUs is found to submit any misleading information regarding their credentials, during or afterwards, of EOI procedure and execution of work, then disciplinary action will be taken against those bidders as per GOI rules.
- **22)** However, the work will be executed subject to approval and sanction of the project by the competent authority of the University.

Special Instructions for Online Bid Submission.

The bidders are required to submit soft copies of their bids electronically on the e-bid Portal, using valid Digital Signature Certificates. REGISTRATION

- 2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Only Class III Certificates with signing + encryption key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.

SEARCHING FOR BIDDING DOCUMENTS

9. There are various search options built in the e-bid Portal, to facilitate bidders to search active bids by several parameters. These parameters could include Bid ID, Item/work id, Last date of submission, etc.

10. Once the bidders have selected the bids they are interested in, the bidder can pay the processing fee by net-banking / Debit / Credit card and then download the required documents / bid schedules, Bid documents etc. as mentioned on website. Once processing fee is paid, it will be moved to the respective "requested" Tab. This would enable the e-bid Portal to intimate the bidders through e-mail in case there is any addendum and corrigendum issued to the bidding document.

PREPARATION OF BIDS

- 11. Bidder should take into account any addendum and corrigendum published on the bid document before submitting their bids.
- 12. Please go through the bid advertisement and the bid document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 13. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the bid document / schedule and generally, they can be in PDF /JPEG formats. Bid Original documents may be scanned with 100 dpi with Colored option which helps in reducing size of the scanned document.
- 14. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders should use "My Documents" available to them to upload such documents.

SUBMISSION OF BIDS

- 16. Bidder should log into the website well in advance for the submission of the bid so that it gets uploaded well in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 17. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the bidding document.

- 20. *Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the bid document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete (unprotected) cells with their respective financial quotes and other details (such as name of the bidder).
