At the outset the Vice-Chancellor and the Chairman of the Executive Council welcomed all the members for attending the meeting. The Chairman also welcomed Prof. (Retd.) Kashinath Jena, Dept. of Political Science, Tripura University, Agartala, OSD (Administration & Academics), NFSU-Tripura & Dr. Sarat C. Kakaty, Professor, Dept. of Statistics, Dibrugarh University, Dibrugarh who attended physically in the meeting as **Visitor's Nominee** and Prof. Krishna Pal Singh, Vice Chancellor, Mahatma Jyotiba Phule Rohilkhand University, Bareilly, Uttar Pradesh & Prof. Buno Zetsuvi, Professor, Dept. of Education, Nagaland University, Kohima who participated online in the meeting as **Visitor's Nominee**.

Thereafter the meeting formally started and following agenda items were taken up for discussion and resolutions were adopted accordingly.

#### (A) Agenda item for confirmation:

Item No.1 :Confirmation of the minutes of the 153<sup>rd</sup> meeting, 154<sup>th</sup> meeting(Emergent), & 155<sup>th</sup> meeting(Special) of the Executive Council:

**EC:156:04-23:01**: The minutes of the 153<sup>rd</sup> meeting, 154<sup>th</sup> meeting(Emergent), & 155<sup>th</sup> meeting(Special) of the Executive Council held on 22<sup>nd</sup> November 2022, 10<sup>th</sup> January 2023 & 27<sup>th</sup> February 2023 respectively were placed in the meeting for consideration and confirmation. Action taken report of the above meetings was placed in the meeting.

**Resolution**: The Council perused the minutes of the 153<sup>rd</sup> meeting, 154<sup>th</sup> meeting(Emergent), & 155<sup>th</sup> meeting(Special) of the Executive Council held on 22<sup>nd</sup> November 2022, 10<sup>th</sup> January 2023 & 27<sup>th</sup> February 2023 respectively. The minutes of 154<sup>th</sup> & 155<sup>th</sup> meeting of the Executive Council were confirmed by the Council where as the minutes of the 153<sup>rd</sup> meeting was confirmed with the observation that the resolution No. **EC:153:11-22:15** with reference to resolution of the 65<sup>th</sup> meeting of the Finance Committee vide No. **FC:65/15** recommended to refer the matter to Finance Committee again for further consideration as implementation of the same shall lead to curtailing of existing wages of Rs 513/- per day for casual employees to Rs 506/- per day. The Council suggested the following:-

- 1) Considering the wage rate of UGC North East Regional Office (NERO) at Guwahati for similar work; or
- 2) Considering monthly wage rate of Rs 18000/- (minimum of 7<sup>th</sup> CPC) with the present DA (42%) equivalent to zero with provision for grant of additional DA as and when granted to CUs.

The Finance Committee may reconsider and allow to implement wages whichever is less from the above two options given.

#### (B) Agenda item for approval/decision by the Council:

#### Item No. 2: Remuneration of Guest Faculty, Department of Education:

EC:156:04-23:02: As per UGC letter vide No. F.25-1/2018 (PS/MISC), the honorarium for Guest Faculty has been enhanced from Rs. 1,000/- to Rs. 1500/- per lecture subject to maximum of Rs. 50,000/- per month. Meanwhile the Dept. of Education had appointed one Guest Faculty/Invited Faculty in the Dept of Education @ Rs. 500/- per lecture because of immediate academic exigency and paucity of fund. The Dept of Education had engaged the above guest faculty on the basis of their Departmental Affairs Committee's decision.

Matter was placed before the Council to regularise the remuneration as per the fund position of the concerned department.

**Resolution:** The matter was discussed in detail. The Council advised to follow a uniform rate for Guest faculty as per UGC guidelines. The Council also directed to create a Central pool of fund by drawing Course Fee/Departmental Development Fee/School Development Fee, if required so that teaching and learning activities by appointing guest faculties, wherever required, do not suffer due to shortage of fund.

#### Item No. 3: Grant of Sabbatical leave to Prof. Suman Gun, Dept. of I.C.L:

EC:156:04-23:03: Prof. Suman Gun, Dept. of Indian Comparative Literature has applied for grant of Sabbatical leave for a period of one year. At present there are only two teachers in the department and accordingly clarification was sought from Prof. Gun about the functioning of the department in his absence. In reply, Prof. Suman Gun made a clarification that during his absence from the department, Scholars of the Dept. shall bear the load of the department. In the said communication made by him he has stated that if the suggestion provided by him is not found viable then he is ready to withdraw his application for sabbatical leave to get the matter closed.

The item was placed before the Council for perusal and decision.

**Resolution:** The Council deliberated the matter in detail and directed the Registrar to route the applications of sabbatical leave henceforth through a Committee. The Council authorized the Vice Chancellor to constitute a Committee for the purpose. The Committee shall examine all such proposals duly forwarded by the Head and the Dean. The proposals shall contain the details of work to be accomplished during the sabbatical leave and how such works shall benefit the University. The Head of the Department/DAC shall specifically mention how the Department shall manage academic activities during the absence of concerned faculty proceeding on sabbatical leave. Till then the instant proposal is kept on abeyance.

#### Item No. 4: Correction of surname & date of completion of probation period:

EC:156:04-23:04: In the 126<sup>th</sup> EC meeting dtd. 27.06.2019, vide its resolution no. EC:126:06-19:19 the surname of Dr. Sukanta Mondal at Sl. No. 19, was inadvertently written as Mandal instead of Mondal and date of completion of probation period was written as 25.10.2018 instead of 23.10.2018. Hence the matter is placed before the



**Resolution:** The Chairman placed the recommendations of the Selection Committee and the Council approved the recommendations for the promotion to Associate Professor and Professor under CAS with the date of effect mentioned against the respective person except Sl. No. 10 of the list.

Item No. 6: Confirmation of services of Dr. Aniruddha Kumar, Asstt. Professor, Dept. of Hindi, AUDC:

EC:156:04-23:06: Dr. Aniruddha Kumar, Assistant Professor, Dept. of Hindi, Assam University Diphu Campus was appointed as Assistant Professor vide offer of appointment letter No. 102/1/2014-Rect dated 15/01/2015. Dr. Kumar joined Assam University Diphu Campus on 03/02/2015. As per terms and conditions of offer of appointment at Sl. No. (e), the term of probation was one year. Dr. Kumar completed one year of services on 02/02/2016 and accordingly completed the probation period for confirmation of services on 03/02/2016. Police verification report has also been received, necessary PBAS has also been submitted by the incumbent in the IQAC. Hence services of Dr. Aniruddha Kumar may be confirmed w.e.f. 03/02/2015, subject to submission of contract deed followed by an order for confirmation. The matter was placed before the Council for approval.



**Resolution :** The Council approved the confirmation of services of Dr. Aniruddha Kumar, Assistant Professor, Dept. of Hindi, Assam University Diphu Campus with a correction on the date of confirmation which shall be 03/02/2016 instead of 03/02/2015.

## Item No. 7: Proposal for formation of Management Board at Assam University Diphu Campus:

EC:156:04-23:07: The representatives of Assam University Diphu Campus Teachers Association (AUDCTA) forwarded the report of the High Power Committee constituted (vide AUR/21-1/2018/5717 dtd. 23rd July 2018) to look into the issues of AUDC to the Registrar during his last visit to Diphu Campus. The AUDCTA has requested to constitute a Management Board for Diphu Campus by adopting proper Regulations on the basis of the report of the High Power Committee. The detail report of the Committee shall be placed in the meeting. The matter was placed before the Council for consideration and decision.

**Resolution:** The matter is kept in abeyance as the Ministry has taken some initiative for upgradation of AUDC to Central University.

#### Item No. 8: Appointment of Head, Dept. of English, AUDC:

**EC:156:04-23:08**: Prof. Anup Kumar Dey has relinquished the post of Head of the Dept. of English, AUDC, and has joined as Ambedkar Chair professor at Head Quarter of Assam University, Silchar. (ii) 100-Bedded Girls Hostel : Rongpharpi Rongbe Girls' Hostel

The matter was placed before the Council for consideration.

#### Item No. 10: Representation from Ph.D. Research Scholars - reg.:

EC:156:04-23:10: A communication has been received from Utpal Suklabaidya, Ph.D. Research Scholar, Dept. of Mass Communication and Sanjeet Kr. Bora, Ph.D. Scholar, Dept. of Agricultural Engineering, through the DSW of Assam University. The concerned Scholars viz Utpal Suklabaidya and Sanjeet Kr. Bora, the signatories of the communication requested the competent authority and sought cooperation for holding of different activates in the name of Assam University Research Scholars Welfare Association (AURSWA). The letter along with some documents as received was placed in the meeting for perusal/consideration of the Council.

**Resolution:** A detail discussion was held on the representation submitted by the PhD Scholars and there after the Council opined that a Committee shall be constituted to look into the feasibilities to form such associations in the University other than the associations accepted in the Statute of the University and thereby the Council authorized the Vice-Chancellor to constitute a Committee to examine the feasibilities in detail and submit a report on the matter.

## Item No. 11: Approval of the recommendations of Minutes of 93rd meeting of Academic Council of Assam University:

**EC:156:04-23:11**: The minutes of the 93<sup>rd</sup> meeting of the Academic Council of the University held on 11<sup>th</sup> April 2023 was placed in the meeting for consideration and approval by the Executive Council.

**Resolution:** The members perused the minutes of the 93<sup>rd</sup> meeting of the Academic Council of the University held on 11<sup>th</sup> April 2023 and approved all the recommendations of the Academic Council with the observation on the agenda as follows:

**Item No. 6**: SI No. 20 of the list in respect to running of two Diploma Courses in the Dept. of Business Administration having similar courses in other departments, shall be routed through IQAC for their views.

**Item No. 11:** The item was discussed and the observations of IQAC noted to the effect that the proposal for setting up of a Centre for Design within the University does not provide detail of funding, requirement of teaching & non-teaching positions and also the academic objectives of the Centre. The members were of the opinion that the proposal as placed may not be considered at this point of time. The proposal may be resubmitted through DIQAC

**Item No. 39:** With regard to the item from the Chair on offering Bachelors degree to Ex-serviceman, the Council resolved to expedite the matter and therefore authorized the Vice Chancellor to appoint a retired Army/Police Officer to prepare

the proposal as per guidelines of MoD and in tune with the UGC norms in this regard. An honorarium of Rs 75000/- for the task has been earmarked by the Council which may be provided on successful completion of the task.

## Item No. 12: Granting of Lien to Prof. Anup Kumar Day on joining as Chair Professor, Dr. Ambedkar Chair Scheme:

**EC:156:04-23:12**: Dr. Anup Kumar Dey, Professor, Dept. of English, AUDC, on the recommendation of the Selection Committee and as per communication received from Dr. Ambedkar Foundation, Ministry of Social Justice & Empowerment, GoI was appointed as Chair Professor under Dr. Ambedkar Chair Scheme. He has joined the said position on 24<sup>th</sup> March 2023 (A/N). Prof. Dey has applied for granting of lien for a period of 05 (five) years w.e.f. 24-03-2023. The matter was placed for approval by the Council.

**Resolution :** The Council approved the lien to Prof. Anup Kumar Day for a period of 05 (five) years w.e.f. 24-03-2023.

#### Item No. 13: Counting of past service of Prof. Sumanash Dutta:

**EC:156:04-23:13**: The matter of counting of past service of Prof. Sumanash Dutta for giving combined service benefit by incorporating into GPF cum pension scheme was referred to UGC as per the resolution No. FC:65/13 of the 65<sup>th</sup> meeting of the Finance Committee dtd. 22th November 2022.

Response from UGC has been received. The matter was placed in the meeting for perusal and further direction.

**Resolution:** The Council perused the matter in detail and directed the Registrar and Finance Officer to immediately grant GPF cum pension scheme to Prof. Sumanash Dutta by counting his past service. The Council also directed to provide Leave encashment to Prof. Dutta on the basis of his last pay as per rule irrespective of the amount received and interest earned from past service.

## Item No. 14: Change of designation of Pro-Vice Chancellor i/c, AUDC to Pro-Vice Chancellor, AUDC:

**EC:156:04-23:14:** As per decision of the 148th meeting of the Executive Council, vide resolution No. **EC:148:04-22:24.2** dtd. 20th April 2022 Prof. Sivasish Biswas was appointed as Pro-Vice Chancellor In-Charge, AUDC. However, on further examination of the matter it is observed that there is no provision of appointment through direct recruitment for the position of Pro-Vice Chancellor (PVC). The PVC is nominated by the Vice Chancellor as per Statute 4(1). As there is no provision of appointment of PVC against sanctioned post of AUDC through direct recruitment, therefore, as per provision of Statute as indicated above the appointment of PVC i/c made by the Executive Council may be reconsidered and Prof. Biswas may be considered as regular PVC with retrospective effect from the date of appointment as Pro-Vice Chancellor, AUDC.



The matter was placed before the Council for consideration and approval.

**Resolution**: The Council discussed the matter in detail and resolved that the designation of Prof. Sivasish Biswas, Pro-Vice Chancellor i/c, AUDC will be Pro-Vice Chancellor, AUDC with retrospective effect without any financial benefits as the appointment has been made as per Statute 4(1) of the University in absence of any provisions in the Statute for direct recruitment of the post.

Item No. 15: Appointment of "Chair Professor" under Dr. Ambedkar Chair Scheme:

EC:156:04-23:15: The Selection Committee meetings for the appointment to the post of Chair Professor under Dr. Ambedkar Chair Scheme against the Employment Notification no 2/2022 dated 13/05/2022 & 3/2022 dated 01/08/2022, in the Academic Level 14 of Rs 1,44,200/p.m. (as in Cell I of 7th CPC under UGC guidelines) held on the 7th February, 2023 at the VC Secretariat, Raja Rammohan Roy Administrative Building, Assam University under the Chairmanship of Prof. Rajive Mohan Pant, Vice-Chancellor, Assam University. On the recommendation of the duly constituted Selection Committee and communication received from the Dr. Ambedkar Foundation, Ministry of Social Justice & Empowerment, Government of India on 24.03.2023, offer of appointment has been issued to Dr. Anup Kumar Dey Professor, Department of English, Assam University, Diphu Campus, Diphu – 782462 as per the standard terms of selection, and conditions stipulated under the Memorandum of Understanding ((MoU) entered between Dr. Ambedkar Foundation and this University.

Homshira Killingpi, Lower Division Clerk, Assam University Diphu Campus was appointed as Personal Assistant, Assam University, Diphu Campus vide offer of appointment letter No. 102/4/2021-RECT/2106-2110 dtd 27/08/2021, Smt. Killingpi joined as Personal Assistant on 27/08/2021. She applied for lien for 2 (two) years w.e.f 27/08/2021 to 26/08/2023 for the post of Lower Division Clerk to enable her to join in her new assignment as Personal Assistant, Assam University Diphu Campus.
