

The candidates will be intimated about the date, time and venue of interview by electronic means prior to the actual date of interview. The above candidates will be eligible to appear for the interview only on production of the requisite documents and fulfillment of the eligibility conditions. After verification of original documents, if any discrepancy is found, then the candidate will not be permitted to appear in the interview.


Any update or changes in this regard will be uploaded in the University website. Candidates are requested to visit the website frequently.
