## TERMS AND CONDITIONS FOR SUBMISSION OF QUOTATION FOR PURCHASE OF OLD CGI SHEET

1. Intending scrap vendor/commission agent/contractor/supplier may quote their rates for old CGI sheets and upload in <https://eprocure.gov.in/eprocure/app> along with all relevant documents. Hard copies of same is to be submitted in a sealed envelope **superscribing quotation for purchase of old CGI sheets in the Estate Section, Assam University, Silchar.**
2. Bidders would be required to register on the Central Public Procurement Portal at [www.eprocure.gov.in](http://www.eprocure.gov.in), using a valid Digital Signature Certificate (DSC) and valid email address to be able to participate in the bidding process. On registration with the Portal, they will be provided with a user id and password by the system through which they can submit their bids online.
3. Digital Signature Certificate (DSC) may be obtained from any authorized agencies registered with the Certifying Authority (CA), through National Informatics Center (NIC) in India.
4. Bidders can download the bid document from Central Public Procurement Portal website at [www.eprocure.gov.in](http://www.eprocure.gov.in). Bidders are required to submit the bid online by scanning and uploading all the relevant documents through [www.eprocure.gov.in](http://www.eprocure.gov.in).
5. It is the responsibility of the bidder to assess the items properly before quoting the rate. No further claims will be entertained after opening of the bids.
6. Earnest money of **Rs.50,000.00** in the form of demand draft favouring Assam University, Silchar is required to be submitted along with quotation.
7. Preference will be given to the Scrap vendor/commission agent/contractor/supplier having past experience for doing the similar nature of works.
8. Quotationer must have registered firm along with valid PAN and GST registration.
9. On acceptance of the rate, successful bidder has to lift the said CGI sheets from the University campus "as is where is basis" within 20 days from the issue of order.
10. Last date of submission of sealed quotation to the Estate Section is 22/12/2023 upto 3 PM.
11. Reserve price fixed for old CGI sheets is Rs.20.00/kg. Quotation below the reserve price shall be summarily rejected.
12. Successful bidder has to deposit sales proceeds in cash with UCO Bank/Demand Draft in favour of Finance Officer, Assam University before lifting of said materials after proper weighing under supervision of the Committee.
13. Quotation highest rate only will not qualify the bidder to be eligible to buy the materials.
14. **Rejection of offer:** Quotation not conforming to the terms and conditions and procedure so outlined or quotation incomplete in any respect is liable to be summarily rejected.
15. In case of confusion in interpretation of above terms and conditions, decision of the Committee shall be final and binding.
16. If there be any dispute, it will be referred to an arbitrator to be appointed by the University for his decision and award. The award or decision of the arbitrator shall be final and binding on both parties.
17. Sale documents may be downloaded from the University website and payment of **Rs.1000.00 non-refundable** in the form of demand draft favouring Assam University, Silchar towards cost of the documents will be submitted along with rate quotation in the Estate Section.
18. The scrap vendor/commission agent/contractor/supplier who accept the above terms and conditions may submit their rate quotation in the prescribed format at "Annexure-A" along with

all relevant documents i.e. Firm/individual registration copy, copy of order of such work etc., in the quotation drop box kept in the Estate Section by 3.00 pm of 22/12/2023.

19. The quotation will be opened on 23/12/2023 at 12 noon in presence of bidder or his authorised representative.

## **SPECIAL INSTRUCTION FOR ONLINE BID SUBMISSION**

### **Special Instructions for Online Bid Submission.**

The bidders are required to submit soft copies of their bids electronically on the e-bid Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the e-Procurement Portal <https://eprocure.gov.in/eprocure/app>, prepare their bids in accordance with the requirements and submitting their bids online on the e-Procurement Portal.

### **REGISTRATION**

1. Bidders are required to enrol on the e-Procurement Portal (<https://eprocure.gov.in/eprocure/app>) by clicking on the link “Online bidder Registration” on the e-bid Portal.
2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.
4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Only Class III Certificates with signing + encryption key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
6. Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.
7. The scanned copies of all original documents should be uploaded on portal.

### **SEARCHING FOR BIDDING DOCUMENTS**

9. There are various search options built in the e-bid Portal, to facilitate bidders to search active bids by several parameters. These parameters could include Bid ID, Item/work id, Last date of submission, etc.

### **PREPARATION OF BIDS**

10. Bidder should take into account any addendum and corrigendum published on the bid document before submitting their bids.
11. Please go through the bid advertisement and the bid document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
12. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the bid document / schedule and generally, they can be in PDF /JPEG formats. Bid Original documents may be scanned with 100 dpi with Colored option which helps in reducing size of the scanned document.



## SUBMISSION OF BIDS

13. Bidder should log into the website well in advance for the submission of the bid so that it gets uploaded well in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

14. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the bidding document.

15. **\*Bidders** are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the bid document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

16. The server time (which is displayed on the bidder's dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

17. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener public keys. Overall, the uploaded bid documents become readable only after the bid opening by the authorized bid openers.

18. The uploaded bid documents become readable only after the bid opening by the authorized bid openers.

19. Upon the successful and timely submission of bid click "Complete "(i.e., after Clicking "Submit" in the portal), the portal will give a successful Bid submission acknowledgement & a bid summary will be displayed with the unique id and date & time of submission of the bid with all other relevant details.
