The University accordingly has communicated the matter to the Ministry of Education for further necessary action vide letter No.103/822/2014-Estt dated 13.02.2023 (copy placed in the meeting as an reminder subsequent agenda item) and to the annexure No.103/01/2022-Estt/999-1001 dated 10.04.2023 (copy placed in the meeting as an annexure to the agenda item). In this connection, Registrar, Assam University has received a copy of the letter of NERIST to the Ministry dated 14th June 2022 (copy

In pursuance of the UGC letter No.F.No.25-4/2007(CU)Pt.file2 Dated 6th July, 2023 (copy placed in the meeting as an annexure to the agenda item) and OM No. 57/05/2021-P&PW(B) Dtd.03-03-2023 of Ministry of Personnel, Public Grievance & Pension, Department of Pension & Pensioners Welfare, Govt. of India (copy placed in the meeting as an annexure to the agenda item), on coverage under Central Civil Service (Pension) Rules in place of NPS of those Central Govt. employees who were recruited against the Post/Vacancies advertised/notified for recruitment on or before Assam University 22-12-2003, a notification was issued by the No.105/8/2020-Estt/959-64, Dtd.30th March,2023 (copy placed in the meeting as an annexure to the agenda item) seeking one time option to be covered under CCS (Pension) Rules-1972 (Now-2021) within 31st August, 2023.

In response to the said notification 50 (fifty) Nos. of employees applied for incorporation into CCS (Pension) Rules-1972 (Now 2021). The University constituted a committee to examine the cases vide notification No.105/8/2020-Estt/2408-13 Dtd.4th October, 2023 (copy placed in the meeting as an annexure to the agenda item). On verification of the 50 (fifty) cases, 28 (twenty eight) such cases were found to provisionally conforming to the Rules as notified for incorporation into CCS (Pension) Rules-1972. A brief of the 28 cases (copy placed in the meeting as an annexure to the agenda item) which were found admissible by the University is forwarded for further MOE. letter and Vide verification and approval of UGC No.105/8/2020-Estt/2698-704 dtd. 19th Oct.2023 (copy placed in the meeting as an annexure to the agenda item).

Since the response in this regard from the UGC and Ministry is still awaited, the matter is reported to the Finance Committee for information and further direction, if any.
