EC:174:03-25:3.1 : Matter relating to disciplinary proceedings against Dr. Biswajit Das, Assistant Professor, Dept. of Law, Assam University Headquarter :



The matter relating to ongoing enquiry against Dr Biswajit Das, Assistant Professor was discussed & the Council was informed that the charge sheet has been issued to Dr. Biswajit Das, Assistant Professor Dept. of Law on the basis of the preliminary report to the Internal Complaints Committee.

Resolution : The Council approved the charge sheet and further directed to issue fresh suspension order in accordance with Rule 10 (1) (a),(b) of CCS (CCA) Rule 1965 and in accordance with Clause 4(i), 4(ii),4(iii) and 4(iv) of DoPT OM No. 11012/17/2013-Estt(A) dated 02.01.2014 . This is in supersession of the earlier decision of the EC in this regard resolved vide **EC:172:01-25:02** Dtd. 9th January, 2025.

EC:174:03-25:3.2 : Matter relating to complaint against Dr. P. K. Nath, Registrar, Assam University :


It has come into notice of the members of the Executive Council that complaint against Dr. P. K. Nath, Registrar has been emailed to more than 100 teachers of the University.


Resolution : The Council opined that the appointment of Dr. P. K. Nath was made by following due process of law and as per rule. The Council also noted that CAG has dropped para against Dr. Nath and others in OBC Certificate matters after due examination. The Council therefore unequivocally condemned such vilification campaign. The Council authorized the University Administration to file an FIR and defamation suit against such complainants. The Council also expressed concern on unauthorized use of official documents in such complaints. The Council proposed to initiate the process of implementation of E-office in Assam University to ensure official secrecy of documents.
