

Resolution : The Council accepted the above candidates admitted to various Degrees either in person or in absentia for 22nd Convocation and recommended the same for approval of the Executive Council.

Item No. 3 : Special Examination beyond the validity of the TDC (Non-CBCS) program :

AC:98:02-25:3 : The Examination Branch has received a number of applications from students whose validity for the program were already exhausted for different reasons, it is proposed to conduct an additional special examination for all such students.

The matter was placed before the Council for perusal and decision.

Resolution : The Council accepted the same and recommended to the Executive Council for approval.

Item No. 4 : Panels of examiners for evaluation of Ph.D. Thesis :

AC:98:02-25:4 : It is observed that the lists of panels of examiners submitted for evaluation of Ph.D. thesis by some supervisors are from the college where PG programs are not offered in the concerned department. As per University rule, the thesis is evaluated by external examiner in the rank of Associate and above from University/College where PG programs are being offered. The existing rule may be continuing in future.

The matter was placed before the Council for perusal and discussion.

Resolution : The issue was discussed in detail and the members were of the opinion that the same shall be dealt with as per the provisions of Ordinance concerned and recommended the same for consideration of the Executive Council.

Item No. 5 : Revised Fee Structure :

AC:98:02-25:5 : The existing fee structure was revised during the year 2018 except Ph.D. and D.Litt. related fees.

Examination Department has revised fee structure related to the examination remuneration, examination fee, thesis evaluation fee, certificate and others exam related fees due to escalation of cost of examination materials etc. The statement prepared showing the existing and enhanced rate of fees was placed in the meeting.

The matter was placed for perusal and consideration of the Council.

Resolution : The Fee Structure as proposed was considered and accepted in principle with a few modification. However, the same shall be referred to the Fee Review Committee whereas other members may be co-opted and the Vice Chancellor was authorized by the Council to take further decision.

Item No. 6 : Award of Grace marks :

AC:98:02-25:6 : 1% of end semester total mark shall be awarded as grace marks to all semesters examinations of all programmes subject to passing of semester(s) after award of grace marks.

The matter was placed for discussion and decision of the Academic Council.

Resolution : The Council accepted the same and accordingly grace mark will be awarded semester wise, if applicable irrespective of number of papers to the maximum tune of 1% of the total mark of that particular semester and there upon recommended to the Executive Council for approval.

Item No. 8 : Action to be taken on Departmental Action Plan presentation on Clause 6 of Assam Accord Based on High Level Committee Report (Justice Biplab Kumar Sharma Committee) :

AC:98:02-25:8 : Communication received from the Additional Secretary to the Govt. of Assam vide dtd. 25-11-2024, 26-11-2024 & 04-01-2025 in respect to implementing the recommendation of the High Level Committee Report (Justice Biplab Kumar Sharma Committee) related Clause 6 of the Assam Accord on points 3, 9, 11 & 38.

The communication as received from the Department of Higher Education, Govt. of Assam was placed in the meeting for discussion and decision.

Resolution : The matter was discussed in detail and it was decided the University administration shall communicate DHE, Govt. of Assam and the UGC/Ministry with detail for implementation of the Clause 6 of Assam Accord.

Item No. 9 : Reallocation of Postgraduate Certificate Course in French :

AC:98:02-25:9 : The Head, Dept. of Hospitality & Tourism Management (DHTM) has submitted a proposal with the approval of Departmental Advisory Committee (DAC) for reallocation of Postgraduate Certificate Course in French. The course, which was accepted by the Academic Council in its 91st meeting vide resolution No. **AC:91:04-22:23** and subsequently approved by the 149th meeting of the Executive Council vide resolution No. **EC:149:05-22:06** was under the Dept. of French.

The DAC, DHTM, was of the opinion that the course may be shifted from the French Department to the Department of Hospitality & Tourism Management. It is also been requested that this course shall be included in the forthcoming prospectus for the academic year 2025-2026 as an additional course offered by the Dept. of Hospitality & Tourism Management.

The matter was placed before the Council for consideration.

Resolution : The matter was discussed in detail. The members appreciated the initiative taken by the Assam Govt. for providing Chairs at Assam University. The same

was approved subject to provision of full financial assistance from the State Government. Further, a proposal for opening Dept. of Assamese in main campus shall be submitted to UGC for concurrence. It was also pointed out that to ensure sufficient students at PG level in the Dept. of Assamese, a letter may be written to Govt. of Assam for opening regular Dept. of Assamese in affiliated Colleges of Assam University at Barak Valley.

The Council further recommended the same to the Executive Council for approval.

Item No. 10 : Proposal for amendment of Regulations on Endowment Funds :

AC:98:02-25:10 : Assam University has been awarding 44 numbers of endowments in convocation from 44 Endowment Funds created by public donation on the basis of Endowment Fund Regulations. As per EC resolution No. **EC:119:05-18:54.1**, dated 5th June 2018, all donors who contributed less than one lakh were requested to deposit additional amount so that capital fund may be raised at least up to one lakh for each Endowment. The purpose was to generate atleast a considerable amount of interest for the award. Most of the donors have responded and deposited additional amount. However, 10 (ten) numbers of donors did not respond in spite of issuing of reminder. Moreover addresses of 5 (five) numbers of donors/their respective legal heirs could not be traced and accordingly a public notice was issued through the University website. Two donors having three Endowment Funds and one donor for one Endowment expressed their willingness to withdraw the fund from the University.

A Sub-Committee viz. **Endowment Fund Regulations Drafting Committee** has examined all the issues and made the following recommendations:

1. Since Endowment Funds in the University are operational through different regulations, all concerned regulations are to be amended as follows:
 - (a) Due to non-cooperation from the donors or legal heirs the 15 numbers of Endowment Funds may be abolished within three years distributing the capital and as well as interest accrued in the three different installments to the endowment prize awardees. The list of endowment Fund shall be placed in the meeting.
 - (b) There are 23 numbers of Endowment Funds having minimum of one lakh as capital amount for each. The same will continue as regular funds. The list of such endowment funds shall be placed in the meeting.
 - (c) Two Endowment Funds having two lakhs or more as capital amount. The details shall be placed in the meeting. These may be continued as regular Endowment Fund
 - (d) The donors of the four Endowment Funds (One having three funds) have expressed their willingness to withdraw the existing fund to discontinue the awards. Their Endowments may be discontinued and amount along with interest if any be returned. The details of the said funds shall be placed in the meeting.
2. As recommended by Assam University Endowment Fund Regulations Drafting Committee the following provisions may be adopted for smooth and easy operation of the Endowment Funds.

- (a) All the Endowment Funds with one lakh and above capital each may be clubbed into a single fund and interest accrued may be distributed proportionately among the prize holders except Gold medal prizes.
- (b) The Endowment Fund with one lakh and above may remain valid for 10 years so that after 10 years the funds position may be reviewed.
- (c) To implement the above changes the existing endowment Regulations may be amended to the extent of above proposals.

The item was place before the Council for consideration and approval.

Resolution : The Council accepted the same with minor change with respect to point/clause No. 2(b) whereby the period of review has been reduced to 05 (five) years and there upon recommended the same to the Executive Council for approval.

Item No. 11 : Minutes of the 58th (Special) Joint Meeting of the BRS (Science) & BRS (SSH), is slated on 10th February 2025.

AC:98:02-25:11 : The minutes of the 58th (Special) Joint Meeting of Board of Research Studies (Science) & (SSH), slated on 10th February 2025 were placed in the meeting for consideration and approval by the Council.

Resolution : The Council accepted the minutes of the 58th (Special) Joint Meeting of Board of Research Studies (Science) & (SSH) and recommended to the Executive Council for approval.

Item No. 12 : Matter related to Supplementary Examination for PG departments :

AC:98:02-25:12 : The Report of the Committee on Supplementary Examination for PG departments was placed in the 20th SCAC meeting and it was subsequently placed in 170th meeting of the Executive Council whereby it was decided vide resolution No. **EC:170:10-24:11(I)** that the decision of the SCAC under resolution No. **SCAC:20:09-24:1** (a) shall be referred back to the Academic Council for wider participation and deliberation before final approval :

The recommendation of the Committee is as below placed for perusal of the members.

- i) Department/Examination Section shall publish the result of even semester within 40 (forty) days of the end of semester end examination.
- ii) Supplementary exam shall be held at a time for all the PG Depts. preferably between 45 - 60 days after the end of even semester exam.
- iii) The supplementary exam shall be held for N/2 +1 papers where N stands for no. of semester in the programme.
- iv) Student shall have choice to select any paper for supplementary exam subject to maximum number of N/2+1 paper.

The matter was placed before the Council for Consideration.

Resolution : The Council accepted the proposal of Supplementary Examination for PG departments with minor modification in Point (i) whereas it shall be 30 (Thirty) days in place of 40 days and in Point No. (ii) it shall be maximum of another 30 days (i.e, total 60

days) from the date of completion of examination. The Council recommended the same to the Executive Council for approval.

Item No. 13 : Item from the Chair :

AC:98:02-25:13 : There was no item from the Chair.

Item No. 14 : Any other item with permission from the Chair :

AC:98:02-25:14.1 : One of the member raised the following issues :

- (i) Matter related to implementation of vacation in the University as per UGC Regulation 2018 and
- (ii) Leave matter of Teachers of the University.

Resolution : The Council heard the concerned member and after consideration of points raised by him the members were of the opinion that the issues being administrative, the member was advised to communicate to the University authority with all details so that the administration can take necessary action on these issues.

AC:98:02-25:14.2 : Inclusion of new member in the BUGS of Ecology & Env. Sc. :

The Head, Dept. of Ecology and Environmental Science has raised the issue of inclusion of new member in the BUGS of Ecology & Environmental Science.

Resolution : The Council heard the proposal of HoD, Ecology & Environmental Science and approved the same subject to following of concerned Ordinance on the issue.


AC:98:02-25:14.3 : Matter related to representation of ACTA :

- (v) Holiday on Idul – Fitr.


Resolution : The Council deliberated on the issues and resolved as follows :

- (i) The response made by Director i/c, CDC was considered by the Council and it was said that the election for members for inclusion in the Academic Council shall be conducted as the earliest.
- (ii) The Controller of Examination was requested to prepare a draft in consultation with ACTA and other stake holders.



- (iii) The proposal of the concerned representative was heard and it was resolved that a Committee shall be constituted to look into the matter and report of the Committee shall be placed to the Vice Chancellor at the earliest.
- (iv) The Council was of the opinion that the representatives of ACTA may be included in the Academic Committees of the University where ever necessary.
- (v) The holiday in the University is followed as per the DoPT Guidelines.

There being no other item to discuss, the meeting ended with thanks to & from the Chair.
