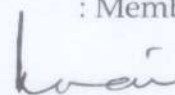

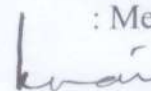

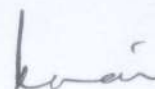

Item No. 1 : To confirm the Minutes of the 99th Meeting of the Academic Council of Assam University :

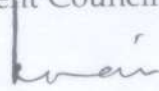
The matter was placed before the Council for approval.

Item No. 10 : Panel of Subject Experts for Theory and Practical Examinations of Dept. of Library & Information Science :

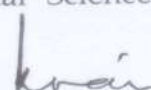

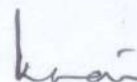

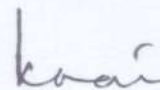

Item No. 17 : Syllabus of 5th and 6th semesters of the FYUG B.Voc. in Information Technology :

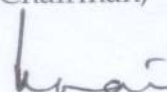
