**Resolution** : The Members of the Executive Council perused the recommendations of the Selection Committee and approved the above mentioned panel for the issue of offer of appointment.


#### **Item No: 2 : Selection and Recruitment of the Deputy Registrar (1, OBC-LV), Assam University:-**


