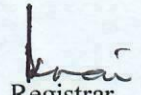

1. The recommendations of the Application Screening Committee and the list of candidates for the post of Professor (OBC), Associate (ST) and Assistant Professor (OBC-LV), **Department of Business Administration**, who have been found **provisionally eligible/ineligible**, along with the reasons for rejection in respect of the ineligible candidates, are attached herewith. The provisional eligibility of the candidates shall remain **subject to verification of all original documents** furnished & mentioned in their respective applications at the appropriate stage. Any claim, objection or grievance relating to the score awarded, eligibility status, or any other matter may be submitted through email: operationsdghosh@gmail.com & recruitment@aus.ac.in within **10 (ten) days from the date of publication of this notice on the University website**. No claim or grievance received after the stipulated period shall ordinarily be entertained.

The University shall issue a **Call Letter/Letter of Intimation** to a limited number of shortlisted candidates, based on the merit/score obtained, for appearing **physically** before the Selection Committee, as and when scheduled. The shortlisted candidates shall be intimated through electronic means regarding the **date, time and venue of the interview** sufficiently in advance of the scheduled date. Candidates shall be permitted to appear before the Selection Committee only upon production of the requisite original documents and fulfillment of all prescribed eligibility conditions. In case any discrepancy is found during verification of the original documents or if a candidate is found not to fulfil the prescribed eligibility conditions, the candidate shall **not be permitted to appear before the Selection Committee**, and the candidature shall be liable to be cancelled. Mere inclusion in the provisionally eligible list does not confer any right upon a candidate to be called for interview or to claim appointment.

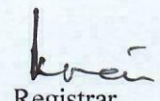
